#### **BAY TO BREAKERS 2018**

The first cross city race, better known now as, "Bay to Breakers", was held in 1912, this race was started to lift the spirits of all San Franciscans that were devastated by the 1906 earthquake. The 1906 earthquake shook San Francisco to its core, and caused so much destruction that people feared the City by the Bay would never be able to recuperate from this natural disaster.

On Sunday, May 20, 2018, at 8am, approximately 45,000 runners participated in the Bay To Breakers Race. The race route begun at the Embarcadero, and headed west through San Francisco until the finish line at Ocean Beach. Every year, the Bay To Breakers Race route heads west on Fell Street, and passes the Panhandle. This year, approximately 20,0000 runners attended after parties in and surrounding the Panhandle. Officers assigned to Park Command enforced laws, especially with regard to alcohol consumption, street vending, and quality of life issues.

This cross city race should remind us all of how far San Francisco has come since the 1906 earthquake, and how beautiful, resourceful, and unique San Francisco truly is.

Thanks to the ALERT Team for helping the officers detailed to Park Station making this year's Bay to Breakers safe and a success!!!



#### MEET THE DUBOCE TRIANGLE FOOT BEAT OFFICERS



SFPD shifted tactics last September in an attempt to reduce vehicle burglaries and other property crimes by increasing foot patrols with officers in uniform and seeking to prevent more crimes before they happen. Chief of Police William Scott said last August that the department will increase staffing at all district stations that will nearly double the number of officers assigned to foot and bike patrols from less than 100 to over 200.

Park Station has sixteen Foot Beat Officers assigned to both Haight Street and the Duboce Triangle area. Four of these officers are assigned to Duboce Triangle area. Two of these officers are Officer Riley Bandy and Officer Keith Lipp.

The hours and routes they patrol in the Triangle constantly change so that they are not predictable. They usually start their shift by checking on calls for service in the Triangle and usually investigate them on foot. They enjoy talking to community members to find out their needs and seize every opportunity to educate the community on crimes and crime prevention.

#### **DUBOCE TRIANGLE FOOT BEAT OFFICERS (CONTINUED)**

They check the Triangle's hot spots, which include Duboce Park, the Church and Duboce street corridors, and Belcher Street. Duboce Park has had a problem with transients and drugs. Officer Bandy says he is motivated by the desire to keep parks used by kids free of crime and drugs. Church and Duboce are good places for crimes of opportunity, i.e., lots of people using cell phones are attractive targets for smart phone thieves.

Even though Park Station assign a Duboce Triangle Foot Beat each day, you may not see the foot patrols every day. An officers' hours and routes change daily. Officer Lipp said they have a "fluid assignment," meaning they go to other areas where crimes have occurred or where additional police officers are required.

Officer Bandy points out that they have to wear many hats, including social worker, medic, crime fighter, traffic accident investigator, and more. They make well-being checks and often have to determine if a situation is a medical emergency or not.

Police work is stressful. Officer Lipp said the "goal everyday is to go home at night," but schedules change, especially if there is an emergency, and officers don't always go home on schedule. He said his "heart rate goes from zero to a 100 many times a day" and that a body can be adversely affected by the adrenalin flow. Officers have to assist citizens, who are in stressful situations in addition to arresting people all of which contribute to stress level.

Officer Lipp graduated in Political Science at UC Berkeley, and worked in the tech industry for a while, but ultimately decided on a career with SFPD two years ago since he "wanted to help people and make a difference." He likes the excitement of the job on patrol and appreciates the "team bonding" between partners and on the police force. Officer Bandy has been an officer for four years and is active in the military. He recently received a Gold Medal of Valor from SFPD for his efforts in apprehending an armed robbery suspect while off duty in Oakland, CA.

What they both have in common – is the desire to defend the weak and less fortunate. Both officers say they are "normal people like everyone else."

Both Officer Bandy and Officer Lipp will be guests at the next DTNA General Meeting on June 11 and will answer questions and discuss crime in the Triangle from their viewpoints.

#### CITIZENS TO THE RESCUE! - OF RUNAWAY DOG!

On May 7th, 2018, Animal Care and Control was notified regarding a "little white dog" that was running in and out of traffic along the busy vehicular thoroughfares along the Panhandle, Stanyan Street, and Kezar Drive. For over 90 minutes, this tiny, terrified dog was running frantically on bustling city streets, somehow avoiding calamitous injury and evading capture.


Lucky for this frightened creature, a very smart young woman named Connie who is an intern at Recreation and Park Department saw the little dog running in front of a bus on Kezar Drive. As soon as the dog made it out of the street, Connie tried to lure it to a grassy area. Nearby, another young woman named Paige, who is a Psychology student from UCSF, was seated on the lawn and saw the little dog with no collar and she immediately joined Connie to help catch the dog, who was cowering behind a bench, shivering, and terrified.

A nearby Park Station Officer saw the women chasing the dog and intervened to assist in their efforts to help corral the dog who was clearly in great distress. Connie lured the dog out of hiding by sharing her own lunch, and the ravenous pup eagerly consumed every morsel while Paige stood by attempting to build trust with the petrified creature. They obtained some twine and together were able to slowly coax the tiny fugitive into a makeshift lasso....

This poor dog was extremely malnourished, with protruding ribcage, and his coat was covered in dirt. Once he was at ease, he was absolutely the sweetest creature and lapped up affection and cuddles.

#### SAN FRANCISCO POLICE NARCAN TRAINING FOR PARK DISTRICT

Since 2015, the San Francisco Police Department (SFPD) partnered with the Harm Reduction Coalition's Drug Overdose and Education (DOPE) project, as well San Francisco's Department of Public Health. The collaboration has resulted in SFPD patrol vehicles and Foot Beat officers being equipped with lifesaving Naloxone (Narcan) medication.

Naloxone, sold under the brand name, "Narcan", is a medication, which acts to temporarily block the effects of opioids.

SFPD officers have been trained on how to recognize the life threatening overdose symptoms from opioid based drugs, such as heroin and various prescription painkillers. Concurrently, officers have been trained on the rapid deployment and administration of the intranasal Narcan medication as part of their structured emergency, and potentially lifesaving, overdose response protocol.

With the growing illegal use of opiate based prescription medications, such as Fentanyl, (which can be 30-50 times more potent than heroin and 50-100 times more potent than morphine), and Carfentanil (approximately 100 times more potent than fentanyl), there is not only concern for the users, but also the possible exposure to a civilian or officer when they are in contact with a user. Park Station is pleased that its officers, in addition to their duties of stopping the spread of these dangerous narcotics, are now equipped to save the lives that narcotics so often destroy.

SFPD and Park Station would like to thank The San Francisco Department of Public Health for going above and beyond in training and equipping (14) fourteen Park Station Foot Beat officers with this life-saving medication.

To assist San Francisco's diverse electorate, people fluent in Chinese, Spanish, Filipino, Vietnamese, or Korean in addition to English are encouraged to apply. For their day of service, all poll workers receive training, a stipend up to \$195, and a commemorative pin. Apply in person at City Hall, Room 48, Monday—Friday, 10 am—4 pm. #### **DEFINITION OF SUSPICIOUS ACTIVITY**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

If you see suspicious activity, please call the non-emergency dispatch line (415-553-0123). The non-emergency line is for situations that require the police, but do not require an <a href="immediate">immediate</a> police response.

Please attempt to get a description of the subject, description of vehicles involved, location of occurrence, and direction of travel.



#### **DEFINITION OF COMMUNITY POLICING**

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- <u>Homeless Outreach and Outreach to Drug Users</u>: Park Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Park Station runs full time beat officers assigned to Haight Street.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Weekly Email Updates</u>: Park Station sends out weekly email newsletter updates to residents in the District that alerts residents to crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



#### **CRIME NOTES**

#### **Definitions**

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

\*Assault is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

#### PARK STATION—ARREST / CITATIONS

#### Arson/ Vandalism to Property/fire Report—1400 block of Hayes St. -05/16/2018 12:02 am

Officers responded to a call of a possible arson suspect located in the above area. Officers spoke with a witness, who stated that he observed a fire emerge from a porta potty and then observed the suspect appear from behind it. The suspect was placed under arrest for arson and officers transported him to Park Station pending further investigation. The suspect was later transported to County Jail for arson, vandalism, and possession of an incendiary device with intent to set a fire.

### <u>Warrant Arrest/Methamphetamine Offense/Paraphernalia Possession—McAllister St. /Central Ave.</u> 05/17/2018 8:41 am

Officers were dispatched to the area regarding a trespasser inside of a stairwell leading to Central Ave. Officers made contact with the subject and it was discovered that he had a bench warrant for vandalism for his arrest. Officers transported the suspect to Park Station, and while performing an arrest search, officers located a glass pipe with white residue, a silver container with a substance suspected to be methamphetamine.

#### Vehicle Burglary/ Parole Violation—100 block of Villa Ter.—05/17/2018 11:20 am

Officers responded to the area regarding an auto boost report. Officers made contact with the victim, who stated that he had observed the suspect in his parked car. Officers detained the suspect, and the victim was able to positively identified the suspect. Officers placed the suspect under arrest and transported him to Park Station. A computer check revealed the subject to be on active felony parole out of Contra Costa County for driving under the influence of alcohol. The subject was later transported to SFGH to be evaluated for mental health detention.

#### Warrant Arrest/Local SF Warrant—1500 block of Haight St.—05/17/2018 4:05 pm

Officers recognized a wanted subject in the above area. Officers detained the subject and it was discovered that he had a misdemeanor warrant out of San Francisco for failure to appear. The subject was arrested for his warrant and charges.

#### Civil Sidewalks Citation—300 block of Castro St.—05/18/2018 10:37 am

Officer observed a subject laying on the sidewalk in violation of the city's sit-lie ordinance and issued him a citation.

# Public Nuisance/ Municipal Police Code Violation—200 block of Herman St.—05/18/2018 2:11 pm Officers responded to the area regarding a possible trespassing incident. Upon arrival, officers observed a male subject sleeping in a sleeping bag surrounded by uncapped syringes and spoiled food. Officers spoke with the resident of the building who stated that she asked the subject to leave and he refused. Officers cited the subject, who cleaned up the mess he created in the driveway.

Traffic Violation Arrest/ Driving with No License Issued—Fulton St. /Stanyan St.—05/18/2018 4:06 pm Officers observed the right rear break light of a vehicle traveling in the area not to be in working condition. Officers conducted a traffic stop and made contact with the driver. It was discovered that the subject did not have insurance or a driver's license issued and he was cited for his violations.





#### CAPTAIN BAILEY'S TIP OF THE WEEK TO PREVENT OR SOLVE CRIME

I want to take this time to remind everyone to record the serial numbers of all your valuables i.e. bikes, tools etc. You can do this by simply taking a photo of the item and then zoom in to take a photo of the serial number. Most people have smart phones and you can easily use your phone camera to achieve this. This is really great information for you to have in the event you are a victim of a theft. We can post the photos on flyers and record the serial numbers of your possessions so that in the event we make an arrest of an individual with stolen items your items will be easily recognizable. Officers can also identify them easily if they are being sold at any location. Bottom line having this information increases your chances of being reunited with your stolen items. It also increases the chances of these thieves being held accountable for their crimes.

Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.

7 Residential Safety Tips



- Garage: When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- Car: Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- Spare Key: Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- Open Buzzer: When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- Security Cameras & Alarm Systems: Cost effective tools for preventing crime and identifying criminals.
- Light Timers: Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- Doors/Windows: Always keep doors and windows locked.

#### Door and Window Safety

#### Doors:

- . Should be made of solid wood or metal
- Have a single cylinder deadbolt lock and a 1-inch bolt
- Have a front door viewer or peep hole with a 180-degree range
- Clearly display unit number

#### Windows:

- Replace if glass is cracked and replace all damaged or missing locks
- Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

#### SAFETY TIP FROM S.F. SAFE



Safety tip for your home:

Help first responders by making sure your address numbers are mounted on a high-contrast background, and that they're illuminated when it's dark.

#### **HELPFUL TIPS**

#### **DON'T BE CAUGHT EMPTY-HANDED!!!!**

- 1. When placing an online or phone order, request signed confirmation upon delivery
- 2. Deliver packages to your office if at all possible; if not, deliver to a neighbor who will be home to sign for your package
- 3. If ordering from Amazon, use a self-service Amazon locker located throughout San Francisco; they will send you a notification email when the package is received. Go to Amazon.com and search for "Amazon Locker"
- 4. For U.S. Postal Service deliveries, you can authorize USPS to have certain deliveries left in a garage, with your neighbor, etc.; first you will need to create an account at USPS.com. Also check out "UPS My Choice" where you can log on to UPS.com and track your package to reroute, reschedule, or authorize a shipment release for your delivery. Get a PO box for deliveries for extra security
- 5. Shipping via UPS? Go online to UPS.com and search for "UPS Access Point"; neighborhood stores that will hold your packages for you
- 6. There are several apps available in San Francisco that allow you to ship to a package destination, and then will schedule the delivery to your home once you are available
- 7. Set up a delivery alert by email or text as to when your package has been delivered
- 8. Pay for insurance to cover the cost of the item shipped if lost, damaged or stolen
- 9. Never let a package sit unattended on your doorstep; package theft is very high in San Francisco.



#### WHO AND WHEN TO CALL?


**3-1-1:** Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

Non- Emergency San Francisco Dispatch Line: Pease call the non- emergency dispatch line (415-553-0123) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, suspicious activities, or a homeless/nuisance related issue. The non-emergency line is for situations that require the police, but do not require an immediate police response.


9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency. The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1**.

- PICK UP THE SYRINGE IN THE CENTER WITH THE NEEDLE POINTING AWAY FROM YOU AND PLACE THE SYRINGE IN THE CONTAINER.
- SEAL THE CONTAINER AND BRING TO YOUR LOCAL SYRINGE ACCESS PROGRAM OR DROP IT OFF AT A 24-HOUR DISPOSAL SITE.

#### What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.
