





Robbery Spree Arrests – 1/16/18

Olmstead / Girard 6:00 pm

A 56 year old victim was walking home when she heard someone running behind her. She turned to see two suspects approaching quickly. One of them grabbed her purse which was strapped over her shoulder. The suspect knocked the victim over and stole the purse. The suspects ran off on foot and turned a corner. A witness in a passing vehicle attempted to stop the suspects but was unsuccessful. He was identified to the officers and provided the description of their get-away vehicle, which was occupied by at least one other suspect.

Unit block Ledyard – 6:00 pm

A 54 year old victim had come home from shopping and was getting ready to enter her home when three suspects came up behind her and one of them grabbed her purse. The violence of the shove caused the victim to fall to the

ground. Officers located a witness that saw the three suspects get into a silver Mercedes that sped from the scene. Officers were also able to locate surveillance footage from the area. Officers searched the area and located a purse on the 100 block of Ledyard. The purse turned out to have been the one stolen in the above Olmstead/Girard robbery which was believed to be perpetrated by the same suspects. The contents were missing the wallet and credit cards as well as a cell phone.

• 1635 Revere – 6:45 pm

A 16 year old victim got off a bus and was walking home when a suspect approached him from behind. The victim turned and saw a second suspect close by as the first suspect shoved him to the ground and ripped his gold chain and pendant from his neck. Both suspect fled on foot. A witness came forward with some video of the suspects.

The officers ensured that the credit card companies of the victim's whose purses were stolen were notified that the suspects had attempted to use one of the victims' credit cards at Target on the **700 block of Mission** and a charge was currently being attempted at Nordstrom's in the Westfield Mall. The officers notified Tenderloin units who responded and detained all four suspects as they made their way out of the mall. They were positively identified in the two purse snatches and were taken into custody. Further investigation revealed that one of the suspects had the stolen gold chain and pendant from the Revere St. robbery in his possession. The suspects were booked on multiple counts of robbery, possession of stolen property, and conspiracy for their respective roles in the robbery spree. (SFPD Case No. 180042102, 180042152, 180042180)

Aggravated Assault- 100 block Napoleon - 1/17/18, 3:30 pm

A 27 year old victim was driving in the area when and was entering a driveway near a couple of subjects skateboarding on the sidewalk. One of the subjects accused the victim of almost hitting her and used her skateboard to bash the victim's windshield in. The victim got out and managed to get the skateboard away from the suspect, sitting on her as she called for police. As she did so, the suspect's companion forcefully removed the victim, freeing the suspects. Both suspects fled on foot. This incident is under investigation. (SFPD Case No. 180044396)

Robbery, Aggravated Assault Arrest- 5900 block 3rd - 1/19/18, 4:04 pm

A business owner called the police after being robbed by two subjects at his establishment. The officers responded to the market and met with the victim who told them that he observed two subjects stealing items from his store and confronted them. One of the suspects punched the victim in the face while the second picked up a wooden shelf and struck him with it. The suspects fled on foot but were located by the officers during their search and were detained. After being positively identified, both suspects were arrested and booked on robbery and aggravated assault charges. (SFPD Case No. 180050525)

Aggravated Assault, Robbery – 2400 block San Bruno – 1/19/18, 4:06 pm

An employee of an electronics store was using his personal laptop at the front counter when a suspect entered the establishment. The suspect asked about phones and looked around for several minutes. The victim became concerned when the suspect began to cover his face with his hood. The victim started to pull his laptop back towards him when the suspect grabbed it and yanked it away. He then walked out of the store and to a waiting white sedan, which was being driven by a second suspect. The victim followed the suspect and got in front of the car to prevent them from leaving. The suspects drove off anyway, striking the victim with the car and causing him to fall to the sidewalk, hitting his head. The victim was treated at ZSFGH for his injuries. This incident is under investigation. (SFPD Case No. 180050036)

Armed Robbery- 500 block Harney - 1/20/18, 5:04 pm

A 37 year old victim was standing next to his parked vehicle when a Honda Accord and a black SUV pulled up to him. A suspect got out of the Honda and brandished a gun at the victim. He ordered the victim to give up the camera that he was holding. The victim, in fear for his life, complied. Additional suspects got out of the two vehicles and began going the victim's car, removing items from the passenger compartment and trunk. They then got back into their vehicles and drove off. This incident is under investigation. (SFPD Case No. 180052929)

Aggravated Assault with Veh, Hit and Run– Bayshore / Donner – 1/20/18, 6:00 pm

A 65 year old victim was standing at the corner when a black Audi pulled up and stopped at the intersection. The passenger of the vehicle "flipped off" the victim

to which he replied with an expletive. The driver yelled something at the victim before driving off. The vehicle continued south on Bayshore then made a U-turn. As the victim crossed the street from the east to the west side of Bayshore, the vehicle sped up and struck him, launching the victim on to the hood before he rolled off and hit the ground. The suspect vehicle fled the scene. The victim suffered serious injuries and was transported to ZSFGH for treatment. This incident is under investigation. (SFPD Case No. 180052963)

Firearm Arrest- 1000 block Fairfax - 1/20/18, 7:06 pm

Bayview officers had developed information that a particular suspect, who was an active West Mob criminal street gang member, was in possession of a firearm and had been recently driving a gray Mercedes. The officers, while on patrol, spotted the vehicle and notice the suspect walking to the car. When he arrived, he was detained. The officers conducted a probable cause search of the suspect and vehicle and recovered a **loaded .40 caliber semi-automatic pistol** in the vehicle. The suspect, a convicted felon prohibited from possessing weapons, was arrested and booked on multiple weapon related charges. (SFPD Case No. 180053109)

Burglary Arrest- 1000 block Pennsylvania – 1/21/18, 11:15 am

Officers responded to a call of a burglary suspect and met with the victim of a burglary from two days prior. He told the officers that his bike had been stolen from his residence and that the incident had been captured on surveillance footage. He told the officers that he had just seen the suspect riding his bicycle in the area of 23rd and Pennsylvania. The officers responded to the location and located the suspect and stolen bicycle at a homeless encampment. He was placed under arrest and booked on burglary and possession of stolen property charges. (SFPD Case No. 180049089)

Robbery- Gilman / 3rd - 1/21/18, 2:45 pm

Officers responded to a call of multiple subject involved in a fight on a MUNI bus. All of the suspects had fled the scene. Pepper spray had been used in the altercation by one of the combatants and multiple passengers had been sprayed or inhaled the chemical due to proximity. The victims (5 total) ranged in age from 26 to 65. One of the victim's told the officers that one of the suspects had stolen her cell phone from her while she was overwhelmed in the chaos. All of the victims were treated at the scene and released. This incident is under

investigation. (SFPD Case No. 180054890)

Robbery - 100 block Bayshore - 1/22/18, 9:23 pm

A 41 year old victim was walking to the convenience store of a gas station with his wallet in his hand when he was approached by two suspects. One of the suspects punched him in the face, causing him to fall, as the second suspect snatched his wallet. Both suspects fled on foot. This incident is under investigation. (SFPD Case No. 180056119)

Burglary Arrest - 1500 block Griffith - 1/23/18, 12:15 am

Officers responded to a call of a burglary in progress at a warehouse being used as a commercial marijuana grow facility. Officers approaching the area nabbed a suspect running from the scene. He had a police scanner app open on his phone and was monitoring the police activity in the area when he was detained. The witness who made the 911 call positively identified the suspect. The witness told the officers that he was working late across the street from the burglarized warehouse when he heard loud pounding. He looked out a window and saw two cars parked in front of the establishment and five suspects, carrying bags, entering the door that they had forced open. The witness called 911 and within minutes watched all the suspects run out and get into their respective cars. Before they drove away, one of the suspects got out and started to run on foot. That is the suspect that the officers had under arrest. The owner of the burglarized business responded to the scene and reported that although the outer and several inner doors had been breached, the suspects did not have time to steal anything before their efforts were thwarted. The officers were able to obtain security footage of the suspects. The one suspect in custody, a parolee, was booked on multiple burglary related charges. An investigation into the identity of his outstanding conspirators is ongoing. (SFPD Case No. 180059301)

Suspicious Activity Defined

Suspicious activity is any observed behavior that could indicate a crime-related incident had been committed, or about to be committed.

Examples:

- An individual peering into vehicles or trying door handles, appearing to trying to locate any valuables
- An individual checking front doors of residences, or attempting to locate unattended packages, or following delivery trucks to see where packages are being dropped off.

Community Policing Defined

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the community.

 Homeless Outreach and outreach to Drug Users: Bayview Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support

- <u>Foot Patrols</u>: Bayview Station has beat officers assigned to the 3rd St. corridor, 18th St., and San Bruno Avenue.
- Monthly Community Relations Meetings: Community Meetings are held continuously on the first Tuesday of each month. Officers also attend meetings with merchant groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving
- <u>Email Updates:</u> Bayview Station sends out weekly newsletter updates to district residents that outline crime trends, upcoming community events, crime prevention tips, and contact information.

Crime Defined

Robbery- The taking of property from another by use of force or fear.

Assault- The unlawful attempt, coupled with present ability, to commit a violent injury on another person. *Assault* is when a person swings their arm and *Battery* is when that arm makes contact with another.

Misdemeanor Battery- Any willful and unlawful touching of another

Felony Battery- The use of force or violence upon the person of another that causes serious bodily injury.

Aggravated Assault- Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

Burglary- The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft- Theft committed when the value of the money, labor, or property taken exceeds \$950

Petty Theft- Theft where the value of property taken is less than \$950

Types of Crime Reports That Can Be Filed Online:

- Harassing Phone Calls: When you are experiencing annoying calls with no known suspects; for example, hang-ups or heavy breathing.
- Lost Property: When property has disappeared and not stolen. If you think it could have been taken but you have no idea by who, you may enter the report online.
- Theft: When property is stolen but there has been no illegal entry or contact by the thief.
- Vandalism/Graffiti: The act of changing, modifying or defacing public or private property, including graffiti.
- Vehicle Burglary: When property was stolen from a vehicle.
- Vehicle Tampering: Tampering with a motor vehicle, including vandalism/graffiti of the vehicle

Calling the Police:

Dispatchers ask questions in a particular order for a reason. It is best to stay calm and answer all questions to the best of your ability.

Complaint: Location, Hazards (ie. weapons at scene), Victim info (sex, age, condition)
Suspect Description: Gender, Race, Age, Clothing, distinguishing features
Vehicle Description: Color, Make, Model, License Plate, distinguishing features

There is a new secured bin at Bayview Station where you can dispose of unwanted and expired medication at any time of the day or night. The bin will accept any type of prescription and off the shelf medication **except** for:

- · Herbal Remedies
- Vitamins
- Supplements
- Cosmetics
- · Other personal care products
- · Compressed Cylinders
- · Aerosols
- · Inhalers
- · Medical Devices
- Sharps
- · Illicit drugs
- · L odine containing medication.

When disposing the medication, please leave it in the original container with your personal information crossed out or removed. You can also place the medication into a



clear plastic zip top baggies. Contact the front desk officer and inform them that you want your medication dispose of. The officer will assist you.

Please note that once an item that had been disposed of inside the bin, we cannot retrieve it. So make sure your ring, cell phone or anything of value is not accidentally disposed of.

With over 2,300 different telephone numbers listed to access local government services, many people did not know what number to dial to reach the appropriate department. Now you can connect to city services with only two numbers to remember: **911** for emergencies and **3-1-1** for everything else.

Before 311, over 50% of calls to the 911 center were not emergency related. **311** relieves 911 operators from these non-emergency calls. If a catastrophic emergency such as an earthquake occurs, **311** operators will be able to provide accurate information to assist during the recovery. In the unlikely event the 911 facilities becomes inoperative, the **311** call center will function as a back up.
