Suspect in Custody for Gunfire on Broadway

On Sunday, May 27, 2018 at 01:34 AM, Officer Colleen Fitzpatrick and Officer Alexander Anton were on-duty patrolling the area of Broadway and Columbus Avenue. Both officers heard what they recognized to be several shots of gunfire from the 400 block of Broadway. They immediately located a witness who pointed to the suspect who was attempting to flee the scene by getting to his parked car. Officer Anton pursued the suspect and with the assistance of Officer Fitzpatrick, Officer Joshua Cabillo, Officer Jonathan Sylvester, Officer Kevin Stucki, and Officer Patrick Backman he was taken into custody.

The incident began as a physical altercation between several parties in the area.

Three firearms were located by the arresting officers and retained as evidence. The suspect, an adult male from Hayward, was booked on multiple charges. Luckily, no one was injured as a result of this incident.

The Central Investigations Team is still actively investigating this case. Thanks to the officers named above for taking a dangerous and armed Suspect in custody.





Incidents of Note

Robbery, Residence, With Gun 5/14/18 2316 hrs 900 BLK of Larkin St

On 05/14/18, uniformed officers on patrol were flagged down by a pedestrian and notified of a takeover robbery with a gun occurring. The officers responded to the location and set up a perimeter. An officer began to make entry, Suspect #1 pointed a firearm at the officers and claimed to be law enforcement. The suspect fled the scene on foot but was apprehended shortly after a firearm was recovered from his person. Officers set up a perimeter around the initial location and ordered potential suspects out of the building. A second suspect was located around the building he initially claimed to be homeless and just looking for a place to sleep. The officers learned that two suspects entered the residence and forced the victim to the ground using their firearms as they looked for money and narcotics. During the investigation, the officers determined that the second suspect was involved in the incident. A search of the residence was conducted and evidence was seized, including a second firearm. Both suspects were booked at County Jail.

Shoplifting, Force Against Agent 5/20/18 1519 hrs 100 BLK of Powell St

On 5/20/18, uniformed officers responded to a retail store regarding a theft. Officers made contact with Victim #2 who is a loss prevention agent for the store. Officers learned that the suspect hit and bit the victim after he attempted to detain her as she walked out of the store with stolen merchandise. A second suspect was able to get away from the victim during his struggle to detain suspect #1. Suspect #1 was booked at the Juvenile Justice Center.

Burglary, Non-Residential, Unlawful Entry 5/27/18 1427 hrs 600 BLK of Geary St

On 4/30/18, Victim #2 responded to Central Station to make a report regarding the theft of a bicycle from his store. The Victim stated a suspect entered the store and asked to test ride a bicycle. The suspect left his identification for the test ride but never returned with the bicycle. A crime bulletin was issued regarding the incident. On 5/27/18, uniformed officers observed the suspect and identified him as being the suspect in the crime bulletin. The suspect was arrested and booked at County Jail.

San Francisco Police Make Arrest in Cold Case Homicides

On December 9, 1999 at approximately 7:00 PM, San Francisco Police responded to an incident in an apartment building on the 400 block of Bush Street. Former University of Nevada, Las Vegas (UNLV) swimmer Kameron Sengthavy, a 25 year-old male, was found deceased from apparent stab wounds.

On June 1, 2000 at approximately 7:00 AM SFPD officers responded to a gas station at Washington and Van Ness Streets where the body of a gas station attendant, Thomas Lee, a 60 year-old San Francisco resident was found shot by an unknown assailant.

Investigators from the SFPD Homicide Detail conducted investigations of these crimes. After exhausting all leads, these investigations were assigned to the Department's Cold Case Unit.

In early 2018, investigators from the SFPD Homicide Detail's Cold Case Unit developed information that led to the identity of the suspect in these two homicides. The suspect was determined to be a Donovan Ray Lacy, a 38 year-old male.

Lacy is currently serving time in a Florida prison for several bank robberies he committed in that state. Lacy, however, had previously lived in the Bay Area and was brought back to Marin County to stand trial for several bank robberies that occurred in 2012 and 2013. In January of 2014, Lacy was convicted on the Marin County bank robbery charges and was sentenced to 105 years in prison. Following his sentencing in Marin County, Lacy was transported back to Florida. A booking photo of Lacy from Marin County Sheriff's Office accompanies this news release.

SFPD investigators gathered evidence and developed probable cause to charge Lacy with the murders of Sengthavy and Lee. An arrest warrant has been issued charging Lacy with two counts of homicide. Lacy is expected to be extradited to San Francisco to stand trial for the murders.

Upon conclusion of the San Francisco murder trials, Lacy is expected to return to Florida to finish out his nine-year sentence for bank robbery. He would then be transported back to Marin County and serve out his 105-year sentence for the 2012 and 2013 bank robbery convictions.

While an arrest has been made in these cases, they remain open investigations. Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles to locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Central Station officers coordinate with city
 agencies to provide outreach and assistance to rehabilitate those who are dependent on
 illegal drugs and outreach to homeless individuals to connect them with resources and
 support.
- <u>Foot Patrols</u>: Central Station have beat officers assigned to Union Square, Fisherman's Wharf, Chinatown, North Beach and Market/Drumm area.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Central Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- 2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- 3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
