Thank you so much for attending the Public Safety Meeting for North Beach this past Monday night at the Tel Hi Center.

Approximately 300 community members attended the meeting and shared a dialogue with a panel consisting of Chief of Police Bill Scott, Commander David Lazar from Heathy Streets of Operation Center (HSOC), Edwin Batongbacal from the Department of Public Health (DPH), Eileen Loughran from DPH Jazmin Barrera from DPH, Randy Quezada from the Department of Homelessness and Supportive Housing (DHSH) and me. The discussion was skillfully moderated by Supervisor Aaron Peskin.

I want to personally thank you for taking the time to be at this meeting and for the opportunity to present the homeless outreach and enforcement strategy for Central Police Station. My personal "take away" and "action items" for the officers at Central Station are:

- Increased police presence and enforcement at our Parks and Schools
- Continued enhanced enforcement of code violations by subjects and referrals to outreach services for the entire Central District.

For garbage or abandoned homeless debris, use the 311 app.





Incidents of Note

Attempted Homicide, Property Theft - Arrest Made 9/23/18 2:09PM Julia St/Minna St

On 8/13/18, a suspect struck a victim multiple times on the head with a blunt object at "Parrot Park," located at Clay and Davis St. The victim sustained life threatening injures. The suspect then stole property from a second victim who witnessed the assault. The suspect fled the area prior to police arrival. Central Station Investigation Team (SIT) conducted an investigation, identified the suspect and disseminated a crime bulletin for the suspect's arrest.

After reading Central SIT's crime bulletin, Southern Station officers located the suspect at the United Nations Plaza on 9/23/18. Officers arrested and booked the suspect at the County Jail for attempted murder, assault with a deadly weapon, and theft.

Vehicle Theft, Possession of Stolen Property, Possession of Burglary Tools- Arrest Made 9/24/18 11:51AM 700 BLK of Taylor St

On 9/24/18, officers responded to the 700 BLK of Taylor St on a report of vehicle theft in-progress. Upon arrival, officers observed a suspect attempting to pry open the door to the victim's vehicle. Officers detained the suspect who alleged that he was the owner of the vehicle and had left his keys inside the car. A records check on the vehicle revealed it was reported stolen out of San Jose. The suspect was arrested and booked at the County Jail for vehicle theft, possession of stolen property and possession of burglary tools.

Attempted Burglary, Possession of Burglary Tools- Arrest Made 9/24/18 1:24AM 1300 BLK of Larkin St

On 9/24/18, officers responded to the 1300 BLK of Larkin St on a report of a burglary. Officers searched the area and located the suspect who attempted to flee the area on foot. A witness at the scene identified the suspect as the same subject who was using a screwdriver and hammer to gain entry a building. The suspect was arrested and booked at the County Jail for attempted burglary and possession of burglary tools.

Robbery, Burglary, Grand Theft - Arrest Made

9/16/18 6:15PM 9/21/18 12:28PM Unit BLK of O'Farrell St

On 9/16/18, a suspect entered a retail store on the Unit BLK of O'Farrell and cut security cables off several hand bags. When an employee attempted to intervene to stop the theft, the suspect threatened to shoot the employee - no gun was seen. The suspect completed the robbery and made off with \$5,140.00 in merchandise.

On 9/21/18, the suspect returned to the same retail store and again cut security cables with a pair of sheers. The suspect raised the sheers when employees tried to approach the suspect and again threated to shoot a Barney's employee. The suspect then stole four purses valued at \$8,890.00 and fled the area on foot.

On 9/25/18, Central Station published a Crime Bulletin containing still photos obtained from surveillance cameras and disseminated it to all sworn SFPD personnel.

On 9/26/18, Tenderloin Station officers read the crime bulletin, recognized the suspect from prior contacts, and located the suspect on Larkin St and McAllister St. Officers arrested the suspect for both robberies. The suspect was booked at the County Jail for robbery, grand theft, and burglary.

Theft from Locked Vehicle, Possession of Stolen Property, Probation Violation - Arrest Made 9/29/18 4:45PM Unit BLK of Bay St

On 9/29/18, Central Plainclothes Officers conducted a vehicle burglary abatement on the Unit BLK of Bay St. Officers observed a suspect reach inside the open window of a locked vehicle to remove a suitcase. Officer detained the suspect and placed the suspect under arrest for grand theft and possession of stolen property. Since the suspect was on probation for vandalism and attempted burglary, he was additionally arrested for violating his probation. The suspect was booked at the County Jail.

Terrorist Threats, Brandishing a Weapon, Resisting a Peace Officer - Arrest Made 10/01/18 5:51AM 1500 BLK of Sacramento St

On 10/01/18, a suspect brandished a box cutter and threated to cause harm to a victim on the 1500 BLK of Sacramento St. Officers located the suspect on the 1400 BLK of Larkin St and ordered the suspect to the ground. When the suspect refused to comply with orders and continued to approach officers with clenched fists, officers used less-lethal options to gain compliance.


The suspect was medically cleared at San Francisco General Hospital and booked at the County Jail for terrorist threats, brandishing a weapon, and resisting arrest.

San Francisco Police Make Arrests in Central District Auto Burglary Investigations

On September 15, 2018 at approximately 8:30 PM, the Central District plainclothes team were conducting auto burglary abatement in the Fisherman's Wharf area. Officers observed a black vehicle with dealer plates exit a public garage on the 300 block of Beach Street. This garage is known to be frequented by auto burglars. Officers conducted surveillance of the vehicle and saw it stop in a parking space on Greenwich Street. When it pulled away from a parking space on Greenwich Street, officers saw property on the ground where the vehicle had been parked.

The officers seized the property and continued the surveillance. When the car pulled in to a gas station the officers recognized the driver as a habitual auto burglar. The officers detained Daevon James and saw in plain view a passport which didn't belong to James, broken glass on the driver's side floor board of the car and a silver laptop which later was determined to be stolen. Two of the officers returned to the public parking garage on the 300 block of Beach Street, where they located two vehicles with shattered windows. Officers located victims who were able to identify the items that had been earlier discarded on Greenwich Street.

Twenty-five year-old San Francisco resident, Daevon James was arrested and booked at county jail for three counts of burglary, three counts of possession of stolen property, and possession of burglary tools.

On September 16, 2018 at approximately 6:30 PM, the Central District plainclothes team were conducting auto burglary abatement near the area of Chestnut Street and Columbus Street. Officers witnessed an unknown male exit the driver's seat of his vehicle, break the rear window of a parked car and reach inside. Twenty-one year-old, San Francisco resident, Shaheen Ali was taken into custody after a brief foot chase. Ali was booked at county jail for 2nd degree burglary, possession of burglary tools, possession of stolen property and resisting arrest.

On September 17, 2018 at approximately 5:56 PM, Central District plainclothes officers received information from a parking lot attendant that suspects driving a Honda were casing vehicles inside a parking garage on the unit block of Francisco Street. Officers conducted surveillance on that vehicle. Officers observed the suspect break the window of a car that was parked next to him. The suspect then reached inside and grabbed two bags from the victim's car. The suspect returned to his vehicle and fled the scene. Officers continued surveillance of the vehicle as it drove to Midway Street and saw items being discarded from the Honda. The suspect vehicle left the scene and drove back to the garage on Francisco Street. Officers surrounded the garage and witnessed the suspects attempting to exit the garage. The suspects were immediately taken into custody without incident.

Nineteen year old Antioch resident Raheem Lewis was booked at County jail for 2nd degree burglary, possession of burglary tools and conspiracy. A seventeen year old male was cited for 2nd degree burglary, possession of burglary tools, conspiracy and driving without a license.

SFPD Pink Patch Project



Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles to locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Central Station officers coordinate with city
 agencies to provide outreach and assistance to rehabilitate those who are dependent on
 illegal drugs and outreach to homeless individuals to connect them with resources and
 support.
- <u>Foot Patrols</u>: Central Station have beat officers assigned to Union Square, Fisherman's Wharf, Chinatown, North Beach and Market/Drumm area.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Central Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- 2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- 3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
