Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are “In progress” crimes, which demand an immediate call to 9-1-1:

- ◆ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages, or

Crime Definition

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

***Assault** is when a person swings their arm and battery is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

1:07am Mission & Excelsior Stolen Vehicle

Ingleside Officers Burke and Anderson were on routine patrol when they spotted a U-Haul truck weaving in and out of lanes of traffic on Mission Street. The officers ran the truck's plate which dispatch revealed it was stolen. The officers requested backup and pulled the truck over. The driver had a long history of stealing U-Haul trucks. The company also had a "Stay away" order to keep him from entering U-Haul premises. He also had a warrant for his arrest out of San Mateo County. He was arrested at the scene and transported to Ingleside Station for booking. Report number: 180200598

7:30am 2900 Alemany Burglary

Ingleside Officers Trujillo, Phillips, Chang, Tiffer, Piper, Tillan, Leong, Alejandrino, and Der along with Sergeants Springer, Ly and Walker were investigating a burglary that occurred a few days before at the Pacific Supermarket. Investigators determined the suspects were living at a vacant building on Leland Street. Several arrests have been made at that address for burglary, possession of stolen property, narcotics, and other crimes. On this date the officers searched the building and found the two suspects along with items linking them to the burglary. They were arrested at the scene and booked at Ingleside Station. 4:19pm 300 Blk. Raymond Threats

A traffic dispute resulted in the arrest of one of the participants. The victim told Ingleside Officers Zandanel and Tom that he was driving home when he stopped behind a double parked car. The victim honked and then went around the car. The driver of the double parked car then followed the victim home and rolled down the window, pointing a pistol at the victim, and threatened to shoot him. 9:31pm Kern & Diamond Investigative Detention

Ingleside Officers Lee, Seavey, and Sgt Lau were on routine patrol near the Glen Park BART Station when dispatch notified them about a person casing vehicles in the BART and nearby parking lots. The officers found a suspicious vehicle, without license plates, double parked on Kern Street near Diamond. The officers exited their patrol car and walked to the window, but before they could interview the occupants, the driver reversed the car and backed out of the street, drove through the neighborhood and onto southbound #280. The officers, along with several other Ingleside units, finally corralled the car at Ocean and Phelan. A Safeway manager called police to report a robbery and assault by woman thief. The shoplifter fought the manager at the store's entrance as he tried to stop her from leaving with several items. He was unsuccessful and the thief, along with an accomplice, left the store and boarded a #14 Muni bus with the stolen items including, coffee creamer, a hair dryer, Trix Cereal, a loaf of bread, Swiffer pads, juice, coffee, and Red Lobster Biscuit Mix. 9:15am 500 Blk. Leland Warrant Arrest

Ingleside Officer Wong and Sgt. Kumli spotted two men leaving a vacant building where several times people have been removed for trespassing and other crimes. These two men were carrying several women's purses and handbags. The officers stopped the pair who consented to a search. The search revealed a key to nearby Honda Odyssey and the claim from one of the men that the items belonged to another squatter in the abandoned building. The officers called for assistance and Ingleside Officers Piper, Phillips, Trujillo, Lau, Foxworth, Espinoza, Ocreto, and Mora arrived. They entered the vacant building and found several other men and women inside along with a knife, machete, a BB gun, and three BB rifles. Robbers sometimes use replica handguns in their crimes. All the weapons were taken to Ingleside Station for safe keeping. All the individuals inside admitted they did not have permission to be in the building. One of the suspects turned out to have an outstanding warrant for his arrest. He was subsequently arrested for the warrant. Another occupant had a pipe on him used for smoking methamphetamine. An additional pipe was found inside the same persons Honda Odyssey. The owner of the Honda was cited for possession of the narcotics paraphernalia. Report number: 180201916

5:44pm Highway #280 & Monterey Stolen Vehicle

Ingleside Officers Peralta and Harper were on their way back to the station when they spotted a speeding Honda Civic traveling south on highway #280. The officers ran the plate which turned out to be stolen out of Broadmoor. Peralta and Harper notified dispatch and followed the Honda until it was pulled over at Seramonte and Junipero Serra Blvd. Now joined by other Ingleside officers, Peralta and Harper removed the driver and placed him under arrest. The suspect suddenly bolted from the line, hitting the manager with his shoulder, and ran out of the store dropping items by the front door. Ingleside Officers Billings and George observed a black Pontiac traveling at a high rate of speed, blowing through stop signs, and ignoring other traffic codes. The officers followed the suspect and finally stopped him in a parking lot on the 1600 block of Sunnydale. The officers asked the suspect for his license, registration, and insurance. He refused using obscene remarks towards the officers. Ingleside Officers Scott and Hardy arrived to assist in the arrest. An observant Ingleside Sgt. Kumli spotted a suspicious man standing on the walkway near the skate park at Ocean and San Jose. The man was looking around and looked very nervous. A possible burglar inside a construction project prompted witnesses to call 911. Ingleside Officers Parker and Cagney, along with other units responded to the scene and searched the entire building without success. After the search, Officers Parker and Cagney went around to the back of the structure and found the woman suspect crawling on her back under the chain link fence trying to escape. She was quickly placed into custody, but not without considerable effort. 1:00Pm 800 Block University Attempted Robbery

An online ad for a BMW that seemed like a good deal led to an attempted robbery, a citywide police chase, and the eventual arrest of three men, two of them young men. It started when a family saw an online ad on "Offer Up", by a seller named "Mike". The seller asked the buyers to travel to the 800 block of University to see the car. When the prospective buyers got there they found three men in an Infiniti, without proper plates, with one of the men holding a gun and pointed it at the hopeful buyers. The victims, quickly backed out and escaped. The suspect's took off and were later spotted on O'Shaugnessy Blvd. by Sgt. Healy of another division. He tried to stop the suspects who then took off at a high rate of speed. The suspects fled through the Mt. Davidson neighborhood and onto Monterey Blvd with several Ingleside and Taraval units pursuing. The three suspects traveled onto northbound highway #280 and then eastbound #101 toward the Bay Bridge where Ingleside Captain Hart spotted the vehicle and suspects. He surreptitiously followed the Infiniti while radioing for help. Capt. Hart, now joined by Officers Fewer, Alvarado, and Lim, were flagged down at 2nd and King Streets where a motorist said one suspect jumped out of the Infiniti, took off his jacket, threw it on the ground, and jumped over a railing. He was quickly found hiding in a stairway of a building on the unit block of King. Meanwhile, other motorists flagged down Officers Fillippi, Biagini, and Zahn saying the Infiniti had got into an accident on the dead end of Delancey Street. The officers broadcast a description and several other officers arrived and found the two remaining suspects hiding inside a building on Townsend Street. All were quickly arrested. Two were taken to the Juvenile Justice Center and one was transported to the County Jail. They were charged with attempted robbery, aggravated assault with a gun, carrying a loaded firearm with intent to commit a felony, and several other crimes. A firearm with a 30 round extended clip that was used in the attempted robbery was also located nearby. Report number: 180194474

A woman was walking westbound on South Hill Blvd., near Chicago Way, noticed an older Honda drive up next to her and stop. A young man got out of the Honda and grabbed the victim's purse. 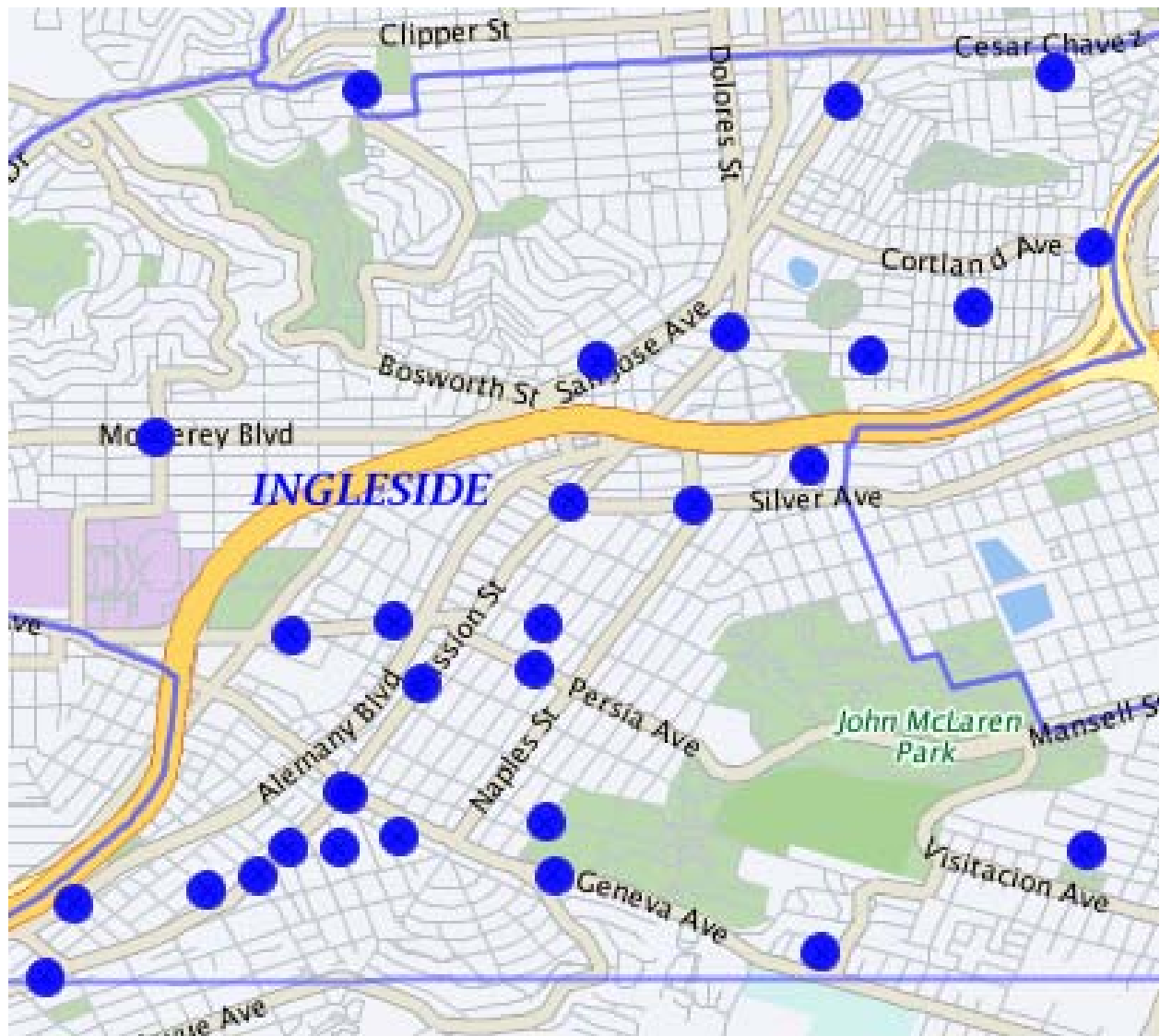
11:50pm Unit Blk. Dichiera Ct. Aggravated Assault

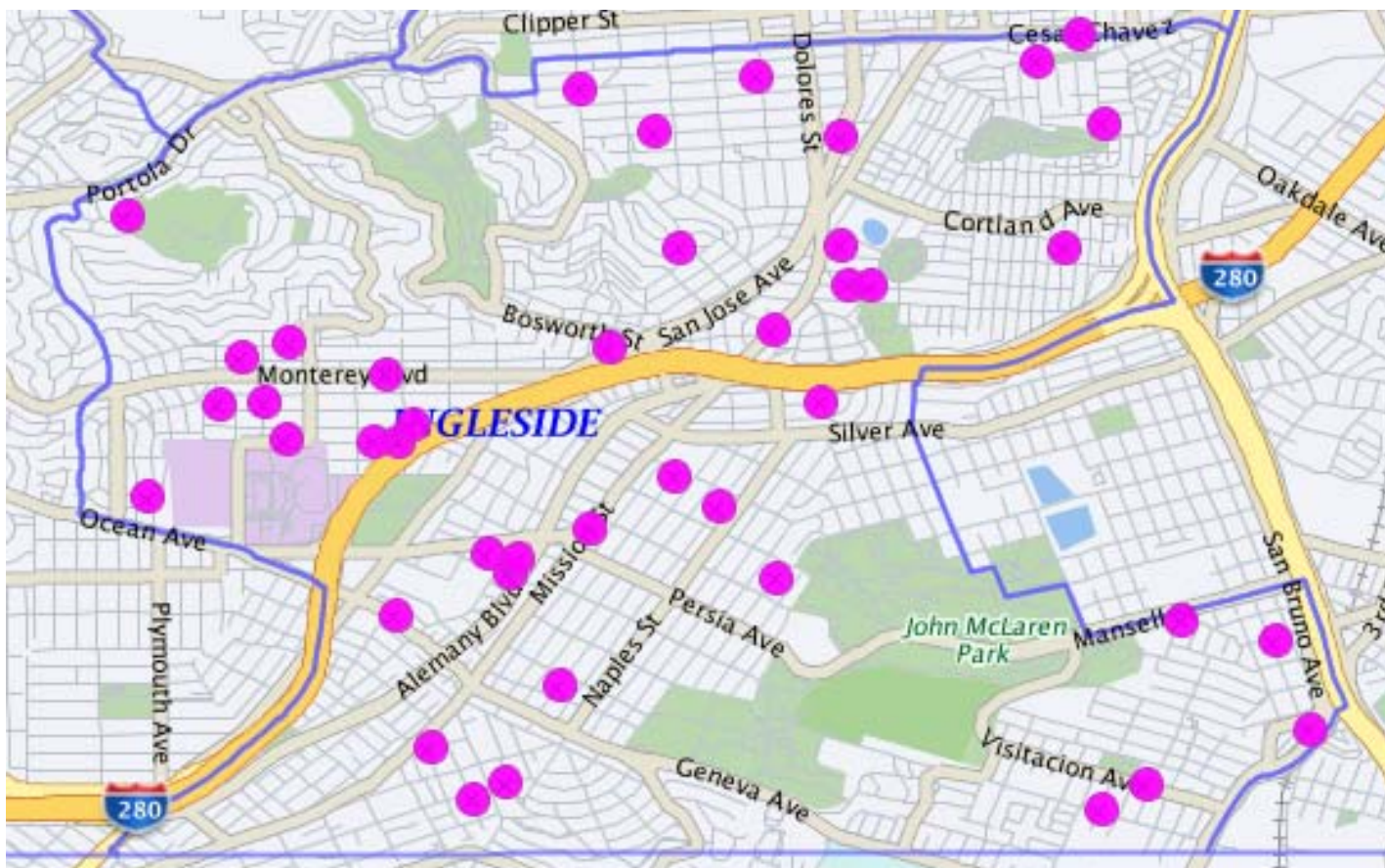

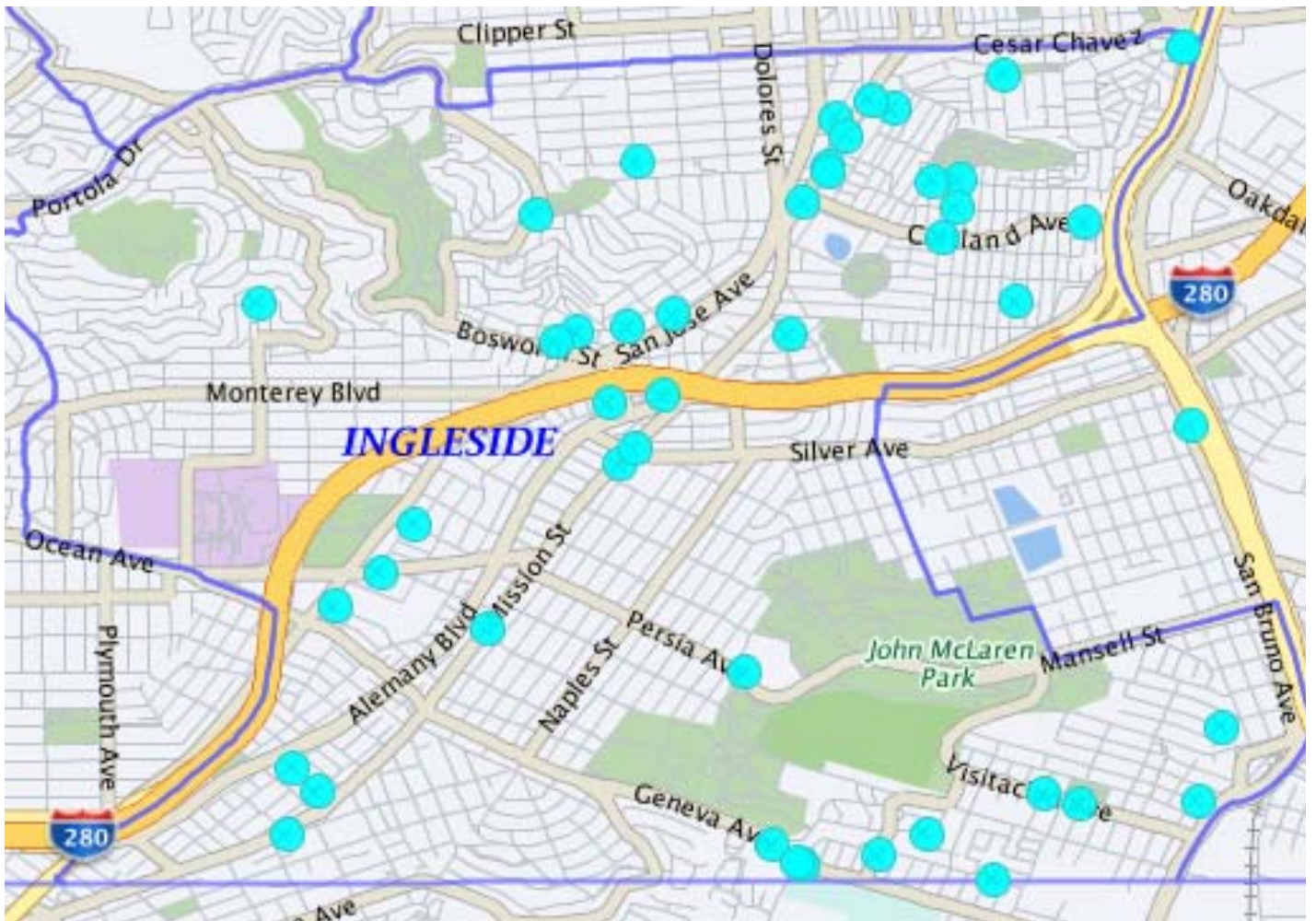

Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on March 14th, 22nd and 28th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

San Francisco Police Department Releases 2017 Year-End Crime Statistics

Data shows decrease in homicides, shooting incidents, burglaries and auto thefts

The San Francisco Police Department today released its 2017 crime data as reported to the FBI through the Uniform Crime Reporting (UCR) program. The data indicates that while Part I crimes increased 11.8 percent in 2017,

- Homicides decreased 3.4 percent
- Homicides by firearms decreased 5 percent
- Non-fatal shooting incidents decreased 15.8 percent
- Human trafficking decreased 32.6 percent
- Assaults against SFPD police officers decreased 4 percent compared to 2016

Through enforcement efforts, the SFPD seized 1,023 firearms in 2017 and collected 275 guns during buyback events, a 29.7 percent increase over 2016.

“Reducing violent crime is and will always be our top priority,” said Police Chief William Scott. “We’re working closely with community members and our City partners to reduce gun related violence. Protecting lives and providing safety for the public- particularly our youth- is key to ensuring a vibrant future for everyone.”

UCR data shows San Francisco and neighboring Bay Area cities experienced a rise in property crimes during the first six months of 2017. San Francisco saw a 24 percent increase in thefts from vehicles last year.

To address these types of crimes, SFPD in 2017 doubled its citywide uniformed foot patrols to deter street crime and focus on neighborhood quality of life issues. Last November, the department created a General Crimes Unit to address serial residential and commercial burglaries, auto break-ins, bicycle thefts and other neighborhood property crimes. In January, 2018, SFPD command staff assigned district

station officers to work directly with community members on crime trends, education and prevention strategies.

Last year, San Francisco police officers booked or cited 790 people for thefts from vehicles. The 2017-2018 data shows a downward trend in auto burglaries, auto thefts and burglaries:

- Auto burglaries decreased 11 percent citywide between November 1, 2017 and December 31, 2017
- Auto burglaries decreased 5 percent citywide between December 1, 2017 and January 31, 2018
- Auto thefts decreased 11 percent in 2017
- Burglaries decreased .8 percent in 2017

"We take these crimes seriously and are allocating our resources toward deterrence and investigations," said Chief Scott. "By collaborating with community members, San Francisco businesses and law enforcement partner agencies, we can address crime through education, prevention and the effective investigation and prosecution of criminals."

The UCR program counts crimes when they become known to the police. A series of 13 reports are submitted to the California Department of Justice each month; CA DOJ in turn reports this data to the FBI. Crime incidents, values of stolen and recovered property values, homicide information, crimes against seniors, hate crimes and domestic violence incidents are some of the summary reports submitted each month to CA DOJ. The submittal deadline is the 10th of the month following the close of the month.

The UCR program is considered a "snapshot of crime" reported in one month. Crime is counted based upon a hierarchical rule following FBI definitions and guidelines, so that

all jurisdictions participating in the UCR program follow the same rules. Figures are only updated twice annually.

The San Francisco Police Department also produces a monthly CompStat profile, which often includes additional crimes which have been reported after the UCR submittal deadline. CompStat focuses on crimes which have occurred during the month, an important distinction from the UCR standard. These profiles provide a more up-to-date picture of crime in San Francisco, and are used to better evaluate crime fighting strategies and deployment efforts. CompStat reports are posted on our website at sanfranciscopolice.org/compstatreports.

Robbery – Officer Involved Shooting Investigation (Update – Names and Booking Charges of Suspects)

On March 6, 2018 at approximately 10:36 PM, uniformed San Francisco Police Department officers in a marked police car were flagged down at 20th and Capp Streets by two victims of an armed robbery. The victims provided the officers with a suspect vehicle description. Shortly thereafter, officers located the suspect vehicle, a black Honda Civic, on Capp Street between 21st and 22nd Streets and ordered the suspects out of the car. The driver complied and was detained.

The officers noticed that the vehicle's trunk was ajar and saw a second suspect in the trunk. While attempting to detain the second suspect, an officer involved shooting occurred. The officers ordered a third suspect from the vehicle and detained her. Officers removed the suspect from the trunk, administered medical aid and summoned an ambulance. Unfortunately, despite lifesaving efforts, the suspect was declared deceased on the scene.

Investigators determined that probable cause existed to arrest the two other suspects in the car for the robbery that occurred near 20th Street and Capp Street. Victor Navarro-Flores, age 19 and Christina Juarez, age 18, both of San Francisco, were booked into San Francisco County Jail on March 7th. They were each charged with two counts of robbery and one count of conspiracy. Due to pending identification matters, their booking photos will not be released at this time.

This is an active and ongoing investigation in the early stages. Several separate investigations are being conducted by the SFPD Homicide Detail, the San Francisco District Attorneys' Office Independent Investigation Bureau, the San Francisco Department of Police Accountability, the SFPD Internal Affairs Division and the Office of the Chief Medical Examiner.

San Francisco Police Make Arrest in Shotgun Robbery Series

On February 18, 2018, at approximately 7:19 PM, San Francisco Police officers from Park Station responded to a market on the 4100 block of 17th Street regarding a robbery. Upon arrival, the victim, a 28 year-old male told the officers that a suspect armed with a shotgun confronted him at the entry to the market. The suspect demanded money and the victim, fearing for his life, walked into the store and opened the cash register. The suspect grabbed US currency from the till and fled the scene in a gold colored sedan driven by another suspect. Officers searched for the suspects and vehicle but were unable to locate them.

On February 20, 2018 at approximately 10:27 PM, San Francisco Police Officers from Ingleside Station responded to a store on the 5500 block of Mission Street regarding a man with a gun. Upon arrival, officers learned that the suspect had fled the scene. The victim, a 41 year-old female told the officers that the suspect entered the store, pointed a handgun at her and demanded money. The clerk opened the cash register. The suspect grabbed US currency from the register and fled the scene east bound on Guttenberg Street. Officers searched the area but were unable to locate the suspect. The Night Investigations Unit assumed the investigation and the scene was processed by the Crime Scene Investigation Unit.

On February 24, 2018 at approximately 9:18 PM, SFPD officers from Ingleside Station responded to a store on the 600 block of Monterey Boulevard regarding a robbery. Upon arrival the victim, a 35 year-old male told them that he was working in the store when the suspect entered and demanded money. The victim looked up and saw the suspect pointing a shotgun at him. The victim backed away from the register and the suspect grabbed US currency before fleeing the store. Officers recognized the suspect's description as being similar to the suspect listed in a crime alert for prior robberies. The SFPD Night Investigation Unit responded and assumed the case.

Believing that the same suspect was responsible for a series of brazen armed robberies involving a shotgun, the SFPD Investigations Bureau worked diligently to identify the suspect. Through the course of that investigation, the Department's Robbery Detail identified the suspect, Michael Sweets, a 47 year-old resident of Oakley.

On February 27, 2018 at approximately 2:20 PM, SFPD Investigators located Sweets in Fairfield. Sweets was in a gold colored sedan that stopped at a store on the 700 block of 5th Street. San Francisco Police seized the opportunity to arrest Sweets when he exited the sedan. Officers took Sweets into custody without incident. He was later transported to San Francisco and booked into the County Jail on multiple counts of robbery, multiple counts of being a felon in possession of a firearm, kidnapping and a parole violation. His booking photo accompanies this news release. The gold sedan was towed and other evidence was seized as part of the investigation.

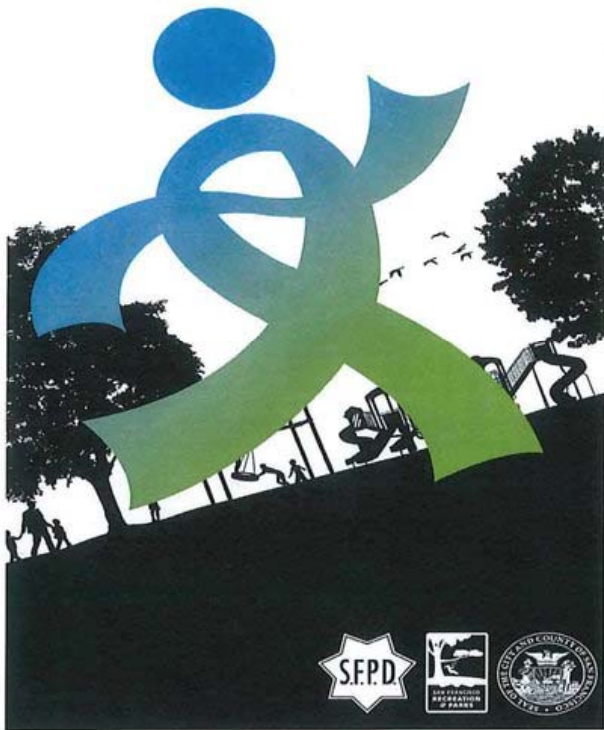

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
