2:16am Bernal Heights & Anderson Firearm

A car without license plates, parked in front of a “No Parking” sign, caught the attention of Ingleside Officers Burke and Downs who were patrolling the area. The officers ordered the man and woman out of the vehicle which had expired registration from a year ago. Inside the officers found a considerable quantity of marijuana, a ski mask, and a loaded 9mm handgun. Ingleside Officers Jensen and Chang responded to a report of a robbery at a store and arrived to find fellow Officers Dungca and Johnson detaining a woman on the sidewalk and numerous San Francisco Fire Personnel on the sidewalk in front of the store. Jensen and Chang talked to witnesses and the store owner who said the suspect entered the store with a BB gun and began firing it in all directions. The suspect then knocked over items in the store while employees scattered and called police. Fire Personnel responded after getting a call about smoke in the store which turned out to be butane canisters that were opened during the assault. A keen eyed store clerk noticed a customer trying to pay for groceries using a fake \$100 bill. The clerk returned the bill to the customer and the customer then reached into his pocket for genuine currency and paid for the items. The clerk called police and Ingleside Officers Peregrina and Dang arrived and found the suspect and a companion sitting in a doorway across from the store. Around them was drug paraphernalia. The woman companion had two outstanding warrants for drug violations. The man, who had a criminal record, was not wanted at the time. Citizens called police to report two men breaking into a parked car. Ingleside Officer Zandanel, Sgt. Ho, and Sgt. Tom were first to arrive on scene and found a new Kia Sedan parked on the street with two occupants and trash surrounding the car. The Kia had paper plates and a check of the VIN number showed it was stolen the day before. A sixteen year old young man, waiting for the bus, was robbed of his possessions. The victim told Ingleside Officers Hopkins and Vong that he was sitting at a bus stop when four unknown men approached him. One put his hands around the victim's neck while another took his handbag containing cash, wallet, house keys, cellphone, and cellphone charger. The suspects then ran away south on Santos Street. The officers obtained nearby security video of the incident that was turned over to the Ingleside Station Investigative Team. 6:46pm 700 Blk. Moscow D.U.I

A call about a hit and run accident in the Crocker Amazon Park parking lot prompted dispatch to send Ingleside Officers Quinlan and Prasadi to investigate. Dispatch broadcast a description of the car and, while on route to the scene, the officers were notified that fellow Ingleside Officers Siracusa and Sherman had stopped the suspect on the 1000 block of Geneva. The driver had watery eyes, slurred speech, and smelled of alcohol. He said he had been drinking vodka and told responding medical personnel that he “was on a five day drinking binge”. The officers conducted a roadside sobriety test which the subject failed. He was transported to the San Francisco General Hospital and consented to a blood alcohol test that was conducted at the hospital. The suspect, because of a chronic health condition, was charged with D.U.I and remained at the hospital for treatment. Report number: 180574252

8:01pm San Jose & Paulding Firearm

Ingleside Officer Chan was on routine patrol driving North on San Jose when he spotted a black Mercedes driving southbound with paper dealer advertisements in place of license plates. Officer Chan turned around and pulled the vehicle over. With the help of Officer Hardy the driver was asked to step out of the vehicle. He admitted to having a loaded .45 caliber pistol in his waistband. He also had a large quantity of marijuana and other narcotics in the car. 1:38am Alemany and Farragut Drug Possession

Officers Anderson and Parker were on patrol in the area of Alemany and Farragut when they spotted a man slumped over the wheel of a parked van. They decided to check on the individual in case he may be in need of medical assistance. The officers knocked on the driver window and were pleased to see that the man awoke to their presence. They obtained his information and found that the subject was currently on probation with a searched condition for a drug offense out of San Mateo County. The officers exercised this right and searched both the subject and the van. Inside the van, Officer Parker found paraphernalia and a good amount of Methamphetamine and a small amount of Heroin for personal use. The subject was placed under arrest and taken to Ingleside Station where he was booked for the narcotics and traffic violation. Report Number: 180568879

9:11am Prague and Geneva Stolen Vehicle

Officer Thompson was dispatched to the area of Prague and Geneva Avenue on a call of a hit and run. When he arrived he found a stolen Toyota Corolla up on the sidewalk. A witness informed Officer Thompson that the victim, whose car was hit head on, was following the two suspects who ran from the Toyota Corolla. A description of both suspects was put out for the other units searching the area. The victim soon returned and said he last saw the suspects walking up the hill behind Crocker Amazon Park. Officers Naser and Hopkins happened to locate the suspects on Brookdale Avenue. The victim was taken to the area where he identified one of the suspects as the driver and the other as the passenger. The driver was taken into custody and eventually booked for two felony counts and two traffic violations. The passenger was released at the scene to family members. Report Number: 180572375

A call of a phone snatch prompted dispatch to send Officers Parker and Anderson to investigate. Once they arrived they spoke to the female victim who said she was sitting at the Muni bus shelter waiting for the bus to arrive. While she was waiting she said she was looking down and focused on her phone. Suddenly, out of nowhere a male suspect appeared and grabbed her phone out of her hands. The suspect made his escape running southbound on Mission Street headed towards Niagara Street. With the help of a passerby, the victim was able to call the police. Taken was an Apple Iphone 6. 1:00pm Diamond/Bosworth Theft

Another phone snatch incident sent Officers Labson and Wynkoop to the unit block of Stoneyford to meet with the victim. She told the officers that she was sitting at a bench located near a Muni bus stop at the corner Diamond and Bosworth near the Glen Park BART Station. The victim was looking down at her Iphone 10 when a suspect approached from behind and reached over her shoulder and snatched the phone from her hands. Auxiliary Law Enforcement Response Team (ALERT)



Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Pathways to ALERT membership:

1. Complete NERT training and receive certification. To register for NERT training courses, please visit www.sfgov.org/sfnert. Once NERT Certified, forward a copy of your NERT ID card to the ALERT program at sfpdalert@sfgov.org. After clearing our background check, you are eligible for ALERT training.
2. If you are an SFPD Community Police Academy graduate, you are eligible for ALERT training after clearing our background check.
