Hello all,

Park Station's officers continue to do great work to ensure the safety of our community, and to increase everyone's sense of security and safety. We continue to pay special attention to the community's concerns within the Panhandle, and its surrounding areas. We hope that our efforts in the Park District are making a difference, because it's our main goal to ensure everyone in our community feels safe.

This week we saw an uptick in burglaries in the Park District, and the incidents are occurring mostly in the evening. Please ensure that you are taking basic security measures i.e. locking and securing all doors and windows. Be mindful of this security even when at home do not leave a window or door open that is easily accessible from the ground floor. Always remember to keep your garage doors closed and secured. Do not leave a hide-a key. Suspects are very in tune with where people leave spare keys. Do not leave your garage door opener in your car or at least keep it out of view. Please think about installing a security camera and motion activated lights. Of course a big deterrent of burglaries is having a dog but I know not all of us can be lucky enough to have our furry friends on guard each day and night. Finally please immediately call 911 if you think you see a crime in progress or a suspicious person in your neighborhood. A recent burglar was caught because he was caught on camera ringing the doorbell of one home after which he burglarized another home. Please take the time, and review the SF SAFE form on the next page (page 2) for helpful residential safety tips.

Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.

7 Residential Safety Tips



- 1 **Garage:** When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- 2 **Car:** Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- 3 **Spare Key:** Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- 4 **Door Buzzer:** When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- 5 **Security Cameras & Alarm Systems:** Cost effective tools for preventing crime and identifying criminals.
- 6 **Light Timers:** Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- 7 **Doors/Windows:** Always keep doors and windows locked.

Door and Window Safety

Doors:

- Should be made of solid wood or metal
- Have a single cylinder deadbolt lock and a 1-inch bolt
- Have a front door viewer or peep hole with a 180-degree range
- Clearly display unit number

Windows:

- Replace if glass is cracked and replace all damaged or missing locks
- Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

**CAPTAIN BAILEY'S TIP OF THE WEEK TO PREVENT OR SOLVE CRIME****Tip: Video surveillance equipment installation:**

If possible all residents and business owners should install video surveillance equipment outside their home or business. Video evidence is probably the biggest investigative tool we have in the police department. It provides rock solid proof/evidence of what is happening. We have used video footage to get convictions on burglars, assaults, drug dealing, trespassing. As they say a picture paints a thousand words. Many times we can identify the suspect via video footage. Video on a house can not only monitor what is happening at that house but can be used to track the path taken by a suspect and or the vehicle used by the suspect. It also allows community members to monitor who comes to your door. We recently broke a burglary ring because of video cameras installed in and outside a home. Using the video camera the victim was able to surveil the suspect, call the police and relay to us every move the suspect was making in real time, including a description of the vehicle involved. The burglar in this case was arrested for numerous burglaries in addition to the one in our district. I cannot speak enough on what a great tool these surveillance cameras are.

## ALERT Volunteer Acknowledged for Local Leadership Role

SFPD Auxiliary Law Enforcement Response Team (ALERT) volunteer, David A. Bolaffi, was chosen as the recipient of the 2017 Neighborhood Empowerment Network (N.E.N.) award for Exemplary ALERT Leadership. David received that award on January 26, 2018, in a ceremony held in the Rotunda at City Hall. The N.E.N. awards celebrate outstanding community leaders and organizations in San Francisco's neighborhoods. The winners are nominated and selected by the community.

David was born in New York City and grew up mostly in Newton, Massachusetts (a suburb 5 miles west of Boston). He is an avid Boston Red Sox, Boston Celtics, Golden State Warriors, and New England Patriots (in that order!) sports "aficionado" fan. He is a graduate of Newton South High School and Boston College. He earned his bachelor's degree from Boston College while working full time in the banking industry. After starting in the "coin room," he worked his way up to the vice-presidency of national and international banks. He received numerous awards and commendations for his excellent innovations and contributions to that industry.

One of David's rarest professional attributes is his insistence on undertaking any and all tasks with a strong sense of ownership and pride. His exemplary work never requires completion or an overhaul from others. This valuable trait continues in his volunteer efforts with the SFPD ALERT program.

David's volunteer work and service



to the public is not limited to his efforts supporting the SFPD ALERT program. For more than 20 years, David has devoted copious time and energy at his synagogue, Sherith Israel. Starting as an usher helper, David now oversees the entire usher staff, supervises security details during the high holidays, and assists in various capacities during all of the synagogue's major events. On numerous occasions, the Rabbi and Cantor have recognized and honored David for his outstanding work.

David is one of the original members of the ALERT program, having graduated from the first training class on April 13th, 2013. Since its inception, David has been and continues to be a unique and creative force in effectively guiding the development and implementation of the ALERT program. In addition to being a member of ALERT's Advisory & Recruitment Committee, David's contributions and leadership to ALERT have earned him the title and responsibility of

ALERT Senior Team Leader. He is one of only six ALERT volunteers to hold this prestigious title and its associated responsibilities. Since joining ALERT in 2013, David has given countless hours of his time to the success and growth of the ALERT program (currently with 134 members). The projects David has spearheaded to better ALERT, the SFPD, and our city are too numerous to be adequately listed. Some of his most notable contributions include:

- As an ALERT Senior Team Leader (ASTL) and member of ALERT's Advisory and Recruitment Committee, David has been highly instrumental in developing and leading many events for ALERT volunteers, including: "420 Day" in Golden Gate Park, Loma Prieta earthquake's 25th anniversary, the Fillmore Street Fairs, the Italian Heritage Day Parade, SF Delta's soccer matches, and the Parade honoring SFPD Officer Robert Fung, of Park Station. In addition, since ALERT's 2013 inception, David has assisted its program coordinator, Mark Hernandez, with fourteen of the sixteen classes for new members.
- David's strong leadership and visionary approach to ALERT's role in both

**DEFINITION OF SUSPICIOUS ACTIVITY**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



## DEFINITION OF COMMUNITY POLICING

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Park Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Park Station runs full time beat officers assigned to Haight Street.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Weekly Email Updates: Park Station sends out weekly email newsletter updates to residents in the District that alerts residents to crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



**CRIME NOTES***Definitions*

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery - (Misdemeanor battery)** is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

\***Assault** is when a person swings their arm and **battery** is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

**PARK STATION—ARREST****Warrant Arrest—1600 block of Haight St.—03/08/2018 7:39 am**

Officers observed two individuals in the area. It was discovered that one of the subjects had two outstanding warrants for possession of narcotics out of Waterloo, Illinois and Mendocino California. He was placed in handcuffs and transported to Park Station where he was booked for his outstanding warrants.

**Warrant Arrest/Local SF Warrant—1400 block of Haight St.—03/08/2018 10:56 am**

Officer observed a known subject with an outstanding bench warrant for burglary. The subject was transported to Park Station where he was booked on the listed warrant.

**Warrant Arrest—1600 block of Haight St.—03/09/2018 1:55 am**

Two officers were dispatched to the area regarding several people in an altercation together. Upon arrival, there was no one fighting or in any altercation. Officers searched the area for a male that dispatch had advised was involved in this incident. The officers located that male, and it was discovered that there was a warrant for narcotic sales from the La Verne Police Department. The subject was placed in handcuffs and booked at Park Station.

**Carrying Concealed Weapon/Resisting, Delaying, or Obstructing Peace Officer Duties/Park Code Violation—1600 block of Oak St.—03/09/2018 10:16 am**

Officers responded to the area on a call regarding a person with a knife. Upon arrival, officers spoke with the victim who stated that he was in his vehicle when he observed a subject, who was acting erratically, remove a fixed hunting blade from his bag. The subject then removed the knife from its sheath and began to swing it around, and proceeded to throw it in the victim's direction. He was placed under arrest for carrying a concealed weapon and resisting arrest. The suspect was transported and booked at Park Station.

**Warrant Arrest—500 block of Frederick St.—03/10/2018 4:14 pm**

Officers responded to the area regarding a male causing a disturbance. Upon arrival, officers made contact with the male, and a computer check revealed that he had a warrant from the Redwood City Police Department for failure to appear for a court date. The subject was transported to County Jail where he was booked for his warrant.

**Marijuana Sales/Marijuana Offense—1700 block of Haight St.—03/11/2018 4:06 pm**

Officer dressed in plainclothes walking in the area was approached by a subject who was carrying a container with a substance suspected to be marijuana. The officer and subject completed a narcotics transaction. The subject was placed under arrest narcotic sales and transported to Park Station.

**PARK STATION—ARREST CONT...****Armed while Possessing Controlled Substance/ Hallucinogenic Possession for Sale—Area of Haight St. / Cole St.—03/11/2018 4:15 pm**

Officers working in plainclothes in the above listed area recognized an individual from a previous incident, and observed him getting into a parked vehicle with an occupant already inside. Officers made contact with the occupants of the vehicle, and observed, in plain view, a plastic container of an alcoholic beverage and smelled an odor of burnt marijuana emanating from the vehicle. Officers decided to conduct a probable cause search. Officers asked both subjects to exit the vehicle and one of the subjects placed a knife on the seat of the vehicle. Officers asked him if there were any more weapons and the subject stated that he had a loaded revolver in the front compartment area, in violation of possession of a concealed and loaded firearm in public. Officers located plastic packages containing suspected Psilocybin Mushrooms and marijuana in his pockets. The subject was placed under arrest for possession of narcotics for sales and booked at Park Station. The second subject was released at the scene without further incident.

**Burglary Vehicle/Probation Violation—Area of Baker St. /McAllister St.—03/12/2018 12:11 am**

Officers responded to a call of an auto boost. Upon arrival, officers were flagged down by a witness who stated that he believed that an auto boost suspect was hiding between several homes in the area. Officers located the subject and detained him. It was discovered that the subject was on probation for burglary and had a search condition. Three methamphetamine pipes, a screwdriver, flashlight, headlamp, and a wrench were located on the subject. Officers placed the subject under arrest for burglary and probation violation. The subject was booked at Park Station.

**Civil Sidewalks Citation—800 block of Cole St.—03/14/2018 7:51 am**

An officer observed a male subject sleeping on the sidewalk in the area. The officer made contact with the subject and advised him that he was in violation of the Civil Sidewalk Ordinance. He was issued a citation for his violation.

**Civil Sidewalks Citation—Area of Haight St. /Masonic Ave.—03/14/2018 1:04 pm**

Officer observed a male subject sleeping on the sidewalk in a fetal position. The subject was issued a citation for being in violation of the Civil Sidewalk Ordinance.

**LIST OF CRIMES****Incidents:****Robbery with Gun—2500 block of Golden Gate Ave.—03/08/2018—11:27 pm**

Two officers responded to the area regarding a robbery. Upon arrival, officers spoke with the victim who stated that she was attempting to unlock the front gate to her apartment when she was approached by two suspects from behind. One of the suspects held a hand gun to her left side and asked for her bag. They proceeded to grab her backpack and cellphone. They then fled the scene in a waiting vehicle that was being driven by a third suspect.

**Battery/Theft from Person—Area of Church St. /Duboce Ave.—03/10/2018 3:21 am**

Officers were dispatched to the area regarding a fight between two male subjects. Upon arrival, officers made contact with the victim who stated that he was waiting at the MUNI stop when an unknown male walked up to him and started to dig through his grocery bag. The victim told him to stop and the subject became enraged and started to attack him. The suspect began to strike the victim with his grocery items and then fled the scene. Several officers searched the area for the suspect to no avail.

**Mental Health Detention—400 block of Stanyan St.—03/14/2018 2:44 pm**

Two officers responded to the area regarding a woman who was lying down on the curb. Upon arrival, the officers made contact with the woman who stated that she had not eaten any food in 9 days, and was having suicidal thoughts. Based on her statements, it was determined that she was a danger to herself, and was transported to SFGH.

The victim chased the suspect and tackled him to the ground but was unable to hold him down. Officers searched the area for the suspect to no avail.

**Theft from Locked Vehicle—1400 block of 7<sup>TH</sup> Ave.—03/13/2018 12:15 pm**

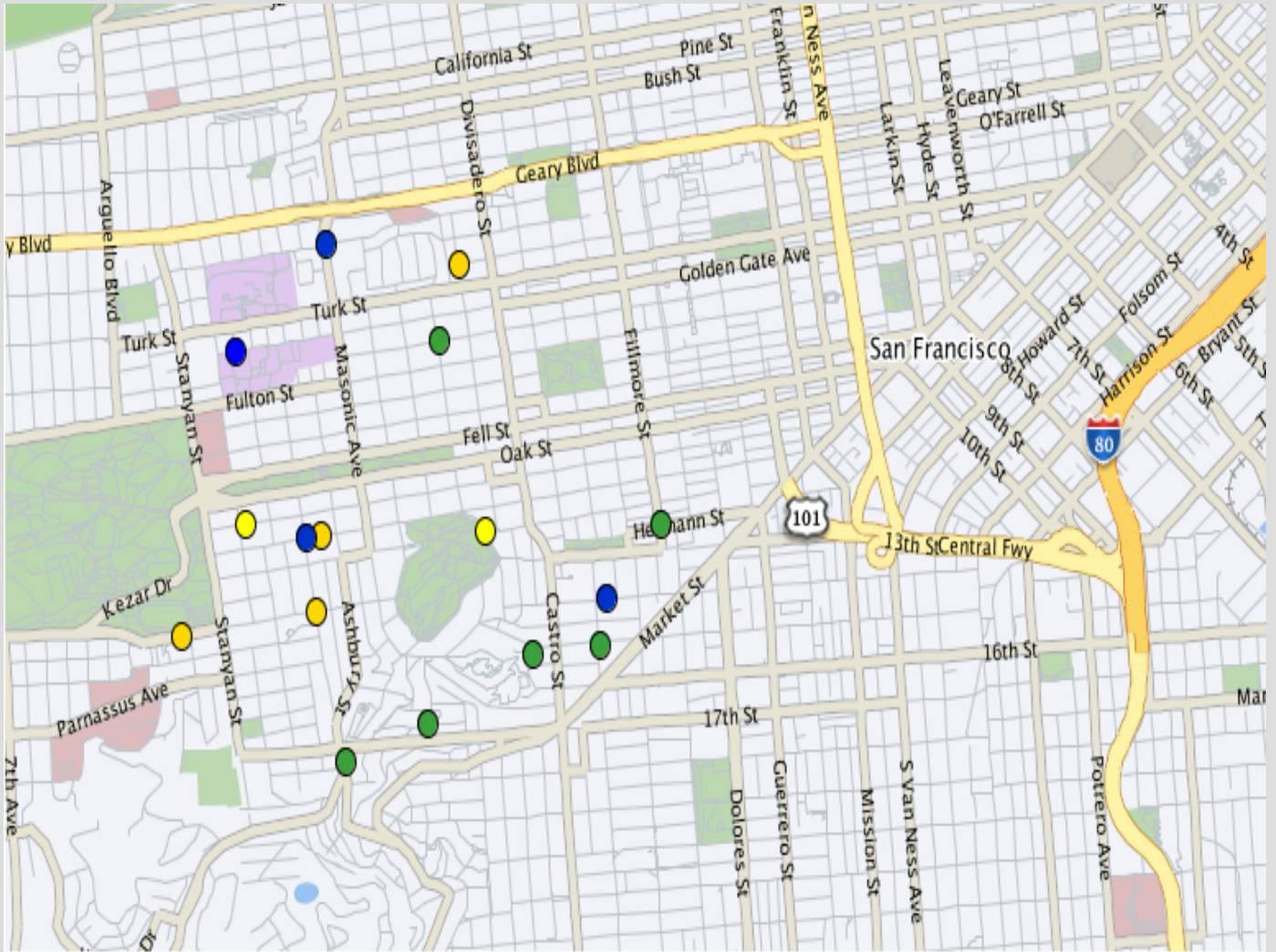
A victim walked into Park Station regarding an auto burglary. She stated that one of the rear passenger windows of her vehicle had been broken, and several items were stolen.

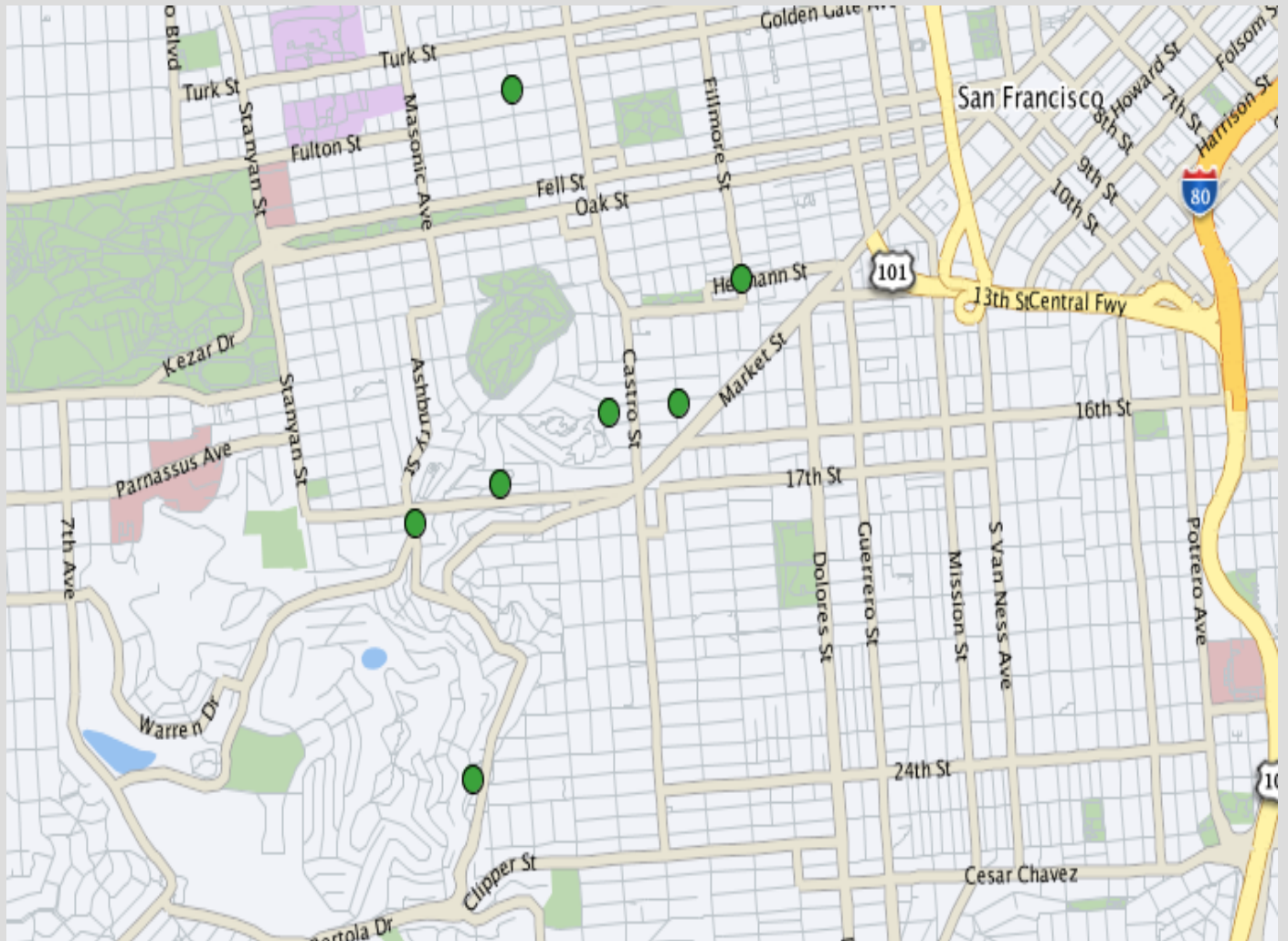

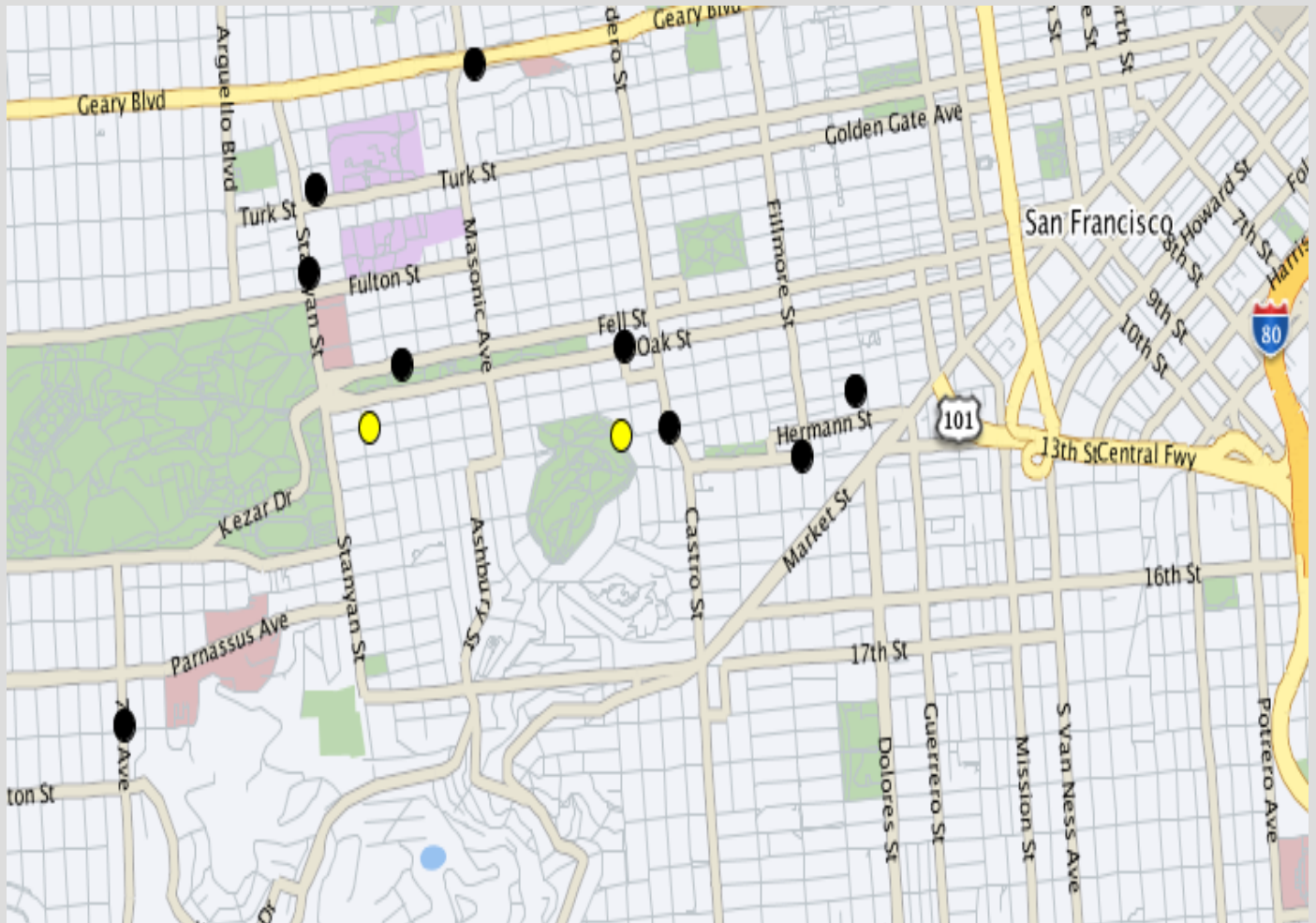

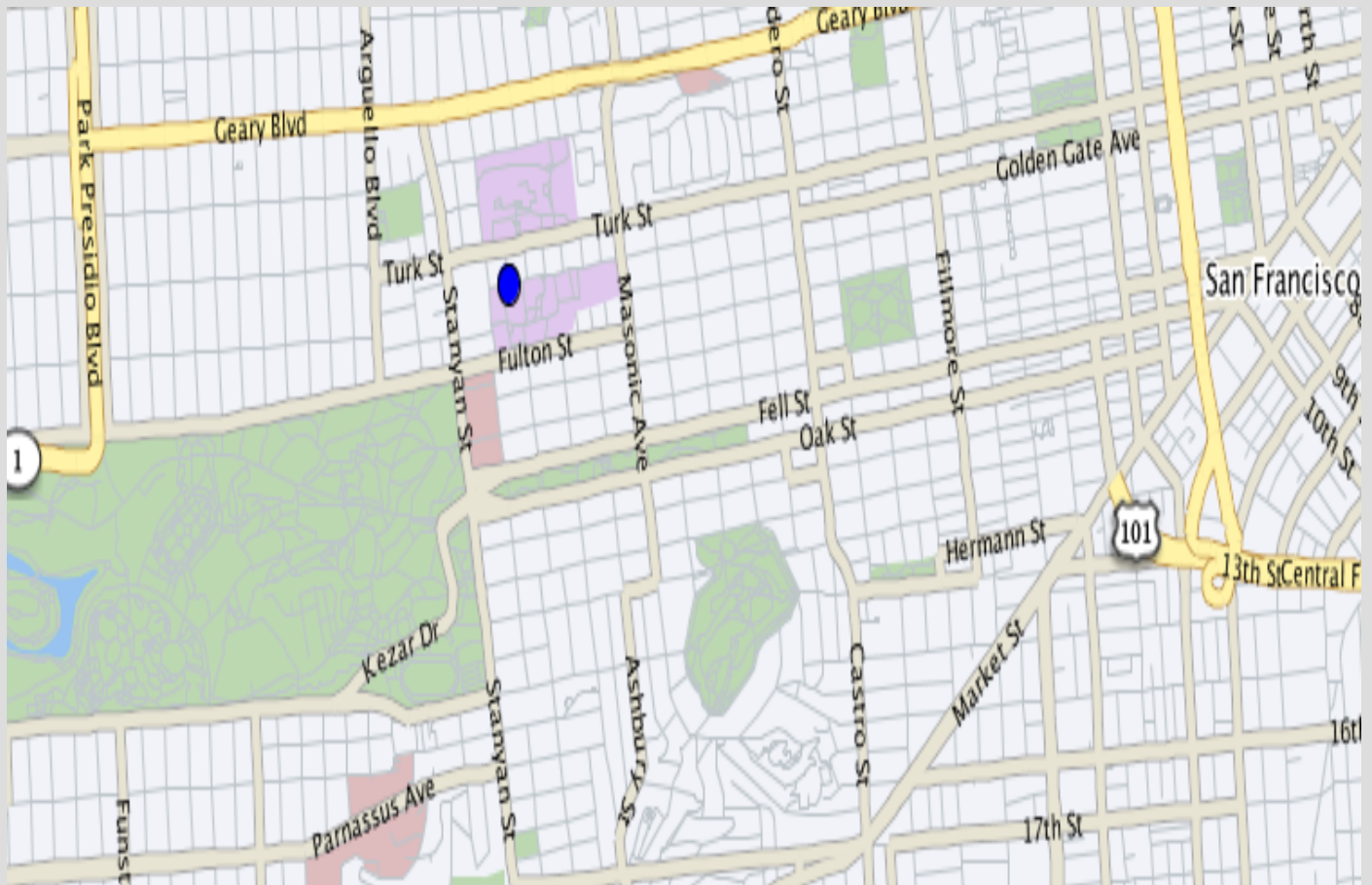

**HELPFUL TIPS****DON'T BE CAUGHT EMPTY-HANDED!!!!**

1. When placing an online or phone order, **request signed confirmation upon delivery**
2. Deliver packages to your office if at all possible; if not, deliver to a neighbor who will be home to sign for your package
3. If ordering from Amazon, use a self-service Amazon locker located throughout San Francisco; they will send you a notification email when the package is received. Go to Amazon.com and search for "Amazon Locker"
4. For U.S. Postal Service deliveries, you can authorize USPS to have certain deliveries left in a garage, with your neighbor, etc.; first you will need to create an account at USPS.com. Also check out "UPS My Choice" where you can log on to UPS.com and track your package to reroute, reschedule, or authorize a shipment release for your delivery. Get a PO box for deliveries for extra security
5. Shipping via UPS? Go online to UPS.com and search for "UPS Access Point"; neighborhood stores that will hold your packages for you
6. There are several apps available in San Francisco that allow you to ship to a package destination, and then will schedule the delivery to your home once you are available
7. Set up a delivery alert by email or text as to when your package has been delivered
8. Pay for insurance to cover the cost of the item shipped if lost, damaged or stolen
9. **Never let a package sit unattended on your doorstep**; package theft is very high in San Francisco.



## WHO AND WHEN TO CALL?

**3-1-1:** Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

**Non- Emergency San Francisco Dispatch Line:** Please call the non- emergency dispatch line **(415-553-0123)** when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, or a homeless/nuisance related issue. **The non-emergency line is for situations that require the police, but do not require an immediate police response.**

**9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency.** The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1.**

**Traffic Safety Enforcement Operations Plan for San Francisco  
with OTS Grant**

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on March 14th, 22nd and 28th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

## What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

### Pathways to ALERT membership:

1. Complete NERT training and receive certification. To register for NERT training courses, please visit [www.sfgov.org/sfnert](http://www.sfgov.org/sfnert). Once NERT Certified, forward a copy of your NERT ID card to the ALERT program at [sfpdalert@sfgov.org](mailto:sfpdalert@sfgov.org). After clearing our background check, you are eligible for ALERT training.
2. If you are an SFPD Community Police Academy graduate, you are eligible for ALERT training after clearing our background check.
