



As you all know the 420 event is happening on Friday 4/20. The event itself takes place in Golden Gate Park in the Robin Williams Meadow. There will be a number of Street closures as a result of this event. Anyone who is in and around this area on Friday 4/20/18 between the hours of 10am and 9pm can expect traffic delays. My advice is to avoid the area and pick an alternate route to get to your destination. If you are coming to the event it would be best to use public transport.

SFPD will have an increased presence in the area in an effort to ensure the safety of all, both the residents and the attendees. The 420 event itself will happen in the park and typically when most people leave the event they go to Haight Street. There will be no open containers of alcohol allowed on Haight Street and this law will be enforced. Essentially we will be doing everything we can to ensure the safety of all.

Each year we have seen tens of thousands of people attend this event and for the most part the event is peaceful. We do not anticipate anything different happening this year. We will as always be prepared for any eventuality.

If you plan on attending the event we are providing information in this newsletter about the event including road closures, muni reroutes and what you can and cannot bring into the venue.

We are also providing information regarding the 420 hotline we will be operating between the hours of 11am and 8pm to field concerns from residents, merchants and the community pertaining to the event.

Residents and business operators will be allowed vehicle access on their street if necessary during the road closures.

WB Frederick Street @ Kezar Dr. / Lincoln Way - No vehicular traffic allowed.



#### 4/20 Press Conference

On Wednesday, April 18, 2018, a press conference at Park Station was held to address the community about the upcoming 4/20 event held at Hippie Hill in Golden Gate Park. Although the 4/20 event is an unsanctioned event by the City and County of San Francisco, the unofficial event traditionally has been a big part of San Francisco's cultural history. But historically, the event has been a burden on city services, the environment, and the community.

4/20 event related incidences in the past have included, but were not limited to: Massive traffic congestions, violent crimes, property crimes, vandalism, public urination, the clean-up of over 20,000 lbs. of trash, and other quality of life issues. Such incidences have put heavy constraints on city resources and services.

Supervisor London Breed, SFPD Park District Captain Bailey, SF Recreation and Park Department Director Phil Ginsberg, and Haight Street Community leader, Alex Aquino, and other city and community stakeholders spoke at the press conference. In an effort to mitigate the above mentioned issues and costs, the city and the community have come together. A collection of hard working and dedicated community members and local agencies have been assembled. This year's 4/20 event will have a plethora of resources deployed, that include, but are not limited to the following resources:

The San Francisco Police Department, the Juvenile Probation Department, the San Francisco District Attorney's Office, the San Francisco Park and Recreations Department, the Department of Public Health, the Auxiliary Law Enforcement Reserve Team, the San Francisco Animal Care & Control Department, the SFMTA, the San Francisco Unified School District, Adult Probation and Parole Department, the San Francisco Fire Department, the San Francisco Sheriff's Department, the San Francisco Department of Public Health, the San Francisco Department of Public Works, Recology, the Haight and Ashbury community, local hospitals, event sponsors, and more.

As the 4/20 event grows each year and the crowds becoming bigger, the main focus for the 4/20 event are as follows: Ensuring the safety of everyone, minimizing the impact on the community, and protecting the park and environment.



# 4/20 Press Conference

#### Participants at the 4/20 event must adhere to the following rules:

- \* No sale of any illegal drugs
- \* No alcohol
- \* No minors allowed
- \*There will be ZERO TOLERANCE for violence, quality of life violations, and other unlawful activities.

#### Items NOT allowed in the event area:

- \* Tents, canopies, tables, or other structures
- \* Unpermitted vendors (permits must be obtained through event organizers)
- \* Coolers larger than 9"x12"
- \* Barbecues or cooking equipment
- \* Amplified sound equipment
- \* Generators
- \* Glass

Members of the community should rest assure that the San Francisco Police Department, city leaders, city agencies, and community members are working diligently to make this a safe and responsible event.

# **BIKE, WALK, AND ROLL TO SCHOOL DAY**

On Wednesday, April 18, 2018, Officer Wu, Officer Zuckerman, Officer Deignan, and the Captain's Clerk, Miss April, had the opportunity to participate in the Chinese Immersion School's Bike, Roll, and Walk to School Event. In attendance were approximately 30 students, parents, families, teachers, and community members.

The Bike and Walk to School Event is a national movement that first started in 1997. Since then, it's come a long way, even gathering international participation. Events such as these aim to bring together communities to promote: Healthier habits such as regular physical activity, cleaner environments by reducing automobile pollution, and a focus on safety.



#### **DEFINITION OF SUSPICIOUS ACTIVITY**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:


- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



#### **DEFINITION OF COMMUNITY POLICING**

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- <u>Homeless Outreach and Outreach to Drug Users</u>: Park Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Park Station runs full time beat officers assigned to Haight Street.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Weekly Email Updates</u>: Park Station sends out weekly email newsletter updates to residents in the District that alerts residents to crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



# **CRIME NOTES**

# **Definitions**

Robbery – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

\*Assault is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

#### PARK STATION—ARREST

#### **Arrests:**

#### Driving, No License Issued/Traffic Violation—Fell St. /Masonic Ave.—04/11/2018 2:00 pm

At the above location, officers effected a traffic stop on a vehicle that had a tinted plastic cover on the rear license plate. Officers made contact with the driver and it was discovered that he did not have a valid driver's license. The subject was issued a citation for the tinted plastic cover on the rear plate, and not having a valid license.

#### Warrant Arrest/Civil Sidewalks Warning- of Noe St. /Beaver St.—04/12/2018 1:16 pm

Officers responded to the above address regarding the homeless encampment in the area. Upon arrival, officers observed a male subject sitting on the sidewalk in violation of the Civil Sidewalk Ordinance. Officers made contact with the subject and it was discovered that he had an outstanding felony warrant out of San Francisco for Failure to Appear. Officers arrested the subject, and while conducting a search on him, officers located a burned glass pipe in a zipper pouch. The subject was transported to County Jail.

#### Civil Sidewalks Citation—Unit block of Belcher St.—04/13/2018 9:19 am

Officers were dispatched to a call regarding subjects sleeping on the sidewalk in the above listed area. Upon arrival, officers made contact with two subjects, and cited them for being in violation of the Civil Sidewalk Ordinance.

#### Warrant Arrest—Upper Ter. /Clifford Ter.—04/13/2018 10:14 pm

Officers observed an individual pushing a chair with a black bag in the middle of the street. Officers made contact with the subject and ordered him to get on the sidewalk. The subject appeared to be nervous and proceeded to back away from the officers. It was discovered that the subject had a misdemeanor warrant for his arrest out of Marin County for Possession of Methamphetamine. Officers booked the subject for the misdemeanor warrant.

#### Stay Away or Court Order/Non-DV Related—1700 block of Fulton St.—04/14/2018 2:31 pm

Officers met with the manager of a restaurant at the above location, who stated that a subject who had a stay away order from being within 100 yards of the restaurant was sitting inside. The manager provided a stapled packet of court papers regarding the active temporary restrain order against the subject. Officers placed the subject under arrest, and later transported her to County Jail to be booked for the stay away order violation.

#### Warrant Arrest/Local SF Warrant—1500 block of Haight St.—04/14/2018 4:05 pm

Officer observed a known subject standing at the above location. The subject was placed under arrest for two warrants of possession of a controlled substance for sale and two charges for violation of a court ordered stay away. Officers transported the subject to Park Station. Officers located suspected LSD, methamphetamine, marijuana, psilocybin mushrooms in the subjects backpack. Officers added the charge of probation violation to the subject's arrest.

#### Municipal Code Violation/Warrant Arrest—Area of Oak St. /Central Ave.—04/15/2018 4:16 am

Officer observed one person lying on a queen sized mattress and another person lying on the grass with blankets. The officer made contact with both subjects and informed them that they were in violation of sleeping in the park. A computer query revealed that one of the subjects had warrant violations for vandalism and trespassing. The other subject had a warrant for battery. Additional officers arrived on scene and both subjects were transported to Park Station.

#### PARK STATION-ARREST

#### **Arrests:**

#### Civil Sidewalks Warning—Area of Belcher St.—04/16/2018 7:00 am

Officers responded to the area regarding a report of a suspicious male who was possibly doing drugs. The reportee requested a welfare check on the subject. Upon arrival, officers observed the male sitting on the sidewalk in the above area in violation of the Civil Sidewalk Ordinance. The subject appeared to be coherent and officers warned him of his violation. The subject refused homeless outreach services and left the area without further incident.

#### Theft from Person/Warrant Arrest/Local SF Warrant—200 block of Fillmore St.—04/14/2018 7:34 pm

Officers in the area were flagged by citizens, who pointed out a fleeing suspect that just stolen a purse. Officers detained the suspect, and spoke with a witness, who stated that she saw the suspect enter the café, look around, then sit behind the victim. The witness observed the suspect grab the victim's purse, and run off. Multiple witnesses assisted identifying the suspect. With all the positive identifications of the suspect, he was placed under arrest for theft. It was discovered that the suspect had a warrant for his arrest out of San Francisco for vandalism. The suspect was booked at Park Station.

#### Civil Sidewalks Citation—1400 block of Haight St.—04/16/2018 10:27 am

Officers observed a subject sleeping on the sidewalk in the area. The subject was cited for violating the sit/lie ordinance.



#### CAPTAIN BAILEY'S TIP OF THE WEEK TO PREVENT OR SOLVE CRIME

I want to take this time to remind everyone to record the serial numbers of all your valuables i.e. bikes, tools etc. You can do this by simply taking a photo of the item and then zoom in to take a photo of the serial number. Most people have smart phones and you can easily use your phone camera to achieve this. This is really great information for you to have in the event you are a victim of a theft. We can post the photos on flyers and record the serial numbers of your possessions so that in the event we make an arrest of an individual with stolen items your items will be easily recognizable. Officers can also identify them easily if they are being sold at any location. Bottom line having this information increases your chances of being reunited with your stolen items. It also increases the chances of these thieves being held accountable for their crimes.

Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.

7 Residential Safety Tips



- Garage: When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- Car: Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- Spare Key: Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- Open Buzzer: When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- Security Cameras & Alarm Systems: Cost effective tools for preventing crime and identifying criminals.
- Light Timers: Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- Doors/Windows: Always keep doors and windows locked.

# **Door and Window Safety**

#### Doors:

- . Should be made of solid wood or metal
- Have a single cylinder deadbolt lock and a 1-inch bolt
- Have a front door viewer or peep hole with a 180-degree range
- Clearly display unit number

#### Windows:

- Replace if glass is cracked and replace all damaged or missing locks
- Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

Safety tip for your home:

Help first responders by making sure your address numbers are mounted on a high-contrast background, and that they're illuminated when it's dark.

#### **HELPFUL TIPS**

#### DON'T BE CAUGHT EMPTY-HANDED!!!!

- 1. When placing an online or phone order, request signed confirmation upon delivery
- 2. Deliver packages to your office if at all possible; if not, deliver to a neighbor who will be home to sign for your package
- 3. If ordering from Amazon, use a self-service Amazon locker located throughout San Francisco; they will send you a notification email when the package is received. Go to Amazon.com and search for "Amazon Locker"
- 4. For U.S. Postal Service deliveries, you can authorize USPS to have certain deliveries left in a garage, with your neighbor, etc.; first you will need to create an account at USPS.com. Also check out "UPS My Choice" where you can log on to UPS.com and track your package to reroute, reschedule, or authorize a shipment release for your delivery. Get a PO box for deliveries for extra security
- 5. Shipping via UPS? Go online to UPS.com and search for "UPS Access Point"; neighborhood stores that will hold your packages for you
- 6. There are several apps available in San Francisco that allow you to ship to a package destination, and then will schedule the delivery to your home once you are available
- 7. Set up a delivery alert by email or text as to when your package has been delivered
- 8. Pay for insurance to cover the cost of the item shipped if lost, damaged or stolen
- 9. Never let a package sit unattended on your doorstep; package theft is very high in San Francisco.



#### WHO AND WHEN TO CALL?


**3-1-1:** Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

Non- Emergency San Francisco Dispatch Line: Pease call the non- emergency dispatch line (415-553-0123) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, or a homeless/nuisance related issue. The non-emergency line is for situations that require the police, but do not require an immediate police response.


9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency. The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1**.

#### SFPD Announces Arrests in Home Burglary Series Suspects Allegedly Stole Nearly \$3 Million in Currency, Credit Cards and Jewelry

In November of 2017, the San Francisco Police Department's newly established Burglary Unit identified a pattern of residential burglaries occurring frequently in the Bayview, Ingleside and Taraval districts. Over the course of the investigation, members of the Burglary Unit determined that as many as sixty of the residential burglaries were being committed by serial burglary crews.

During the commission of the burglaries, the crews used multiple vehicles with paper license plates and attempted to disguise their identities. The suspects gained entry to the burglarized homes by forcing their way through locked gates and breaking front and rear doors of the residences. The burglaries occurred in occupied and unoccupied homes.

Burglary Unit investigators determined that eleven firearms, hundreds of pieces of jewelry, US and foreign currency, credit cards, passports, vehicle titles and vehicle keys were stolen, valued at nearly \$3,000,000.00.

Assisted by numerous local, regional, out-of-state, and federal agencies, SFPD was able to identify nearly thirty individuals responsible for or accomplices in the burglaries. As a result, the department authored and served several search and arrest warrants over the last ninety days in San Francisco, Oakland, Antioch, Brentwood and Las Vegas.

During the serving of these warrants, nine of eleven known stolen firearms were recovered. In the search warrant served in Brentwood last week, four more firearms were recovered, including two that were stolen in separate burglaries in Fremont, CA and Reno, NV.

Investigators also recovered multiple pieces of stolen property including jewelry, passports, US and foreign currency and eight vehicles used in the burglaries.

Of the thirty individuals identified in the investigation, ten have been apprehended along with two additional individuals arrested during the search warrant served in Brentwood. SFPD continues to investigate the remaining individuals for their involvement in the burglaries.

"With these arrests, there has been a marked decrease in burglaries in the Bayview, Ingleside and Taraval districts," said San Francisco Police Chief William Scott. "Our establishment of a General Crimes Unit to focus on serial residential and commercial burglaries, auto break-ins, bicycle thefts and other neighborhood property crimes is bearing results. We will continue to pursue crime prevention and investigation strategies that will increase safety for all and help bring justice for victims of serial criminals."

The ten individuals arrested to date in this burglary series are:

- 23 year-old Demarria Conley of Antioch, charged with conspiracy, burglary, possession of stolen property, and resisting arrest
- 64 year-old Steve Levy of Oakland, charged with firearms violations
- 44 year-old Jabari Jackson of San Francisco, charged with multiple counts of possession of stolen property and vehicle theft
- 25 year-old Kelvon Watts of San Francisco, charged with assault with great bodily injury and elder abuse
- 33 year-old Marshay Goodspeed of Antioch, charged with burglary and reckless evasion
