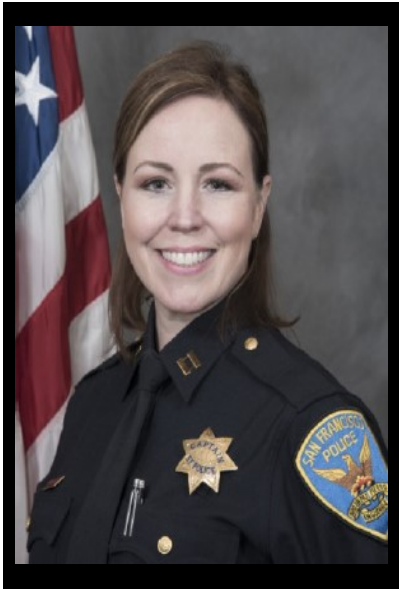

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ♦ **An individual peering into vehicles, to try, and locate any valuables left unattended.**
- ♦ **An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.**
- ♦ **An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.**

DEFINITION OF COMMUNITY POLICING

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

Homeless Outreach: Richmond Station Officers coordinate with city agencies to provide assistance and offer City services as needed. The Officers handle quality of life issues and find programs for willing individuals.

Foot Patrol: Richmond Station has dedicated foot patrols on Clement St., Geary Blvd, Golden Gate Park as well as the Cliff House.

Richmond Station Community Meetings: Community Meetings are held once a month for the public and residents of the Richmond District to attend. People can voice their comments or concerns about issues in the Richmond District.



Definitions

Robbery– Robbery is the taking of property from another by using force or by using fear.

Assault– An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery- (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

****Assault is when a person swings their arm and battery is when that arm makes contact with another person. ****

Aggravated Assault– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

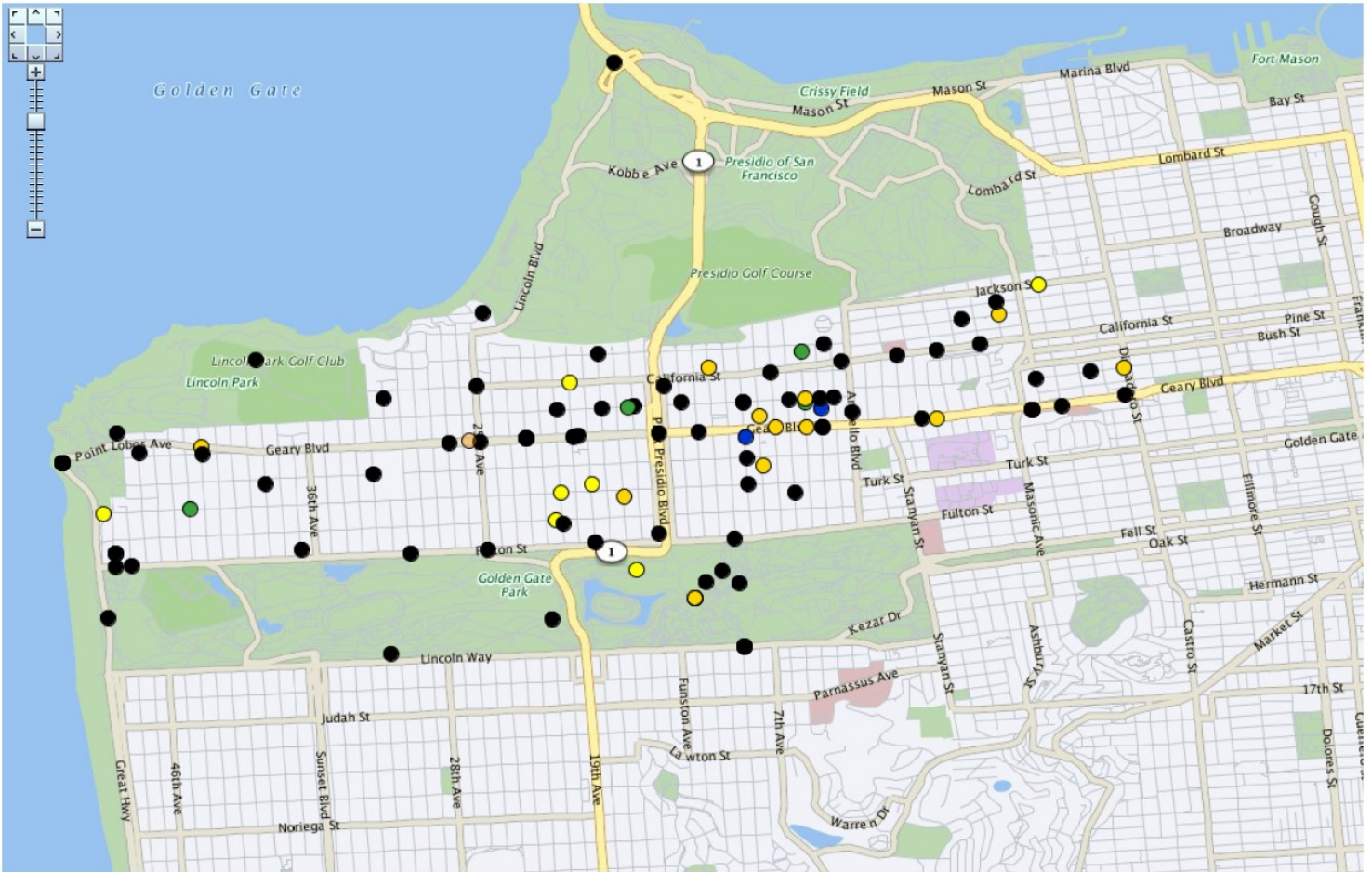
Burglary– The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft– Grand Theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Recovered, Stolen Vehicle
(Arrest)
01/24/2018 0131 hrs.
100 Block of 34th Ave.**

Officers on routine patrol were in the area of the Legion of Honor, when they observed two individuals at the rear of a running vehicle, placing bags in the trunk.

Per SF parking code, PK 6.01, it is illegal to park a vehicle in the parking lot between 2200-0600 hours.

The Officers conducted a computer check of the vehicle, which revealed it was a stolen vehicle out of this city. The two suspects entered the vehicle,

with the male suspect entering the driver's seat. Officers quickly took both suspects into custody without incident. The female was released at the scene and the male suspect was booked for possession of a stolen vehicle.

**Burglary, Vehicle (Arrest)
01/24/2018 1620 hrs.
Sunnydale Ave.
(Clement & 3rd Ave.)**

On 01/22/2018 Richmond Station Officers were dispatched to an auto burglary at Clement St. & 3rd Ave. Many witnesses on scene described the suspect vehicle used in the auto burglary as a white Crown Victoria with the license plate in the window.

The Officers obtained video of the vehicle used in the burglary, and the suspect who broke into the victim vehicle. Richmond Station put out an inter depart-

ment crime alert bulletin, with information on the suspect vehicle and the suspect in the auto burglary.

On 01/24/2018 Tenderloin units attempted to stop the white Crown Victoria and it fled at a high rate of speed.

At 1620 hours, the same day, Ingleside Officers observed the above listed vehicle stopped on Sunnydale Ave. Officers conducted a traffic stop on the vehicle and detained all three occupants without incident.

One male suspect was positively identified as the male suspect

who broke into the vehicle on Clement St. The two other males were identified and released at the scene.

The male suspect was booked for 459 PC in the second degree.

The male suspect was booked into County Jail for the outstanding warrants.



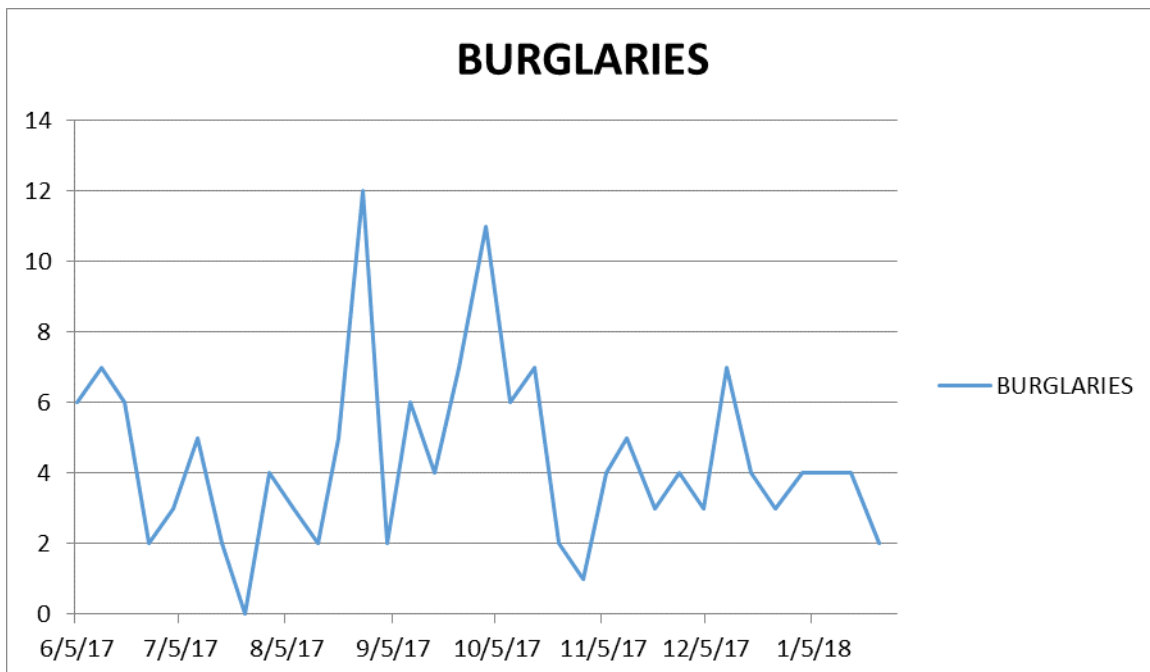
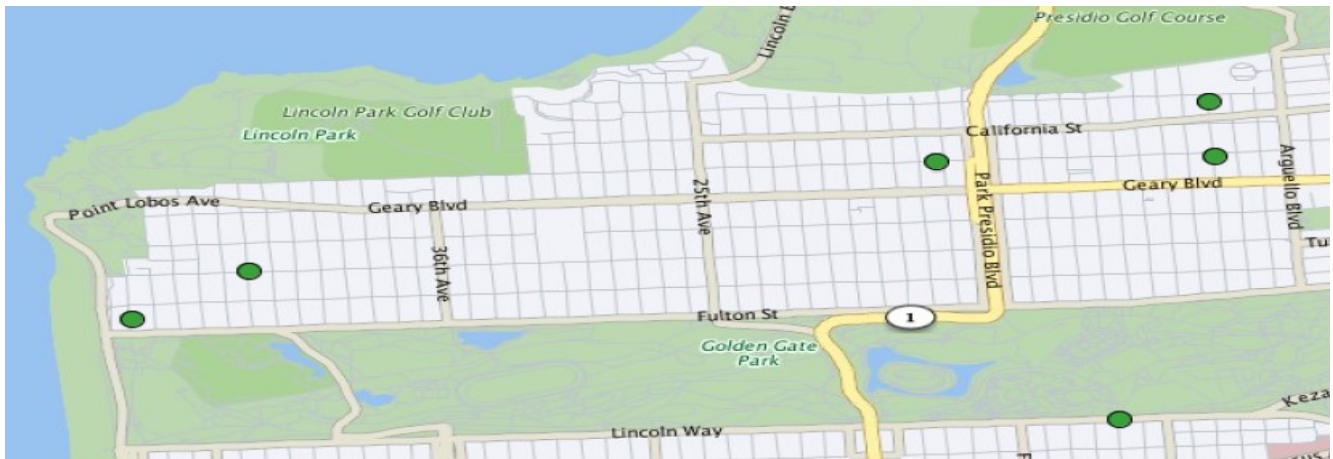

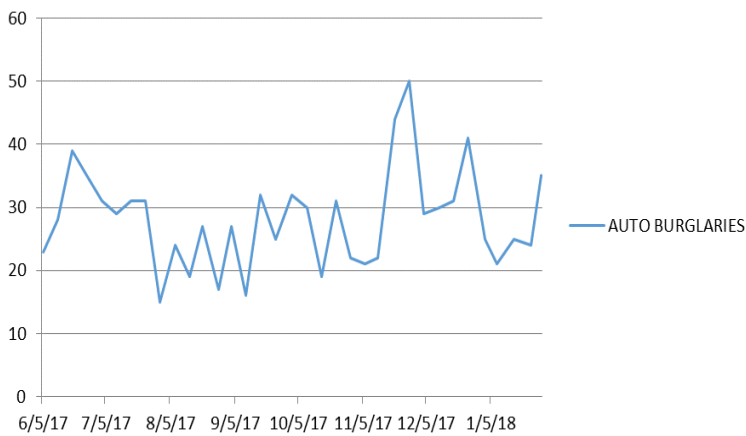

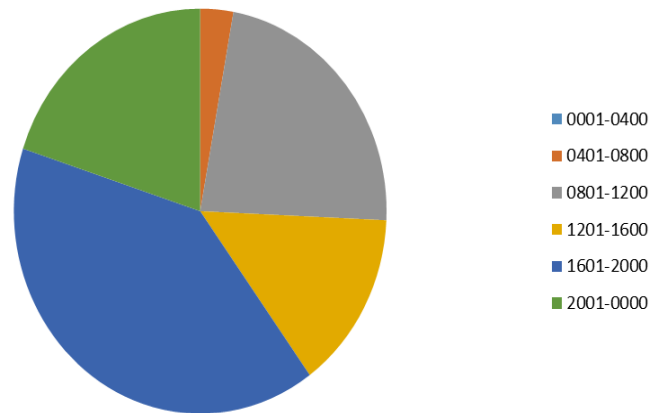

The above pie chart represents the time of day auto boosts occur.



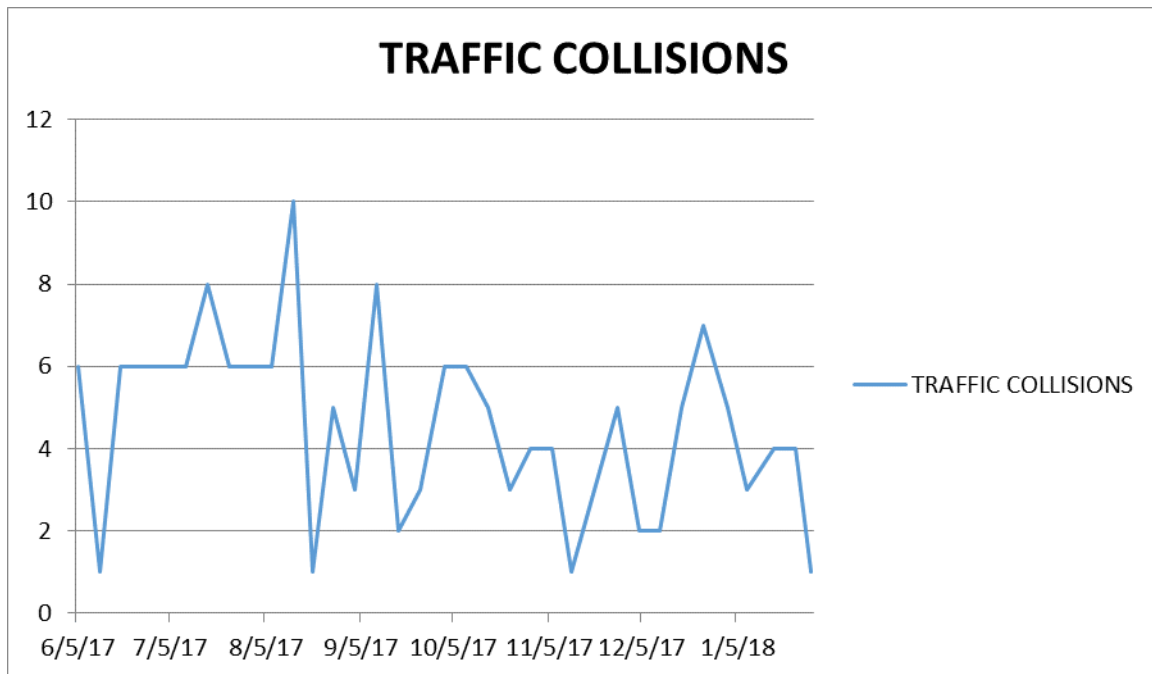

Auxiliary Law Enforcement Response Team (ALERT)



Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.

San Francisco Police Make Arrest in Richmond Auto Burglary

On January 22, 2018 at 1:34 PM, San Francisco Police officers responded to the 200 block of Clement Street regarding an auto burglary. Officers were able to obtain a description of the suspect and getaway vehicle involved. Investigators from the Richmond Station Investigation Team (SIT) subsequently issued a department wide Crime Alert.

On January 24, 2018 at approximately 3:00 PM, the suspect vehicle was spotted by Tenderloin Station officers. The vehicle fled before officers could make contact with any of the occupants. At approximately 4:20 PM, members of the Ingleside Station Plainclothes Team spotted the suspect vehicle. The plainclothes officers, with the assistance of uniformed patrol officers were able to effect a traffic stop and conduct an investigation.

26 year-old San Francisco resident Tyrell Baldwin was placed under arrest for the January 22nd auto burglary. Baldwin was booked into the San Francisco County Jail for felony second degree burglary. It was later determined Baldwin was involved in another auto burglary that occurred on January 19th, 2018 in the Central District and will be charged accordingly. A booking photo of Baldwin accompanies this news release.

34 year-old San Francisco resident Fredrick Reed was cited for driving with a suspended license and released at the scene.

A third adult male occupant was detained and released at the scene without incident.

Although an arrest has been made, investigators are asking anyone with information on this case to contact the San Francisco Police anonymously at 415-575-4444 or text-a-tip to TIP411 with SFPD at the start of the message.

Types of Crime Reports That Can Be Filed Online:

- **Harassing Phone Calls:** When you are experiencing annoying calls - with no known suspects; for example, hang-ups or heavy breathing.
- **Lost Property:** When property has disappeared and not stolen. If you think it could have been taken but you have no idea by who, you may enter the report online.
- **Theft:** When property is stolen but there has been no illegal entry or contact by the thief.
- **Vandalism/Graffiti:** The act of changing, modifying or defacing public or private property, including graffiti.
- **Vehicle Burglary:** When property was stolen from a vehicle.
- **Vehicle Tampering:** Tampering with a motor vehicle, including vandalism/graffiti of the vehicle.

Calling the Police:

Dispatchers ask questions in a particular order for a reason. It is best to stay calm and answer all questions to the best of your ability.

Complaint: **Location, Hazards (ie. weapons at scene), Victim info (sex, age, condition)**

Suspect Description: **Gender, Race, Age, Clothing, distinguishing features**

Vehicle Description: **Color, Make, Model, License Plate, distinguishing features**
