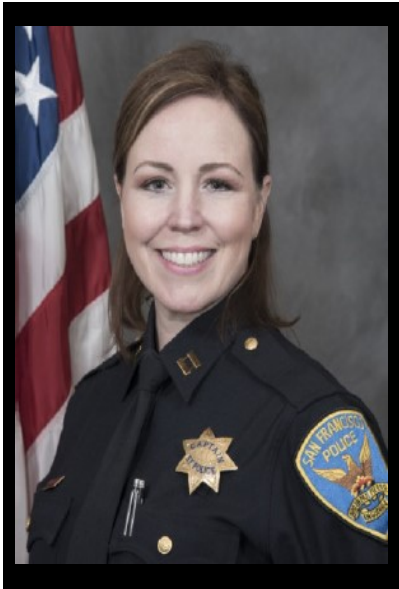

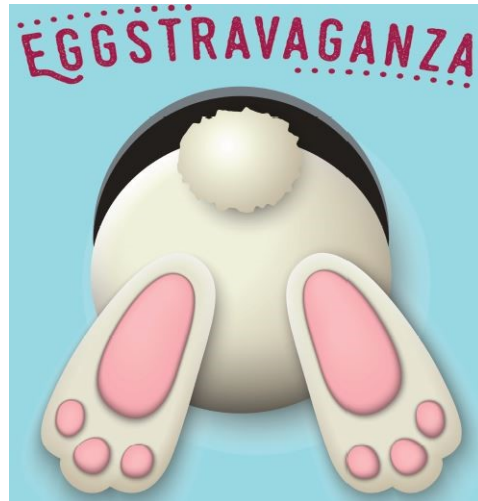

## DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

### Examples of Suspicious Activity:

- ♦ An individual peering into vehicles, to try and locate any valuables left unattended.
- ♦ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.
- ♦ An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

## DEFINITION OF COMMUNITY POLICING

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

**Homeless Outreach:** Richmond Station Officers coordinate with city agencies to provide assistance and offer City services as needed. The Officers handle quality of life issues and find programs for willing individuals.

**Foot Patrol:** Richmond Station has dedicated foot patrols on Clement St., Geary Blvd, Golden Gate Park as well as the Cliff House.

**Richmond Station Community Meetings:** Community Meetings are held once a month for the public and residents of the Richmond District to attend. People can voice their comments or concerns about issues in the Richmond District.



# Definitions

**Robbery**– Robbery is the taking of property from another by using force or by using fear.

**Assault**– An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery- (Misdemeanor battery)** is any willful and unlawful touching of another.

**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

**\*\*Assault is when a person swings their arm and battery is when that arm makes contact with another person. \*\***

**Aggravated Assault**– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

**Burglary**– The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft**– Grand Theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

The Victim just completed a pizza delivery and left his vehicle parked running with the key in the ignition in front of the store. The Victim saw the Suspect standing in front of the store and pro-

ceeded to go inside leaving the vehicle unattended. Witnesses stated the Suspect then got in the Victim's vehicle and drove away. The Victim was able to track the location of his vehicle. Responding officers located the vehicle, which was involved in a collision with a traffic wall. The Suspect was inside the vehicle in the drivers seat and appeared disoriented. Officers determined the Suspect to be under the influence of drugs and alcohol. A glass pipe with a brown substance was found in the Suspects possession. A records check revealed the Sus-

pect also had an outstanding warrant for his arrest and his license was suspended. The Suspect was arrested and booked at County Jail One on the following charges: Possession of a Stolen Vehicle, Driving under the Influence of Drugs and Alcohol, Driving with a Suspended License, Possession of Drug Paraphernalia, Warrant Arrest.

Officers responded to a call of a person with a knife and a bat, hitting a garbage can. The caller wanted to remain anonymous and stated it did not appear the suspect was threatening anyone. Officers searched the area and located a Suspect matching the description a few blocks away. The Suspect still had a knife and bat in his hands. Offic-

ers saw the Suspect crouch behind a vehicle, then stand up and walk away. Officers were able to gain control of the Suspect who was in possession of several knives and a bat. A records check revealed the Suspect had two outstanding felony no bail warrants out of Santa Clara for his arrest for a similar offense.

The Suspect was arrested and booked at County Jail One on the following charges: Two Felony Warrants.



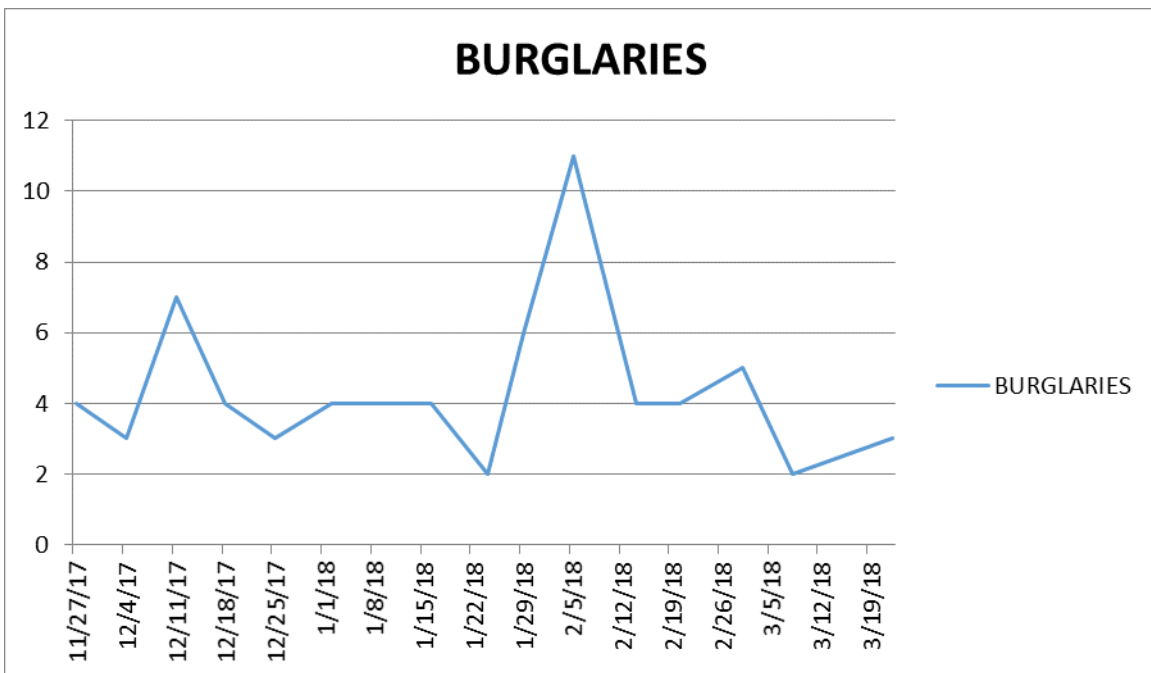

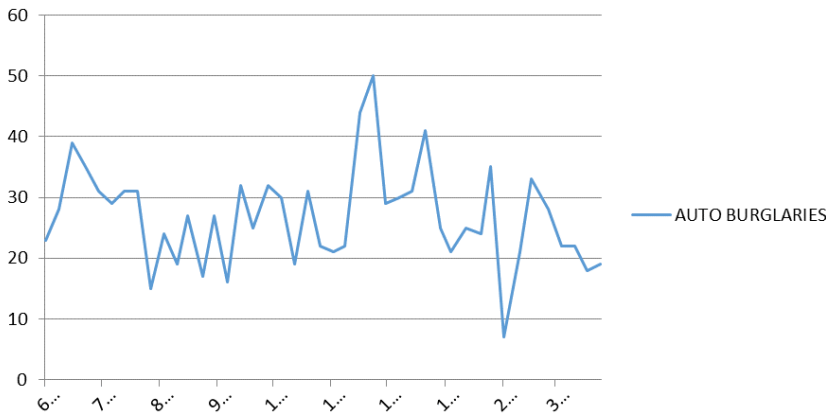

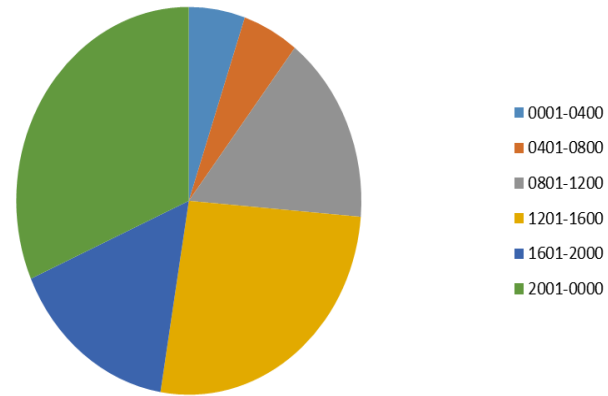

The above pie chart represents the time of day auto boosts occur.



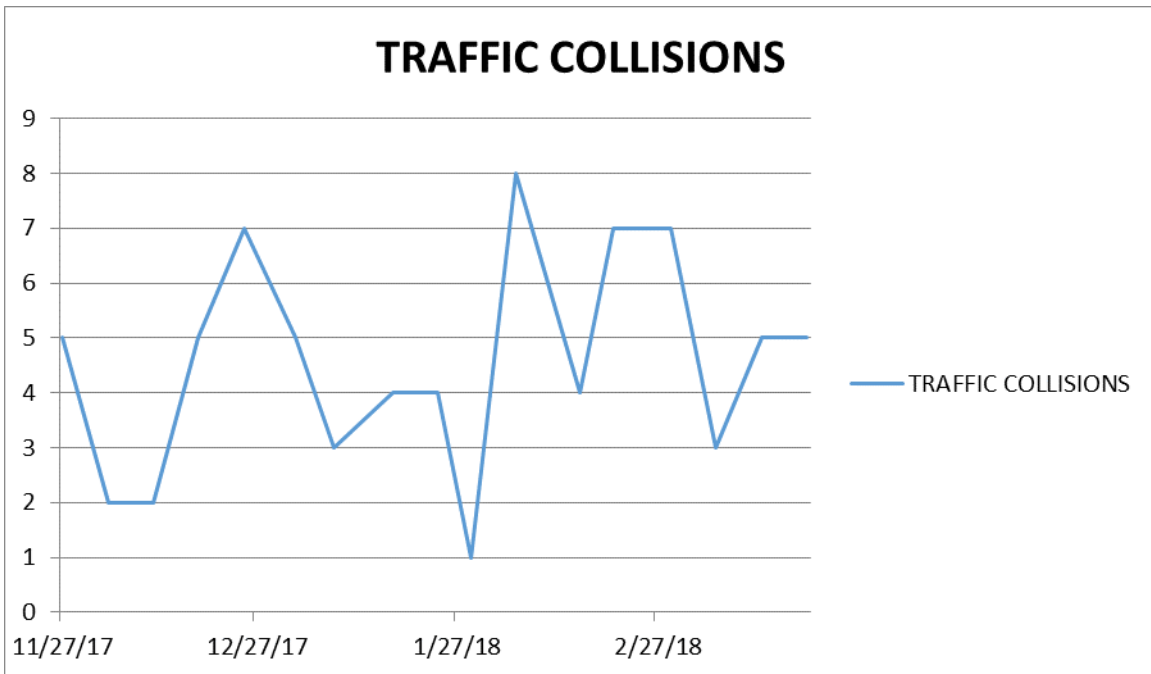

## Auxiliary Law Enforcement Response Team (ALERT)



Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



## What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

### Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.

### **San Francisco Police Arrest Suspect Wanted for Threatening and Attacking Muni Drivers**

On Wednesday March 7, 2018 at approximately 7:08 PM, San Francisco Police officers from the Richmond District were dispatched to the corner of Sacramento Street and Cherry Street regarding a Muni driver being threatened by a passenger.

The Muni driver had arrived at the end of the line when she observed a male passenger who remained on the bus. After determining the passenger didn't need medical assistance, the driver informed him the bus had reached the end of the route and all passengers are required to exit. The passenger made threats to harm the driver before ultimately exiting the bus and fleeing on foot.

Responding officers located and detained a subject matching the suspect description on the 3700 block of California Street. While conducting their investigation, officers were approached by a male victim who stated he was threatened and attacked by the detainee. The victim told police he was inside a medical facility on California Street when the suspect threatened to harm him, pushed the victim and fled the facility.

Based on evidence and witness statements obtained from the scene, the suspect, later identified as Eugene Stevens, a 51 year-old San Francisco resident, was arrested and booked into the San Francisco County Jail on criminal felony counts of threats and misdemeanor battery. Due to pending identification matters, Stevens' booking photo will not be released at this time.

During the course of the investigation, officers also determined Stevens was the same suspect wanted for attacking a Muni driver on March 3, 2018 in the Richmond district. Stevens was also booked for felony battery on a transit employee and felony criminal threats.

### **Local Merchants Aid SFPD In Stolen Property Arrest**

On Monday March 12, 2018 at approximately 11:30 AM, SFPD officers responded to the area of 18th and Harrison Streets regarding a report of individuals attempting to break into a toolbox attached to a vehicle. A 911 caller said that the vehicle was parked behind a bus that was converted into a mobile home. Officers arrived on scene and detained three suspects.

Further investigation revealed the vehicle was a small golf cart-like vehicle that appeared to belong to a private business in the area of Fisherman's Wharf. Officers contacted the business and learned the vehicle was stolen hours before the 911 call in the Mission District.

Officers spoke with a local merchant in the area of 18th and Harrison Streets and learned that the bus had been parked in the area for a number of weeks and merchants suspected the individuals were operating a bicycle "chop shop". Officers observed numerous bicycles on the sidewalk just outside the bus. One of suspects indicated he was the owner of one of the bicycles. The rest of the bicycles were unclaimed.

Central station officers obtained security footage from the Fisherman's Wharf business and observed consistencies in the clothing description of the suspect that stole the vehicle and the suspect detained in the Mission District. Employees of the Fisherman's Wharf business responded to the scene and confirmed items taken from the vehicle were the business's property.

The vehicle and stolen property were returned back to the business's employees. Officers seized the bicycles for safekeeping, towed the bus pending further investigation and arrested the three suspects. Twenty three year-old San Francisco resident Francisco Platero was booked for grand theft, possession of stolen property and conspiracy. Thirty-nine year-old transient Oscar Centeno and a 28 year-old San Bruno resident Chester Rebolledo were both booked for possession of stolen property and conspiracy. Booking photos of all three suspects accompany this news release as well as surveillance footage and photos of the bus and golf cart.

## Types of Crime Reports That Can Be Filed Online:

- **Harassing Phone Calls:** When you are experiencing annoying calls - with no known suspects; for example, hang-ups or heavy breathing.
- **Lost Property:** When property has disappeared and not stolen. If you think it could have been taken but you have no idea by who, you may enter the report online.
- **Theft:** When property is stolen but there has been no illegal entry or contact by the thief.
- **Vandalism/Graffiti:** The act of changing, modifying or defacing public or private property, including graffiti.
- **Vehicle Burglary:** When property was stolen from a vehicle.
- **Vehicle Tampering:** Tampering with a motor vehicle, including vandalism/graffiti of the vehicle.

## Calling the Police:

**Dispatchers ask questions in a particular order for a reason. It is best to stay calm and answer all questions to the best of your ability.**

Complaint: **Location, Hazards (ie. weapons at scene), Victim info (sex, age, condition)**

Suspect Description: **Gender, Race, Age, Clothing, distinguishing features**

Vehicle Description: **Color, Make, Model, License Plate, distinguishing features**
