The San Francisco District Attorney's Office is inviting residents and businesses to register their security cameras. Registration is voluntary and there is no cost associated with registration. Registering your information *does not* provide the District Attorney's Office with direct access to your camera, just the location and the contact information. All information will be kept confidential and only accessed by law enforcement personnel who are investigating criminal activity. You may be contacted by law enforcement to request a copy of any video captured by your camera, which may assist in a criminal investigation.

The goal of the program is to deter crime and promote public safety through collaboration between the San Francisco District Attorney's Office and the communities we serve.


OFFICER OF THE MONTH

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is left unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ♦ **An individual peering into vehicles, to try and locate any valuables left unattended.**
- ♦ **An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.**
- ♦ **An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.**

IF YOU SEE SOMETHING, SAY SOMETHING

DEFINITIONS OF CRIME

Robbery– Robbery is the taking of property from another by using force or by using fear.

Assault– An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery- (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

****Assault is when a person swings their arm and battery is when that arm makes contact with another person. ****

Aggravated Assault– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

Burglary– The intent upon entry into a property to commit grand theft, petty theft, or any felony.



DEFINITION OF COMMUNITY POLICING

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

Homeless Outreach: Richmond Station Officers coordinate with city agencies to provide assistance and offer City services as needed. The Officers handle quality of life issues and find programs for willing individuals.

Foot Patrol: Richmond Station has dedicated foot patrols on Clement St., Geary Blvd, Golden Gate Park as well as the Cliff House.

Richmond Station Community Meetings: Community Meetings are held once a month for the public and residents of the Richmond District to attend. People can voice their comments or concerns about issues in the Richmond District.




MAP OF CRIMES

Officers responded to 2675 Geary Blvd, Target parking lot, regarding a possible auto break-in. Officers located the vehicle and the suspect described by the witness. The suspect was detained and a records check revealed he had a warrantless search condition. A search of suspect and the vehicle revealed several bottles of pills, small baggies of a white powdery substance, several baggies of suspected heroin, additional small plastic baggies, and a scale.

The Suspect was arrested and booked at County Jail One on the following charges: Transporting a controlled substance, Possession for Sales controlled substance.

The suspect walked away and yelled at the victim "I am not finished with you, I will come back and kill you!" The victim feared for his life and believed the suspect would carry out his threat. The suspect was located and detained by officers responding to the scene. The victim positively identified the suspect as his attacker.





SFPD Makes Several Auto Burglary Arrest Throughout the City

On Monday April 2nd, 2018 at 1:45 AM, Central District police officers were dispatched to the area of Grant Street and Filbert Street regarding subjects breaking into vehicles. Dispatch advised that the subjects had fled the area and gave a description of their vehicle. While enroute to the call, a victim contacted dispatch and said that he located the suspect vehicle at Montgomery Street and Francisco Street. Officers responded to the scene and witnessed one of the suspects burglarizing another vehicle on the 1800 block of Kearny Street. Officers determined that four suspects were involved in the burglaries and were able to take them into custody.

Tyler McKinney, a 26 year-old Berkeley resident, Christopher Wise, a 28 year-old Sacramento resident, Robert Warren a 23 year-old San Francisco resident and a 16 year-old juvenile male suspect were all booked on two counts of burglary and one count of conspiracy each.

On Tuesday April 3rd, 2018 at 11:05 PM, Mission Station officers were patrolling the area of Church Street and 20th Street when they observed a vehicle driving with dealer plates only. When the officers attempted to make a traffic stop, the vehicle sped off. Officers did not pursue the vehicle but the suspect's car was involved in a traffic collision at the corner of 25th Street and Church Street. Officers searched for the suspect and spoke to a witness who said that he heard someone jump over his backyard fence on the 3800 block of 25th Street. Officers responded to the backyard and arrested Dominic Spears, an 18 year-old transient.

Spears was booked at the San Francisco County Jail on one count of theft of vehicle, one count of possession of stolen property, one count reckless evading, one count failing to stop and exchange information at an accident, one count of failure to have a valid driving license while driving, one count of resisting arrest and one count of driving without a license plate.

On Wednesday April 4th, 2018 at approximately 8:24 PM, Southern District plainclothes officers were conducting surveillance on the area of the 1700 block of Alameda Street. The officers witnessed a car double park near another vehicle. A male who was later identified as Troy Savoy, a 20 year-old San Francisco resident, exited the car and began casing another vehicle. Savoy then returned to the driver's seat of his car and left the scene. Moments later Savoy returned in the vehicle, exited and approached the vehicle that he was casing. Savoy broke the window and grabbed a backpack from inside the victim's vehicle. Officers moved in to arrest Savoy. Savoy attempted to flee and crashed his vehicle into a parked car. Savoy and another passenger, who was later identified as Earl Jihad, an 18 year-old Pleasant Hill resident attempted to flee on foot but were quickly taken into custody.

Savoy was booked at San Francisco County Jail on one count of 2nd degree burglary, two counts of possession of stolen property, one count of conspiracy, one count of resisting arrest, as well as several vehicle code violations.

Jihad was booked at San Francisco County Jail on one count of 2nd degree burglary, one count of conspiracy, two counts of possession of stolen property and resisting arrest.

On Thursday April 5th, 2018 at 9:32 PM, plainclothes officers observed a suspect who was later identified as Manuel Mills, a 30 year-old Richmond resident, casing vehicles near the corner of 10th Street and Harrison Street. The suspect entered the front passenger seat of a car and drove away. Mills exited the vehicle again and changed seats with the driver who was later identified as Taj Williams, a 41 year-old Alameda resident. Mills drove the car to Division Street just west of King Street. Williams exited the vehicle and broke the rear window of a parked car. Officers attempted to arrest both subjects but Williams entered the vehicle and Mills reversed his car and crashed into a vehicle that was stopped in traffic. Officers placed both men under arrest and located another subject in the backseat, Savannah Jacobs, a 25 year-old female Richmond resident who was also placed under arrest. Officers located and seized burglary tools from the vehicle.

Taj Williams was booked at San Francisco County Jail on one count of burglary, one count of conspiracy, one count of possession of stolen property and one count of possession of burglary tools.

Manuel Mills was booked at San Francisco County Jail on one count of burglary, one count of conspiracy, one count of possession of stolen property.

Savannah Jacobs was booked at San Francisco County Jail on one count of burglary, one count of conspiracy and one count of possession of burglary tools.

On Saturday April 7th, 2018 at approximately 3:30 PM, officers were dispatched to 5th Street and Townsend Street regarding a bicycle being stolen out of a vehicle. Upon their arrival, officers were able to speak with the witness on scene and review surveillance footage of the incident. Officers were able to identify the suspect as Troy Hawthorne, a 34 year-old transient. The police were able to locate Hawthorne at 4th Street and Harrison Street in a tent. The stolen bike was recovered and Hawthorne was placed under arrest.

Hawthorne was booked at San Francisco County Jail on one count of burglary, one count of conspiracy, one count of possession of stolen property and possession of burglary tools.

Booking photos accompany this news release, except for the one juvenile male that was arrested.

These arrest are an example of the department's commitment to combat auto burglaries through the strategic deployment of resources, increased responsiveness and expanded deployment of both patrol and undercover officers.

San Francisco Police Make Arrest in Armed Robbery Investigation

On April 3, 2018 at 9:17PM, officers assigned to Tenderloin Station were patrolling the area of 6th Street and Market Street when they heard a loud argument. The officers saw two men involved in argument. As the officers approached, the two men walked away together, westbound on Market Street and continued to argue.

The officers contacted them and an officer recognized one of the subjects from a crime bulletin regarding an aggravated assault and robbery that occurred in the Mission District on March 18, 2018. In that incident, the 25 year-old victim was attacked near 25th Street and Bryant Street at 5:45AM when the suspect struck him in the head with a handgun. The victim fell to the ground and briefly lost consciousness. The suspect stole a backpack containing the victim's wallet, cell phone and other items.

The officers contacted the Robbery Detail investigator who confirmed that the subject detained at 6th and Market was the suspect wanted in connection with the March 18th robbery. The suspect, Luapou Lee, a 24 year-old San Francisco resident, was taken into custody. A 9MM handgun and suspected narcotics were recovered during the arrest.

Lee was booked into the San Francisco County Jail on the following charges: robbery, aggravated assault, possession of suspected methamphetamine for sale, carrying a concealed firearm, and resisting or delaying a peace officer. Due to pending identification matters, his booking photo is not available at this time.

While an arrest has been made, this remains an open an active investigation. Anyone with information is asked to call the SFPD 24 hour tip line at (415) 575-4444 or Text a Tip to TIP411 and begin the text message with SFPD. You may remain anonymous.

Sobriety Checkpoint In San Francisco

San Francisco Police Department's Traffic Unit will be conducting a sobriety checkpoint this Friday, April 27, 2018, at an undisclosed location within the city limits between the hours of 7:00 P.M. and 3:00 A.M.

The deterrent effect of sobriety checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized sobriety checkpoints and proactive DUI patrols are conducted routinely. Nationally, the latest data shows nearly 10,000 people were killed by an impaired driver.

Officers will be looking for signs of alcohol and/or drug impairment with officers checking drivers for proper licensing delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving. Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while also yielding considerable cost savings of \$6 for every \$1 spent. Nearly 90 percent of California drivers approve of DUI checkpoints.

DUI checkpoints are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

Types of Crime Reports That Can Be Filed Online:

- **Harassing Phone Calls:** When you are experiencing annoying calls - with no known suspects; for example, hang-ups or heavy breathing.
- **Lost Property:** When property has disappeared and not stolen. If you think it could have been taken but you have no idea by who, you may enter the report online.
- **Theft:** When property is stolen but there has been no illegal entry or contact by the thief.
- **Vandalism/Graffiti:** The act of changing, modifying or defacing public or private property, including graffiti.
- **Vehicle Burglary:** When property was stolen from a vehicle.
- **Vehicle Tampering:** Tampering with a motor vehicle, including vandalism/graffiti of the vehicle.

Calling the Police:

Dispatchers ask questions in a particular order for a reason. It is best to stay calm and answer all questions to the best of your ability.

Complaint: **Location, Hazards (ie. weapons at scene), Victim info (sex, age, condition)**

Suspect Description: **Gender, Race, Age, Clothing, distinguishing features**

Vehicle Description: **Color, Make, Model, License Plate, distinguishing features**

Auxiliary Law Enforcement Response Team (ALERT)



Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
