SFMTA rules state that it is OK to park in the street and block one's own driveway as long as the driveway does not serve more than 2 tenants. Any multifamily units of 3 or more cannot block the driveway.

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is left unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ◆ An individual peering into vehicles, to try and locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

IF YOU SEE SOMETHING, SAY SOMETHING

DEFINITIONS OF CRIME

Robbery– Robbery is the taking of property from another by using force or by using fear.

Assault– An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery- (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

****Assault is when a person swings their arm and battery is when that arm makes contact with another person. ****

Aggravated Assault– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

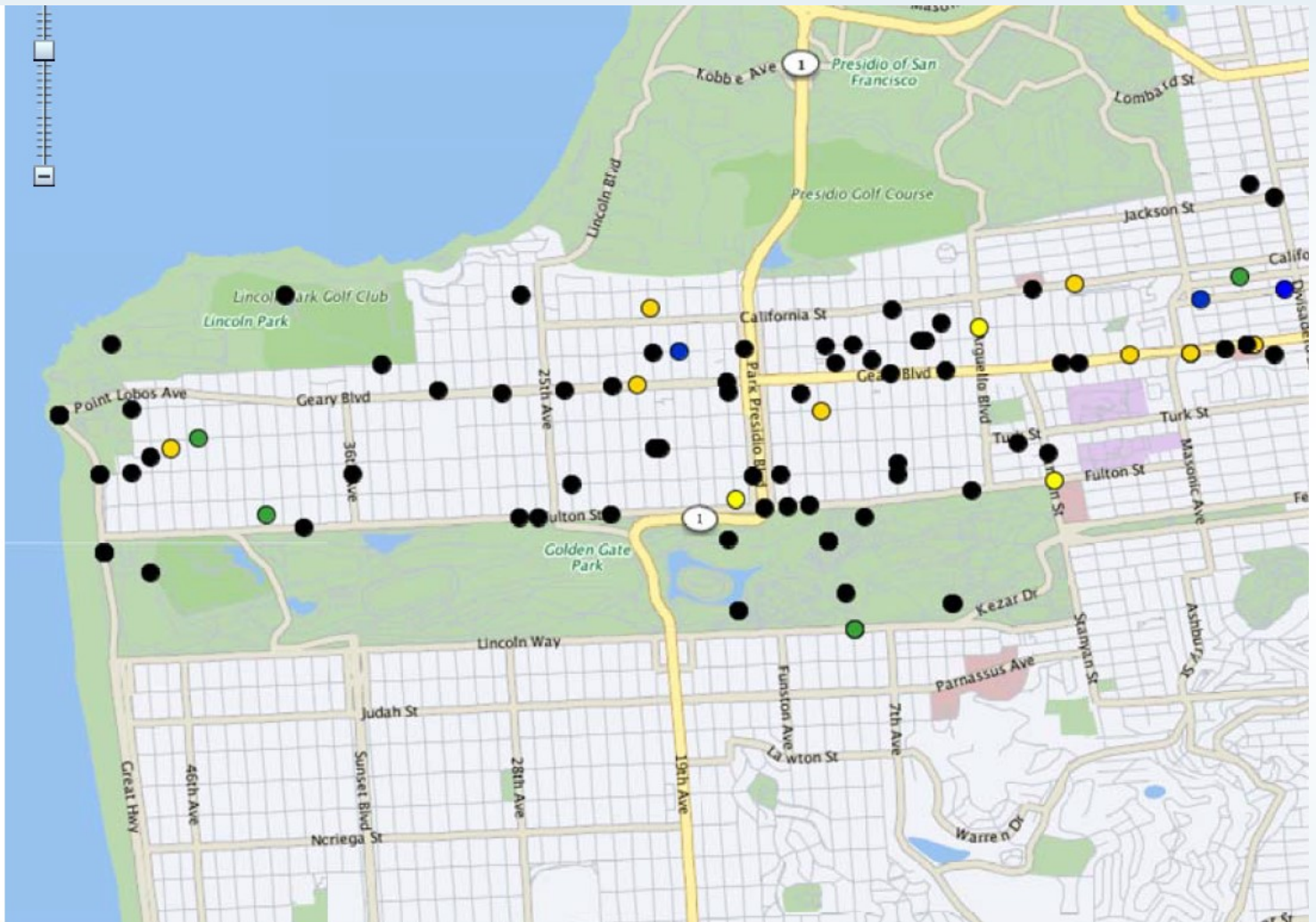
Burglary– The intent upon entry into a property to commit grand theft, petty theft, or any felony.

The victim was walking down the street when two suspects wearing masks exited a vehicle and quickly approached the victim. The suspects grabbed the victims backpack and a struggle ensued. One of the suspects then brandished a black hand gun and demanded the victims backpack. The victim, fearing for his life, relinquished the backpack and the suspects fled in the vehicle.

Suspect 1 is described as a Black Male, 18-25 years old, thin build, wearing all black clothing and a black mask.

Suspect 2 is described as a Black Male, 18-25 years old, thin build, wearing all black clothing and a black mask.

Suspect 3 is the driver of the vehicle and described as a Hispanic Female with a heavy build.

All suspects are outstanding and this in an ongoing investigation.

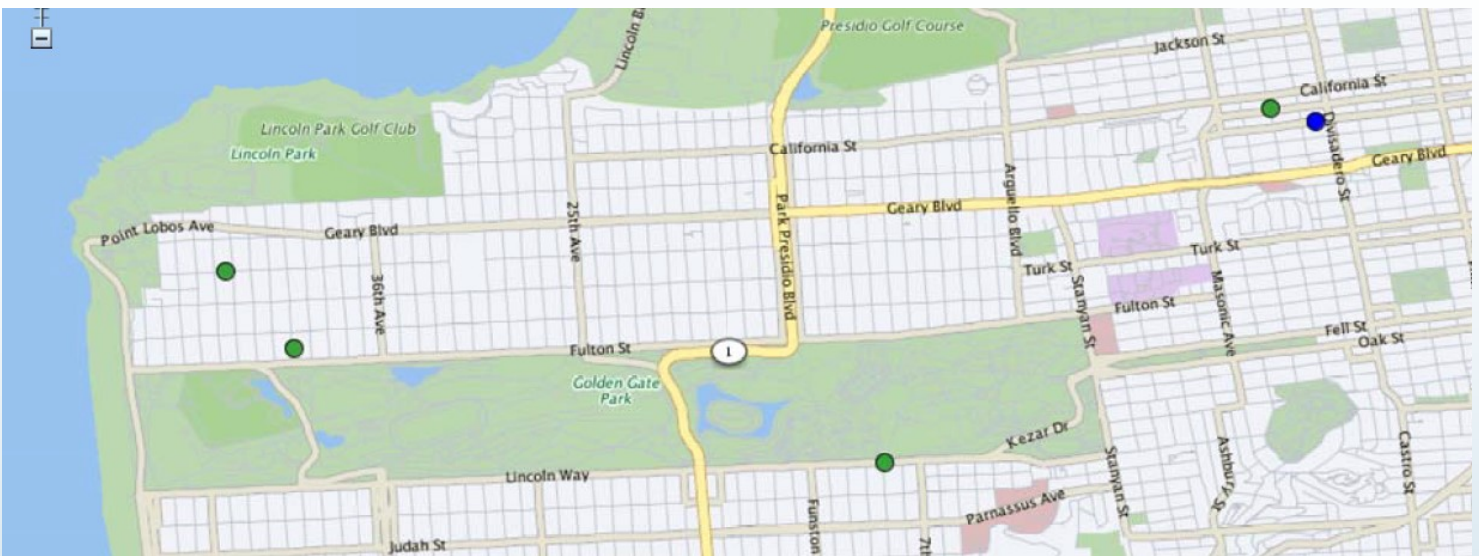

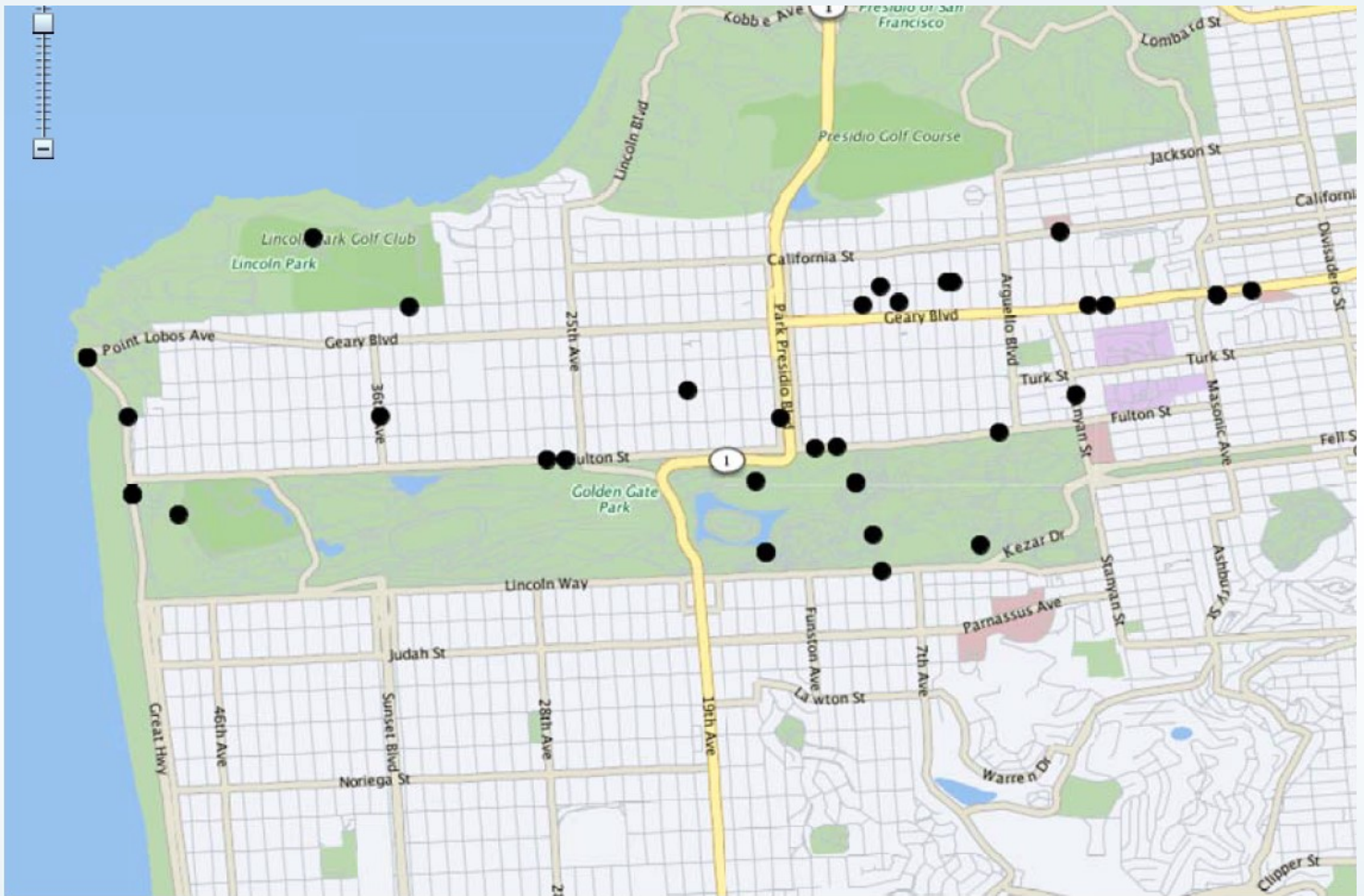

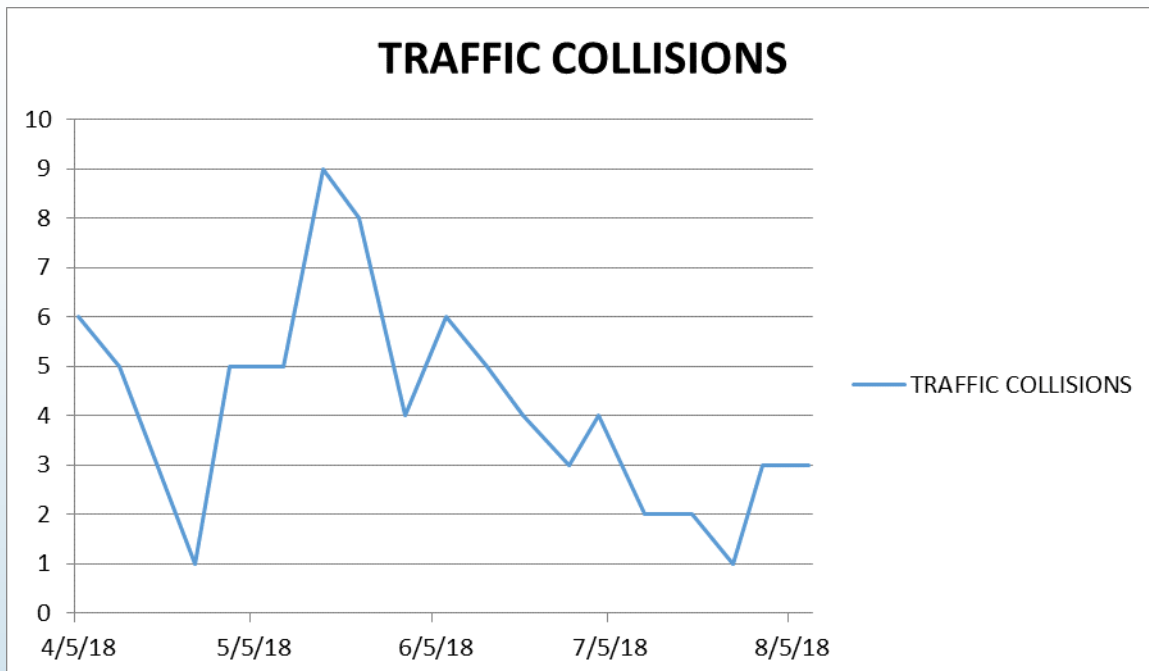

Burglary Awareness and Prevention Tips for Construction Sites

SECURING & PREVENTING

- 1) Secure all equipment and vehicles at all times
- 2) Take effort to reduce the visibility of tools and equipment secured in vehicles, or on job sites.
- 3) Make use of adequate lighting in conjunction with open chain-link fencing on the perimeter to allow for high visibility to the job site.
- 4) Strongly consider the use of security systems such as alarms and video surveillance. Ensure signage for such is clearly visible.

PRECAUTIONARY MEASURES

- 1) Photograph all tools. Ensure photographs clearly show the associated serial number, and/or distinctive markings.
- 2) Ensure job site keys are marked "Do Not Duplicate" and are controlled at all times.
- 3) Attempt to park employee vehicles within visible range of the job site.

SHOULD A BURGLARY OCCUR

- 1) If the crime is in progress call 911, if not please use the non-emergency line at 415-553-0123. Be prepared to provide the following information:
 - a. Date and time of Incident
 - b. Suspect description (if available)
 - c. Video (if available)
 - d. Items Taken, (including make, model, description, location taken from, value, photos and serial numbers)
 - e. Owners Information

San Francisco Police Request Public's Assistance in Solving Richmond District Hit and Run

Investigators from the San Francisco Police Department's Traffic Collision Investigations Unit (TCIU) are requesting assistance from the public in locating a suspect and vehicle wanted in connection to a hit and run traffic collision.

On August 4, 2018, at approximately 1:23 AM, SFPD officers responded to a traffic collision at Geary Boulevard and 2nd Avenue. A preliminary investigation determined that the victim, a 54 year-old male San Francisco resident, was crossing the intersection diagonally from the northeast to southwest when he was struck by the suspect vehicle. At the time of the collision, the suspect vehicle was travelling eastbound on Geary Boulevard. The driver immediately fled the scene, failing to stop to provide aid to the victim. The pedestrian suffered life threatening injuries and is still hospitalized.

The suspect vehicle is described as a dark colored sedan that likely has front end damage. The vehicle was last seen traveling southbound on Arguello Boulevard from Geary Boulevard.

San Francisco Police Make Arrests In Auto Burglary Cases

On Friday June 15, 2018 at approximately 2:17 PM, San Francisco police officers responded to the unit block of Locksley Avenue regarding a theft from vehicle report. The victim advised officers that he had filed an online report regarding the theft on Tuesday June 12th, 2018. The victim now had surveillance footage of the incident showing the suspect.

Officers reviewed the surveillance footage and were able to identify the suspect as seventy-five year-old Leonard Freeman of San Francisco. Freeman can be seen on the surveillance video entering a vehicle and removing property.

On Wednesday July 25, officers responded to Freeman's home in an attempt to place him under arrest for an outstanding warrant related to auto burglaries. Freeman attempted to flee the scene. He was arrested and booked at San Francisco County Jail for an outstanding warrant, three counts of possession of a controlled substance and one count of resisting arrest.

On Monday July 30th, 2018 at approximately 5:53 AM, officers responded to the unit block of Graystone Terrace regarding an auto burglary in progress. Upon arrival, officers discovered Tommy Boggs, a forty-six year-old transient, being held down by a witness and an auto burglary victim. During the preliminary investigation, a check of the vehicle Boggs had been driving revealed that the license plates and the vehicle were listed as stolen.

Boggs was placed under arrest. A search of the vehicle revealed property stolen in seven other auto burglaries from the past 24 hours. It was also discovered that Boggs had a garage door opener stolen from a vehicle in order to burglarize a house. Officers contacted the victims in these incidents and all of the property was returned to the rightful owners.
