CAPTAIN'S MESSAGE:

Hello Richmond District Residents,

Café Coco is hosting Coffee With A Cop on Wednesday 10/3 at 9am—see the flyer on page 6.

This week we are focusing on bicycle safety. The San Francisco Bicycle Coalition (sfbike.org) website contains useful information on Bicycle Laws and Safety Tips. Here are some of their recommendations:

Pedestrians Have The Right of Way:

In the crosswalk or not, bike riders and drivers are required to exercise due care for the safety of pedestrians.

Stop Behind The Crosswalk:

Leave crosswalks free and clear for pedestrians. Always stop behind the line.

Mind The Signs and Lights:

Stop at stop signs and obey red lights, just like all other vehicles.

Stay On The Streets:

It's illegal to ride on the sidewalk if you are over the age of 13.

Go With The Flow:

Ride the same direction as traffic. Walk your bike on the sidewalk if you find yourself on the wrong block of a one-way street.

Light Up The Night:

Reflectors and a front white light are required by law. We recommend you use a rear light as well

Keep An Ear Clear:

Even when using hands-free devices, bike riders and drivers are required to keep one ear free of headphones.

Pass On The Left:

Although bike lanes are often on the right side of the road, people biking and driving are required to pass other traffic on the left.

CITIZEN OF THE MONTH PAULETTE LEWIS




Meet our Citizen of the Month!

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is left unattended, a window/ door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

DEFINITIONS OF CRIME

Robbery– Robbery is the taking of property from another by using force or by using fear.

Assault- An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery- (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily in jury.

**<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person. **

Aggravated Assault– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.


Burglary– The intent upon entry into a property to commit grand theft, petty theft, or any felony.

INCIDENTS IN THE RICHMOND DISTRICT THIS WEEK

Warrant Arrest, Resisting Arrest 9/23/2018 18:15 Hours Fulton St & Arguello Ave

A witness called police and reported a subject with a large knife who appeared to be breaking into vehicles. Officers were flagged down by the witness and located the suspect. The suspect was pacing back and forth on the sidewalk and refused to comply with officers orders.

Additional units arrived and were able to safely detain the suspect. A records check revealed that the suspect had multiple outstanding warrants for his arrest. No damaged vehicles were located and the original witness declined to cooperate further.

While at Richmond Station and during transport to County Jail, the suspect continually spit on the ground and in the patrol vehicle at officers. At County Jail, medical assistance was requested to apply a spit mask as the suspect continued to spit on the patrol car and at Officers.

The suspect was booked into County Jail One on the following charges: 4 Outstanding Warrants and Resisting Arrest.

INCIDENTS IN THE RICHMOND DISTRICT THIS WEEK

Traffic Collision, Hit & Run, DUI Arrest 9/21/2018 20:30 Geary Blvd & 40th Ave

A driver heading eastbound on Geary Blvd, stopped for the stop sign at 40th Ave. He was waiting for a pedestrian to clear the crosswalk (thank you!) when his vehicle was struck from behind.

The driver who had struck the stationary vehicle got out of his car, and, according to the first driver, immediately fell on his face. The first driver, noticing that the other driver smelled of alcohol, was having difficulty standing and was slurring his speech, starting videoing him and called 911. The other driver fled, but was detained by responding officers a block away, and positively identified by the first driver, who never lost sight of him.

Responding officers conducted Field Sobriety Tests (FSTs) on the detained driver, at which he performed poorly. His breath test later showed a Blood Alcohol Concentration of 0.180%, or slightly over twice the legal limit of 0.008%.

The suspect was transported to San Francisco County Jail and booked for Driving Under the Influence (DUI), Misdemeanor Hit and Run, and Giving false information to a police officer.

Geary Rapid Project

Coming this October 2018: Transit-Only Lanes between Stanyan and Gough Streets



The Geary Rapid Project aims to make traveling on Geary and O'Farrell a more reliable and safer experience, with dedicated bus lanes, bus stop changes, improved crosswalks and traffic signal upgrades. Geary Rapid Project parking and traffic changes were legislated by the SFMTA Board in August, and implementation will begin this October.

How will this affect people driving?

Transit-only lanes on most blocks between Stanyan and Gough streets will be implemented, resulting in removal of one travel lane in each direction. The transit-only lane will be on the side of the street, typically next to the parking lane, though on a few blocks it will be curbside, replacing on-street parking. Between Stanyan and Masonic, transit-only lanes will receive a full treatment. From Masonic to Gough, temporary transit-only lane treatments will be implemented and later colorized red after roadway repaving is completed.

The rules for when you can enter Geary transit-only lanes

San Francisco's transit-only lanes (red or not) are off-limits to people driving, with a few exceptions. On Geary, you can enter transit-only lanes in the following situations:

 Turning Right. When preparing to make a right turn, safely enter the transit-only lane as you approach the intersection or driveway, as you would with any right turn. Red transit lanes are often dashed approaching intersections to make it easier to see where may be a good point to enter the lane before making a turn. Accessing Parking. People driving may enter a transit-only lane to pull in or out of a curbside parking space next to the lane.

How will new transit-only lanes be enforced?


Like any active traffic lane, pick-ups, drop-offs and double parking are not allowed within transit-only lanes. Double parking in transit-only lanes is enforced by automatic cameras on Muni buses, so you may get a ticket in the mail for those violations. In addition, SFMTA is working with the San Francisco Police Department to provide additional education and enforcement resources on the corridor during implementation.

How will this affect traffic?

Improving the speed and reliability of bus travel can improve conditions for people driving, too. Buses move more people in less space than a car, and when more people choose transit because it's fast and reliable, there are fewer cars on the street. During the project's environmental review process, future travel demand was estimated in order to study the impacts of dedicating these travel lanes to transit vehicles. Overall, the study found that fewer intersections would experience high levels of delay with the project than without.

Next steps

Following implementation of transit-only lanes, major Geary Rapid Project improvements and coordinated utility upgrades will begin and continue into 2021. During construction, one lane of traffic at a time may be closed in segments of the corridor. However, work is not planned to be done during peak commute hours or at night.


Friday, September 21, 2018 - SFPD Make arrest in Portola District Robbery Series

In early September of 2018, a series of strong - arm robberies occurred in the Portola District of San Francisco. The suspect in these robberies approached female victims who were walking by themselves and used force in the commission of the crimes. Investigators received reports of incidents at the following locations:

September 5, 2018 at 10:15 AM; Bacon Street and Hamilton Street September 7, 2018 at 3:21 PM; 500 block of Holyoke Street September 9, 2018 at 12:40 PM; Bacon Street and University Street September 10, 3018 at 12:55 AM; Woolsey Street and Girard Street

The San Francisco Police Department's Robbery Detail began an investigation that led to the identity of the suspect. On September 14, 2018 at approximately 12:35 PM, members of the SFPD Robbery Detail and the Antioch Police Department arrested the suspect, 29 year - old Michael Crayton, in the area of the 4100 block of Lone Tree Way in Antioch, CA.

Search warrants served on Crayton's car and residence in Antioch resulted in the discovery of evidence from an unreported robbery that occurred in San Francisco on September 11, 2018. Cr ayton was booked in San Francisco on charges of five counts of robbery, two counts of battery with serious injuries and one count of aggravated assault. Due to pending identification matters, Crayton's booking photo is not being released at this time. Th is quick and successful completion of this investigation would not have been possible without the assistance of Portola neighborhood residents and business owners who provided surveillance video to investigators.
