### DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is left unattended, a window/ door is open that is usually closed, or other out-of-the-ordinary situations occur.

**Examples of Suspicious Activity:** 

- An individual peering into vehicles, to try and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

## IF YOU SEE SOMETHING, SAY SOMETHING

### **DEFINITIONS OF CRIME**

Robbery- Robbery is the taking of property from another by using force or by using fear.

Assault- An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery- (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily in jury.

\*\*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person. \*\*

**Aggravated Assault**– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.


Burglary– The intent upon entry into a property to commit grand theft, petty theft, or any felony.

#### **INCIDENTS IN THE RICHMOND DISTRICT THIS WEEK**

#### Burglary, Arrest 10/06/18 2045 Hours Lake St/ 5th St

A witness observed a suspect "jimmy" the front door of the apartment building and proceed to the apartment's bicycle storage area and check which bicycles were locked. Witness called 911 and the suspect attempted to flee. The witness chased the suspect, who stopped and pulled out a knife. The witness was concerned for his safety so he grabbed the suspect's arm and wrestled the suspect to the ground. Responding officers placed the suspect in handcuffs and searched him, locating a knife and a screwdriver. The suspect was on parole from the CDC for burglary.

The suspect was arrested and booked at County Jail on the following charges: Burglary, Possession of Burglary Tools, and Assault with a Deadly Weapon.

#### Felon in Possession of Ammunition, Arrest 10/07/18 2118 Hours MLK JR Dr/ Hagiwara Tea Garden Dr

Officers responding to an auto-burglary in progress located an individual matching the description of the suspect, wearing a face mask, riding a Ford GoBike on MLK Jr Dr in the direction opposite to traffic and looking into parked vehicles. The officers conducted a cold show with the witnesses, who confirmed similar build and clothes but were unable to positively identify suspect's face due to the mask he was wearing. A search of the suspect's backpack revealed two loaded high-capacity magazines, burglary tools, and credit cards and identification not belonging to him. The suspect was on parole for burglary and on probation for petty theft and possession of heroin.

The suspect was arrested and booked at County Jail on the following charges: Probation Violation, Felon in Possession of Ammunition, Possession of a High-capacity Magazine, and possession of burglary tools.







#### San Francisco Police Arrest Burglary Suspect

On Friday September 21, 2018, around 5:10 am, San Francisco Police Officers from Southern Police Station responded to the 1400 block of Folsom Street for a report of a burglary in progress. A passerby alerted police when they noticed that the front doors of the business were damaged. Officers searched the multi-level business and interrupted the burglar on the first floor as he was attempting to carry out stolen items. A preliminary investigation identified twenty separate storage units that had been broken into and numerous items had been stolen.

Officers placed 46 year-old Lamont Jackson of San Francisco under arrest for multiple burglaries. Following an investigation by the SFPD Burglary Unit, which was presented to the San Francisco District Attorney, Mr. Jackson, already on probation for burglary, was charged with twenty counts of burglary and probation violation.

#### San Francisco Police Seek Public's Assistance in Locating Hit and Run Driver and Car

On October 3, 2018 at approximately 9:11 PM, San Francisco Police officers responded to a vehicle versus pedestrian collision at Oak Street and Baker Street. Upon arrival officers located the pedestrian, a 60 year-old male San Francisco resident, suffering from life threatening injuries. The victim was transported to Zuckerberg San Francisco General Hospital (ZSFGH) where he remains hospitalized in life-threatening status.

Investigators from the SFPD Traffic Collision Investigation Unit (TCIU) determined that the suspect vehicle, a black or dark blue Toyota Prius ran a red traffic light while traveling eastbound on Oak Street at Baker Street. The Prius struck the pedestrian who was in the crosswalk while crossing Oak Street from the southeast to northeast corner.

The driver of the Prius stopped at the scene and briefly exited the vehicle, before fleeing in the Prius eastbound Oak Street to southbound Broderick Street. The Prius likely sustained front end damage as a result of the collision.

SFPD TCIU Investigators are asking the driver of the Toyota Prius to contact them by calling the SFPD 24 hour tip line at (415) 575-4444. Investigators are also asking residents and business owners in the area of the incident to check surveillance cameras for any images related to the incident. Anyone seeing a black or dark blue Toyota Prius with front end damage, or anyone with information regarding this incident is asked to call the SFPD 24 hour tip line at (415) 575-4444 or Text a Tip to TIP411 and being the text message with SFPD.
