# Officer Involved Discharge 006-15

Incident: September 5, 2015

Location: 3000 Block of Ingalls Street

Finding: In Policy

At 10:05 hours, Bayview Station officers responded to a report of a vicious dog mauling a child. Arriving officers saw a pit bull in the midst of a fatal mauling, violently shaking a smaller dog, as a horrified crowd attempted unsuccessfully to intervene. An officer fired a department-issued shotgun once at the vicious dog to stop its deadly violent attack and protect the people present. The pit bull was struck; it collapsed and expired at the scene.



# Officer Involved Shooting 15-005

Incident:

July 26, 2015

Location:

US 101/San Bruno Avenue

Finding:

In Policy

An officer assigned to the Airport Bureau responded to assist other officers searching for a hit and run driver that had run from them. The suspect had repeatedly attempted to carjack passing vehicles while trying to get away. The suspect began to head toward one of the officers. The officer gave ground and ordered the suspect to the ground, before firing twice to stop the suspect's imminent assault. The suspect was struck once in the torso and taken into sustody.

# OIS Investigations Update

The previous OIS Quarterly Report was presented to the Police Commission on October 5, 2015. Since that report:

- One (1) OIS investigation (OIS 15-005) was presented to the last FDRB. A summary letter is forthcoming to the Police Commission.
- Two (2) charging decision letters from SFDA were received on December 15, 2015 (OIS 13-008 and 14-001).
- Four (4) OIS investigations opened (OIS 15-007, 15-008, 15-009, and 15-010). There are active criminal investigations by SFPD Homicide and SFDA.

# Open OIS Cases Summary

As of October 5, 2015, there are eighteen (15) open OIS investigations:

- Two (2) cases have been reviewed by the SFDA and charging decision letters issued. These are expected for presentation at the next FDRB.
- Eleven (11) criminal investigations are currently under review by the Office of the District Attorney of San Francisco. The District Attorney's charging decisions in these cases are pending. The corresponding SFPD administrative investigations are tolling.
- Five (5) criminal investigations are active. One with the San Mateo Police Department and four with the SFPD Homicide Detail and SFDA.
