**Monday, December 10<sup>th</sup>, 2018**

### Arrests:

#### **4:30pm Silver & Cambridge**

#### **Aggravated Assault**

An elderly Muni passenger boarded a bus and wanted to sit in the front section reserved for the elderly and disabled. He asked a young teenage girl, sitting in one of the seats, if he could sit down. She refused and an argument ensued which quickly turned into an assault as the young woman struck the elderly man several times in the head using a flashlight. She, along with two friends, quickly exited the bus while the driver called police. Medics treated him for his injuries and Ingleside Officers Fyles and Tom broadcast a description of the suspects to surrounding units. Video of the incident was sent by MUNI officials to the station investigative unit. Report number: 180931298

#### **Arson**

Ingleside Officers Tom and Fyles were dispatched to a report of a fire on City land. When they arrived SFFD personnel had already extinguished the blaze. A witness said they saw a man earlier use a bottle of accelerant to start a small fire on the hillside. He speculated the fire may have been an attempt to scare away a nearby coyote. #### **Aggravated Assault**

A fake \$100 bill, a pair of scissors, and some costume jewelry, all were ingredients of an incident involving a flea market vendor and a customer. The woman customer bought the jewelry for \$25 from a vendor with a fake \$100 bill. The vendor gave the woman customer \$75 change and handed the \$100 bill to his wife. The spouse immediately discovered the bill was fake prompting her husband to run after the suspect to get his \$75 and jewelry back. The suspect wasn't cooperative and fought the vendor using a pair of scissors to cut his hand. A market security guard was summoned and held the suspect until Ingleside Officers Gunter and Zandanel arrived for the arrest. Report number: 180928091

#### **Aggravated Assault**

A dispute outside a bar, just closed for the night, ended up with two patrons injured by an unknown suspect. One victim told Ingleside Officer Clayton that he witnessed two men arguing on the sidewalk outside the bar. The argument turned violent when one of the men punched the victim several times causing him to fall to the ground. Then, the suspect turned his attention to the complainant punching him several times to where he briefly lost consciousness. The first victim was not at the scene when Officer Clayton arrived and was later found at San Francisco General Hospital being treated for serious injuries. #### Hot Prowl Burglary

#### Battery

A dispute between a homeowner and a couple of skateboarders resulted in the homeowner losing a tooth. #### Robbery

Store security spotted a suspicious person cruising the Safeway aisles placing beer, candy, and other items into his backpack. They told Ingleside Officers Church and Brown that the suspect walked out of the store without paying and was confronted in the parking lot. The employees told him to return to the store and either pay or surrender the items. He refused and started fighting with security personnel. During the fight, the suspect's wife jumped into the melee and punched store personnel several times while they tried to subdue the suspect. #### Gunshots

A search of the pre-school found no evidence of a break-in but did find damage to the school's fence. Other witnesses confirmed hearing "7 gunshots", but not seeing any suspects or victims. 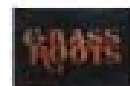

### **Vandalism Suspects Surrender After Release of Video Footage**

On Saturday December 8<sup>th</sup>, 2018 at approximately 6:47 PM, San Francisco police officers were flagged down outside of a restaurant located on the 1400 block of Polk Street regarding a vandalism incident.

The officers met with an employee who stated that two unknown women who appeared intoxicated came into the restaurant. One of the women told the employee that she had paid for food but never received it. The employee denied that she had paid for food and refused her service because she was too intoxicated. The woman became angry and began knocking over items, including the cash register. The employee confronted the woman and she punched him in the face. The employee ran away for safety while the woman continued to knock items over inside the restaurant. The employee stated that the other woman grabbed a chair outside the restaurant and shattered the front door glass. Both of the women then left the scene.

Video of the incident was released. On Tuesday, December 11<sup>th</sup> after having seen the footage on the local news, both women surrendered themselves at Northern Police Station.

Twenty-one year-old San Francisco resident Natalie Alcantar was booked at San Francisco County Jail for felony vandalism. Twenty-one year-old Pacifica resident Hannah Baughman was also booked at San Francisco County Jail for felony vandalism and battery. Booking photos are not available at the time of this release.

### **San Francisco Police Department Prompts Shoppers To Park Smart During The Holidays**

*Reminder Comes as Auto Burglaries Continue to Decrease, Arrests Rise*

The San Francisco Police Department today reminded shoppers to take simple steps to protect their purchases this holiday season, while announcing a 16 percent year-to-date decrease in auto burglaries citywide.

The decrease comes after the SFPD took significant steps to address auto burglaries by increasing plainclothes teams and doubling uniformed foot patrols, expanding investigative resources at district stations, creating a General Crimes Unit to address serial auto burglars, identifying and focusing on burglary hot spots, and increasing training for fingerprinting.

"Addressing the spike in car break-ins has been one of my top priorities since my time on the Board of Supervisors," said Mayor London N. Breed. "I am excited that our targeted awareness and enforcement campaigns are steadily addressing this issue, and I want to thank Chief Scott and the SFPD for their continued efforts to keep our neighborhoods safe for residents and visitors."

In the first 10 months of 2018, San Francisco police officers booked or cited 331 people for auto burglaries, a 31 percent increase over total bookings and citations for 2017.

"We're seeing consistent and significant progress in our efforts to stop auto break-ins," said San Francisco Police Chief William Scott. "But we recognize that too many San Francisco residents, workers and visitors continue to be impacted by these crimes. Our officers will have increased visibility during the upcoming holidays to combat street crimes. By remembering to Park Smart this holiday season, shoppers can help us prevent auto burglaries."
