### Incident Date

**Monday, January 14<sup>th</sup>, 2019**

### Arrests:

**12:17am      200 Blk Judson Ave      Stolen Vehicle**

Ingleside Officers were on patrol when they observed a suspicious vehicle parked in front of a known problem location. The officers got out to investigate and discovered a female in the vehicle. Officers discovered that the plate on the vehicle did not match the vehicle's identification number. The reason for this was because the vehicle was reported stolen. The female suspect was arrested and charged appropriately. Case # 190006671

Ingleside Officers responded to the above location on the report of an assault. The victim reported that while walking home he was approached by two male suspects. The suspects grabbed the victim, and punched him in the ribs. Ingleside Officers responded to the above location on the report of an armed robbery. Two victims reported as they walked by a group of suspects near the Precita Steps, one suspect called out to them and then pulled a gun from his hooded sweatshirt. Two subjects from the group then proceeded to go through both victims' pockets, stealing their belongings. All suspects then fled up the staircase on foot. Ingleside Officers were on patrol when they observed a suspicious vehicle. When the officers ran the license plate they learned it was reported stolen. The officers observed a male suspect exit the driver side of the vehicle, and walk towards a known problem location on the block. The suspect ignored the officer's commands to stop. The suspect entered the residence and refused to come out. The owner of the residence allowed police to enter and after a short struggle, took the suspect into custody. #### **Robbery**

Ingleside plain clothes officers were in an unmarked vehicle on Geneva Avenue and Mission Street stopped in traffic. They observed a subject running through traffic with two juvenile males chasing after him. As the subject passed the officers they noticed a cell phone in his hand. The suspect jumped into a waiting vehicle and sped off. The officers broadcasted their observations, and with assistance from multiple units, were able to catch up to the getaway vehicle and detain all three occupants. The two victims reported they were walking home from school when the suspect approached them and demanded their phones. In fear for their safety the victims complied with the suspect's demands. The suspect then fled on foot to the awaiting getaway vehicle. The victims positively identified Suspect #1 as being the subject who robbed them. All occupants of the vehicle were arrested and charged appropriately. Case # 190018814

#### **Assault/Burglary**

Ingleside Officers responded to the call of a burglary. The caller reported seeing a suspect leaving her elderly neighbor's home, which is the flat above her own. The victim's brother arrived on scene and started canvassing the area for his sister who was not home. The brother found the victim in the park near the playground. Officers discovered the victim was severely beaten, and unconscious. The victim was transported to SFGH for a skull fracture, brain bleed, and numerous facial fractures. The victim is in critical condition. The case is assigned to the Special Victims Unit. Case # 190017656

## Auxiliary Law Enforcement Response Team (ALERT)



Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



## What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

### Pathways to ALERT membership:

1. Complete NERT training and receive certification. To register for NERT training courses, please visit [www.sfgov.org/sfnert](http://www.sfgov.org/sfnert). Once NERT Certified, forward a copy of your NERT ID card to the ALERT program at [sfpdalert@sfgov.org](mailto:sfpdalert@sfgov.org). After clearing our background check, you are eligible for ALERT training.
2. If you are an SFPD Community Police Academy graduate, you are eligible for ALERT training after clearing our background check.

### ABOUT PROPOSITION E

Last November, the voters passed Proposition E by a 75% majority thereby earmarking 1.5% of the City's 14% Hotel Tax for arts and cultural programming. The legislation increases extant city support for GFTA, the Cultural Equity Endowment, and Cultural Centers. It also includes funding for new priorities, such as a fund to support cultural districts (administered by the Mayor's Office of Housing and Community Development) and a newly established Arts Impact Endowment to address emerging needs in the arts and culture sector. The SFAC and GFTA have launched a public engagement process to help create a Cultural Services Allocation Plan to help guide how the new Arts Impact Endowment funds will be spent over the next five years.

### **Volunteer to serve on the San Francisco Civil Grand Jury**

San Francisco Superior Court is seeking volunteers for the Civil Grand Jury. The Civil Grand Jury is the “watchdog” for the City and County of San Francisco. The Civil Grand Jury investigates the operations of City government, including officials, departments, and agencies. Each year, the Civil Grand Jury issues reports based on its findings. Those reports are heard before the Board of Supervisors.

The Civil Grand Jury will serve from July 1, 2019 through June 30, 2020. The application deadline is May 17, 2019.

#### **Eligibility Requirements:**

- 18 years of age or older and a United States citizen.
- San Francisco resident for at least the past 12 months.
- Able to commit time consistently throughout the term.
- Desire to work together with other committed San Franciscans.

## SAN FRANCISCO CIVIL GRAND JURY FACT SHEET AND SELECTION TIMELINE

### **What is the Civil Grand Jury?**

- As required by the California Constitution, the Civil Grand Jury is a “watchdog” that investigates the operations of the City and County government, including its officers, departments, and agencies.
- The Civil Grand Jury is 19 members randomly drawn from a pool of applicants who volunteer to serve for a one year term.

### **How does it Work?**

- Each Civil Grand Jury determines, by majority vote, which issues related to the government of the City and County of San Francisco to investigate. Typically, the Jury divides itself into committees, which carry out the investigations and write the reports.
- To do the investigations and write its reports, Civil Grand Jurors review records and financial documents; interview City and County department heads, elected officials, and staff; and visit government facilities. The entire Jury must vote to approve reports.
- After the Presiding Judge of the Superior Court reviews the reports to ensure they meet legal requirements, the reports are issued. The affected departments are required by law to respond to each finding and recommendation contained in the reports.
- The Board of Supervisors holds a public hearing on each report. The Civil Grand Jury presents the report, and each affected department responds. The Board of Supervisors then issues its own response.

### **When?**

- The entire Civil Grand Jury meets once per week, generally in the late afternoon. Subcommittees meet as needed. Most of the Jury’s work takes place during regular business hours.
- Jurors must be able to serve the entire term, from July 1 through June 30. Jurors must be able to commit time consistently throughout the term.

### **Who is Eligible?**

- In order to volunteer to be considered for the Civil Grand Jury, you must be a United States citizen; at least 18 years of age; have lived in San Francisco for at least the past one year; have no felony convictions; and have the ability to communicate in English.

### **How do I Apply?**

- Applications may be downloaded from <http://civilgrandjury.sfgov.org/join.html>, or you may pick one up at San Francisco Superior Court, 400 McAllister Street, Room 007. The application deadline is on May 17, 2019.
- The most qualified applicants will be invited to attend a mandatory informational session on May 21 or May 30, 2019.
- Selection by a panel of Superior Court Judges will be held on June 7, 2019.
- The 2019 – 2020 Civil Grand Jury will be trained on June 10, 17, 18, and 24, 2019.
- The 2019 – 2020 Civil Grand Jury takes office on July 1, 2019.

### Visitacion Valley Aggravated Assault Update

On January 8, 2019 at approximately 6:45AM, San Francisco Police officers responded to a residence on the 1000 block of Visitacion Avenue. A witness reported seeing an unknown male suspect exit the residence from an interior staircase then walk eastbound on Visitacion Avenue.

Shortly thereafter, an 88 year-old female suffering from severe head injuries was located in a park across the street. The victim was transported to the hospital and still being treated for life-threatening injuries.

Investigators believe the unknown suspect attacked the victim in the park and then entered her home across the street before fleeing the area. The suspect is described as a black male in his thirties, approximately 5'6" tall with a skinny build. A dedicated team of investigators from the SFPD Special Victims Unit is actively working this case. A forensic sketch of the suspect accompanies this news release.

## **DMV Reminds Motorists of New 2019 Laws**

**Sacramento** – With the New Year just around the corner, the California Department of Motor Vehicles (DMV) wants to inform the public about several new laws or changes to existing law that, unless otherwise noted, take effect January 1, 2019.

**Temporary License Plate Program ([AB 516, Mullin](#)):** This law requires licensed California dealers, of new and used vehicles to attach temporary paper license plates on a vehicle at the point of sale if that vehicle does not display license plates previously issued by the DMV. The temporary license plates contain a unique number and expiration date. No vehicle can be driven off the dealership lot without the temporary license plate affixed to it unless it already has issued plates. The intent of this new law is to reduce the number of toll violators and improve safety for law enforcement.

**Gender Identity Female, Male, or Nonbinary ([SB 179, Atkins](#)):** This law allows individuals applying for a California driver license or identification card to self-certify their chosen gender category of male, female or nonbinary in the application. Applicants who select nonbinary will receive a card with an "X" in the gender category.

**Driving Under the Influence – Ignition Interlock Device ([SB 1046, Hill](#)):** From January 1, 2019 to January 1, 2026, this law mandates repeat offenders for driving under the influence (DUI) and first DUI offenders whose violations resulted in injury, to install an ignition interlock device (IID) for a period ranging from 12 to 48 months. This law also allows those who receive a suspension under the Administrative Per Se law to obtain an IID-restricted driving privilege, and receive credit toward their required IID restriction period if they are later convicted of a DUI. These provisions apply to DUI violations that involve alcohol or the combined use of alcohol and drugs. They do not apply to drug-only violations. Additionally, courts have the discretion to order a non-injury first DUI offender to install an IID for a period of up to 6 months. If the court does not order IID installation, a non-injury first offender may apply for a driver license for IID restrictions or restrictions that allow them to drive to, from, and during their employment and to and from a DUI treatment program for 12 months. Previously, an IID pilot program was only in effect in Alameda, Los Angeles, Sacramento and Tulare counties.

**Smog Check Changes and New Abatement Fees ([AB 1274, O'Donnell](#)):** This law expands the existing smog check exemption to vehicles that are up to eight model years old, up from the current exemption of six model years. During the additional two years of exemption, these vehicles will pay an annual \$25 smog abatement fee. The current annual \$20 smog abatement fee for the first six years of exemption remains unchanged.

**Driving Privilege for Minors ([AB 2685, Lackey](#)):** This law repeals a juvenile court's authority to suspend, restrict or delay the issuance of a driver license of a habitual truant or ward of the state for up to one year. The law clarifies that any suspensions or delays reported prior to January 1, 2019, remain in effect.

**Motorized Scooters, ([AB 2989, Flora](#)):** Bicycle helmets are no longer required for riders of motorized scooters who are age 18 or older. It also amends existing law to prohibit a person from operating a motorized scooter on a highway with a speed limit greater than 25 miles per hour, unless it is within a [Class IV bikeway as well as a Class II bikeway](#). However, it permits local authorities to authorize the operation of motorized scooters on roads with speed limits up to 35 miles per hour outside of a Class II or Class IV bikeway.

**Unsafe, unsecured loads on vehicles ([AB 1925, Choi](#)):** This law requires the DMV to include at least one question addressing laws pertaining to driving with an unsafe, unsecured load in at least 20 percent of the knowledge tests administered to driver license applicants. Unsecured loads, such as ladders, buckets and loose items in the back of pickup trucks, can be dangerous for motorists when they fall onto the road. Therefore, all vehicle loads must be covered or secured.

**High-Occupancy Vehicle Lanes ([AB 544, Bloom](#)):** As previously announced, AB 544 created a new program to grant low-emission vehicles and transitional zero-emission vehicles access to high-occupancy vehicle (HOV) lanes for an approximate four-year period, regardless of the vehicle occupancy level. A green or white decal is valid until January 1, 2019 and vehicles displaying these decals no longer have access to HOV lanes. Vehicles that were issued a green or white decal between January 1, 2017 and March 1, 2018 are eligible to apply for a red decal that grants them access to HOV lanes until January 1, 2022. The DMV notified these customers of their eligibility by mail. The DMV will issue light purple decals in 2019 that will grant access to HOV lanes until January 1, 2023. Decals are available to applicants who have not applied for or received a consumer rebate pursuant to the Clean Vehicle Rebate Project, unless they meet annual income requirements.
