What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Pathways to ALERT membership:

- 1. Complete NERT training and receive certification. To register for NERT training courses, please visit www.sfgov.org/sfnert. Once NERT Certified, forward a copy of your NERT ID card to the ALERT program at sfpdalert@sfgov.org. After clearing our background check, you are eligible for ALERT training.
- 2. If you are an SFPD Community Police Academy graduate, you are eligible for ALERT training after clearing our background check.

San Francisco Police Department Makes Arrest in Visitacion Valley Assault Case Suspect Linked to Carjacking and Two Separate Robberies

On January 8, 2019 at approximately 6:45AM, San Francisco Police officers responded to a residence on the 1000 block of Visitacion Avenue. A witness reported seeing an unknown male suspect exit the residence from an interior staircase then walk eastbound on Visitacion Avenue.

Officers noticed that the front door of the residence was unlocked and open and searched the residence but were unable to locate the occupant. Shortly thereafter, an 88 year-old woman suffering from severe head injuries was located in a nearby park on Leland Avenue. The victim was transported to Zuckerberg San Francisco General Hospital where she is still being treated for her injuries.

The two incidents were linked by video surveillance footage and evidence located at the scene of the assault and the victim's residence. Investigators believe the suspect assaulted the victim, stole the keys to her residence, and was in the process of committing a burglary at the residence when he was interrupted by a witness.

Over the course of two weeks, SFPD investigators worked tirelessly to identify the suspect. Investigators reviewed surveillance footage, conducted multiple interviews, collected evidence and distributed a forensic artist sketch of the suspect to the public for assistance in our investigation. Evidence collected from the incident was submitted to SFPD's crime lab and on January 18, investigators were notified that DNA analysis linked 18 year-old San Francisco resident Keonte Gathron to the assault and subsequent burglary.

An immediate search began to locate and apprehend Gathron. Almost simultaneously, Gathron was also identified as a suspect in a carjacking which occurred in the early morning hours of January 16, on the 1600 block of Visitacion Avenue. The carjacked vehicle was later found abandoned at gas station on San Bruno Avenue. Video

evidence obtained at the scene led to the identification of Gathron as the carjacking suspect.

On Saturday, January 19 at approximately 4:45PM, a 14 year-old girl was approached on the 1000 block of Woolsey Avenue by a suspect on a red bicycle and robbed of her cell phone at gunpoint. At approximately 6:00PM, a 17 year-old girl was approached at Charles Avenue and Belle Avenue in the Taraval district by a suspect on a red bicycle. The suspect punched the girl in the face and stole her phone.

Responding officers from Ingleside Station were able to track the cell phone to the Sunnydale district of San Francisco. During a search, officers made contact with Gathron, whose clothing matched the description of the robbery suspect. After a short foot pursuit and search, officers located Gathron hiding in a vehicle and placed him under arrest.

Gathron's charges are as follows:

Assault/Burglary Case: Attempted Murder, Kidnapping, Robbery, Aggravated Assault, Elder Abuse, Burglary, Possession of Stolen Property, Attempting to Destroy Evidence.

Robberies: Robbery (2 counts), Child Endangerment, Possession of Stolen Property, and Resisting Arrest.

"SFPD investigators, patrol officers and our crime lab personnel worked relentlessly to identify and arrest a suspect in these brutal crimes," said San Francisco Police Chief William Scott. "We thank all of the community members who came forward to work with us and address safety concerns related to this case."





ABOUT PROPOSITION E

Last November, the voters passed Proposition E by a 75% majority thereby earmarking 1.5% of the City's 14% Hotel Tax for arts and cultural programming. The legislation increases extant city support for GFTA, the Cultural Equity Endowment, and Cultural districts (administered by the Mayor's Office of Housing and Community Development) and a newly established Arts Impact Endowment to address emerging needs in the arts and culture sector. The SFAC and GFTA have launched a public engagement process to help create a Cultural Services Allocation Plan to help guide how the new Arts Impact Endowment funds will be spent over the next five years.



Volunteer to serve on the San Francisco Civil Grand Jury

San Francisco Superior Court is seeking volunteers for the Civil Grand Jury. The Civil Grand Jury is the "watchdog" for the City and County of San Francisco. The Civil Grand Jury investigates the operations of City government, including officials, departments, and agencies. Each year, the Civil Grand Jury issues reports based on its findings. Those reports are heard before the Board of Supervisors.

The Civil Grand Jury will serve from July 1, 2019 through June 30, 2020. The application deadline is May 17, 2019.

Eligibility Requirements:

- 18 years of age or older and a United States citizen.
- San Francisco resident for at least the past 12 months.
- Able to commit time consistently throughout the term.
- Desire to work together with other committed San Franciscans.

SAN FRANCISCO CIVIL GRAND JURY FACT SHEET AND SELECTION TIMELINE

What is the Civil Grand Jury?

- As required by the California Constitution, the Civil Grand Jury is a "watchdog" that investigates the
 operations of the City and County government, including its officers, departments, and agencies.
- The Civil Grand Jury is 19 members randomly drawn from a pool of applicants who volunteer to serve for a one year term.

How does it Work?

- Each Civil Grand Jury determines, by majority vote, which issues related to the government of the City
 and County of San Francisco to investigate. Typically, the Jury divides itself into committees, which carry
 out the investigations and write the reports.
- To do the investigations and write its reports, Civil Grand Jurors review records and financial documents; interview City and County department heads, elected officials, and staff; and visit government facilities. The entire Jury must vote to approve reports.
- After the Presiding Judge of the Superior Court reviews the reports to ensure they meet legal requirements, the reports are issued. The affected departments are required by law to respond to each finding and recommendation contained in the reports.
- The Board of Supervisors holds a public hearing on each report. The Civil Grand Jury presents the report, and each affected department responds. The Board of Supervisors then issues its own response.

When?

- The entire Civil Grand Jury meets once per week, generally in the late afternoon. Subcommittees meet
 as needed. Most of the Jury's work takes place during regular business hours.
- Jurors must be able to serve the entire term, from July 1 through June 30. Jurors must be able to commit time consistently throughout the term.

Who is Eligible?

 In order to volunteer to be considered for the Civil Grand Jury, you must be a United States citizen; at least 18 years of age; have lived in San Francisco for at least the past one year; have no felony convictions; and have the ability to communicate in English.

How do I Apply?


- Applications may be downloaded from http://civilgrandjury.sfgov.org/join.html, or you may pick one up at San Francisco Superior Court, 400 McAllister Street, Room 007. The application deadline is on May 17, 2019.
- The most qualified applicants will be invited to attend a mandatory informational session on May 21 or May 30, 2019.
- Selection by a panel of Superior Court Judges will be held on June 7, 2019.
- The 2019 2020 Civil Grand Jury will be trained on June 10, 17, 18, and 24, 2019.
- The 2019 2020 Civil Grand Jury takes office on July 1, 2019.

San Francisco Police Arrest Homicide Suspect

On Monday October 15th, 2018 at approximately 6:36 PM, San Francisco Police officers responded to a report of a person down at the 5100 block of 3rd Street. Upon arrival, officers located 21 year-old Lionel Clark, who had been shot and was critically injured. Mr. Clark was transported to the hospital where he succumbed to his injuries.

Homicide investigators commenced an investigation into the death of Mr. Clark and on Sunday January 27th, SFPD served search warrants in connection to the investigation. Based on information received, 21 year-old San Francisco resident, Joshua Robinson was arrested and charged in the murder of Lionel Clark. Robinson was already in custody in the San Francisco County Jail at the time of his arrest on unrelated charges.

Due to pending identification matters, Robinson's booking photo is not being released at this time.

San Francisco Police Make Arrest in Mission Robbery

On January 13, 2019 at approximately 5:35PM, San Francisco Police officers from Mission Station responded to 24th Street and Mission Street regarding a robbery. When officers arrived at the scene, they determined that the suspect had stolen a purse belonging to the victim, an 84 year-old San Francisco resident who had been in a fast food restaurant. When the victim attempted to retrieve her purse, the suspect engaged in a "tug of war", with the victim, dragging her from the restaurant to the sidewalk. The suspect continued to pull on the purse, lifting her off the ground. The victim lost her grip and fell to the cement sidewalk

The suspect then fled across Mission Street and boarded a stopped Muni bus. Several witnesses and bystanders boarded the bus and detained the suspect until police arrived. The victim's purse was recovered at that time. The victim told officers that she was not injured and refused medical attention.

The suspect, 43 year-old Oakland resident Anthony Terrell Sims was arrested and later booked into San Francisco County Jail for robbery, elder abuse, violation of the terms of his probation and for threatening an executive officer. Sims is on probation for a prior burglary conviction. The charge of threatening an executive officer stems from threats Sims made to kill one of the arresting officers in this case.

The San Francisco Police Department appreciates the assistance of the community members who saw the victim in distress and took action to detain the suspect. Their action prevented a violent suspect from escaping. While an arrest has been made, this remains and open investigation. DMV Reminds Motorists of New 2019 Laws

Sacramento – With the New Year just around the corner, the California Department of Motor Vehicles (DMV) wants to inform the public about several new laws or changes to existing law that, unless otherwise noted, take effect January 1, 2019.

Temporary License Plate Program (<u>AB 516, Mullin</u>): This law requires licensed California dealers, of new and used vehicles to attach temporary paper license plates on a vehicle at the point of sale if that vehicle does not display license plates previously issued by the DMV. The temporary license plates contain a unique number and expiration date. No vehicle can be driven off the dealership lot without the temporary license plate affixed to it unless it already has issued plates. The intent of this new law is to reduce the number of toll violators and improve safety for law enforcement.

Gender Identity Female, Male, or Nonbinary (<u>SB 179, Atkins</u>): This law allows individuals applying for a California driver license or identification card to self-certify their chosen gender category of male, female or nonbinary in the application. Applicants who select nonbinary will receive a card with an "X" in the gender category.

Driving Under the Influence – Ignition Interlock Device (SB 1046, Hill): From January 1, 2019 to January 1, 2026, this law mandates repeat offenders for driving under the influence (DUI) and first DUI offenders whose violations resulted in injury, to install an ignition interlock device (IID) for a period ranging from 12 to 48 months. This law also allows those who receive a suspension under the Administrative Per Se law to obtain an IID-restricted driving privilege, and receive credit toward their required IID restriction period if they are later convicted of a DUI. These provisions apply to DUI violations that involve alcohol or the combined use of alcohol and drugs. They do not apply to drug-only violations. Additionally, courts have the discretion to order a non-injury first DUI offender to install an IID for a period of up to 6 months. If the court does not order IID installation, a non-injury first offender may apply for a driver license for IID restrictions or restrictions that allow them to drive to, from, and during their employment and to and from a DUI treatment program for 12 months. Previously, an IID pilot program was only in effect in Alameda, Los Angeles, Sacramento and Tulare counties.

Smog Check Changes and New Abatement Fees (<u>AB 1274, O'Donnell</u>): This law expands the existing smog check exemption to vehicles that are up to eight model years old, up from the current exemption of six model years. During the additional two years of exemption, these vehicles will pay an annual S25 smog abatement fee. The current annual S20 smog abatement fee for the first six years of exemption remains unchanged.

Driving Privilege for Minors (<u>AB 2685, Lackev</u>): This law repeals a juvenile court's authority to suspend, restrict or delay the issuance of a driver license of a habitual truant or ward of the state for up to one year. The law clarifies that any suspensions or delays reported prior to January 1, 2019, remain in effect.

Motorized Scooters, (<u>AB 2989, Flora</u>): Bicycle helmets are no longer required for riders of motorized scooters who are age 18 or older. It also amends existing law to prohibit a person from operating a motorized scooter on a highway with a speed limit greater than 25 miles per hour, unless it is within a <u>Class IV bikeway as well as a</u> <u>Class II bikeway</u>. However, it permits local authorities to authorize the operation of motorized scooters on roads with speed limits up to 35 miles per hour outside of a Class II or Class IV bikeway.

Unsafe, unsecured loads on vehicles (<u>AB 1925, Choi</u>): This law requires the DMV to include at least one question addressing laws pertaining to driving with an unsafe, unsecured load in at least 20 percent of the knowledge tests administered to driver license applicants. Unsecured loads, such as ladders, buckets and loose items in the back of pickup trucks, can be dangerous for motorists when they fall onto the road. Therefore, all vehicle loads must be covered or secured.

Green and White Clean Air Vehicle Valid Until January 1, 2019

High-Occupancy Vehicle Lanes (AB 544, Bloom): As previously announced, AB 544 created a new program to grant low-emission vehicles and transitional zero-emission vehicles access to high-occupancy vehicle (HOV) lanes for an approximate four-year period, regardless of the vehicle occupancy level. A green or white decal is valid until January 1, 2019 and vehicles displaying these decals no longer have access to HOV lanes. Vehicles that were issued a green or white decal between January 1, 2017 and March 1, 2018 are eligible to apply for a red decal that grants them access to HOV lanes until January 1, 2022. The DMV notified these customers of their eligibility by mail. The DMV will issue light purple decals in 2019 that will grant access to HOV lanes until January 1, 2023. Decals are available to applicants who have not applied for or received a consumer rebate pursuant to the Clean Vehicle Rebate Project, unless they meet annual income requirements.
