Hello all, code I want to talk about the  
 SF311 app is used to report quality of life issues such as graffiti, blocked sidewalks and potholes. I recently attended a community meeting in my district where members were singing the praises of the SF311 app. I thought it would be a good idea to share this information with all of you as I know there are times that calling 311 can be a test of patience. With the SF311 app you text your concern with a photo and you will receive a text when the issue is addressed. Not only does that sound pain free but in addition the community members reported they were very happy with the response time. Let me finish by reminding you all this is not the number to call if you are observing a life threatening situation or crime in progress it is only for non-emergency situations. Review attached flyer on page 3

I want to again emphasize the importance of locking up your bikes even if in your garage or on your deck. We are still seeing an uptick in this type of theft in our district. Please consider installing a tracker on your bike.

I want to share with you a community members experience of being a victim of a crime. The victim was a **victim of a burglary**. Here are all the things this victim and her cousin did right.

#1 The home had an app (part of the NEST program) which notifies her when someone opens her door.

#2 The home had a surveillance camera that provided video footage of the suspect entering her home and exiting with her items.

**CAPTAIN BAILEY'S MESSAGE CONTINUED**

#3 One of the items taken had a tracker which allowed her to track the device to a tent in the Mission at which time she called the police. The victim assured me she would never have approached the suspect/s and that is why she immediately called the police.

#4 Police responded and made the arrest of the individual who was in possession of the stolen property and was on probation for yes you guessed, burglary. All the victim's property was recovered.

What a great end to an invasion of her home. This victim's success was based on all the steps she and her cousin had taken to keep their home secure and safe and even though the culprit had made entry into her home her proactive steps allowed us to make an arrest.

Takeaway lesson- get your surveillance camera, your app that notifies you of someone entering your home and put a tracker on any device that is of value.

Be safe and do everything you can to prevent being a victim but if you are a victim take all the precautions that will allow us to take these predators into custody.



**THANK YOU***A JOB WELL DONE*

On February 10, 2019 at approximately 6:00 PM Officers responded to Fulton and Masonic and a report of a stolen laptop. The first Officers arrived on scene and met with the victim and a witness. Officer Villaarin and Officer Salazar gave a detailed description over their police radios of the suspects and the laptop that was stolen.

The following Sergeants and Officers responded to the area to search for the suspects and stolen laptop: Sgt. O'Malley, Sgt. Friedman, Sgt. Salazar, Ofc. Aguirre, Ofc. Riechsteiner, Ofc. Cheng, Ofc. Asare, Ofc. Lewis, Ofc. Coronado, Ofc. Prescott, Ofc. Murphy, and Ofc. Street. A short time later one of the suspects was seen hiding between two vehicles, this suspect was detained. The victim and witness could not positively identify the suspect as the person who stole the laptop, so he was released.

The above Sergeants and Officers continued to search the area for the others suspects and stolen laptop. Unfortunately they were not located, but the laptop was found in the area where the suspect was hiding and it was returned to the victim. This investigation took a total team effort. The victim was very appreciative of the all the work the Sergeants and Officers did to get her laptop back and sent the following thank you note.

Officer Cheng was born and raised in San Francisco. He has also attended public schools from kindergarten to high school in the San Francisco Unified School District, starting off with Jefferson Elementary, Herbert Hoover Middle School and Abraham Lincoln High School. After graduating from Lincoln, Officer Cheng attended San Francisco State University, where he earned a B.A. degree in Economics with a minor in Hospitality Management.

Officer Cheng wanted to contribute back to the city he was born and raised in and loved so dearly, he decided to apply to become a San Francisco Police Officer and was recruited to attend the Police Academy in 2008. Officer Cheng did his Field Training in Tenderloin Station, passed and began his one year probation in the Bayview District, where he passed and remained for another three more years. Officer Cheng ultimately transferred to Park District, where he has stayed since. During his career, Officer Cheng has been assigned to Patrol, Plainclothes Unit, Captain's Staff and now Park Station CPT. He has continued to enjoy serving the public, protecting and ensuring the safety of the community.



**SOME OF PARK STATION'S ARRESTS FOR THE WEEK****Hallucinogenic, Possession for Sale, Haight and Ashbury Charges: NW11378HS**

On February 25, 2019 Park units coordinated a Buy-Bust Operation targeting the Haight Street corridor. At Haight/Ashbury, the suspect, later identified as Goodrich offered to sell some illegal LSD drugs to our undercover plainclothes officer. The transaction was completed by giving Goodrich the Marked Currency Funds which was later used as evidence. The arrest team arrived and arrested the subject. Goodrich failed to show up for his court date. On March 20, 2019 Goodrich was seen and recognized by Park units who were familiar with a narcotic warrant for his arrest. Upon the detention, officers confirmed the warrant and Goodrich was arrested for his \$20,000 warrant. He was transported to County Jail.

**Assault, Aggravated, W/ Force, Warrant Arrest, Enroute To Outside Jurisdiction/ Area of Haight St. - 03/18/19 19:14**

Officers were dispatched to the area of Haight Street regarding a fight in the middle of the street. Dispatch informed the officers that there were approximately 5-10 subjects in a physical altercation with one male victim. When officers arrived at the scene the victim had a head injury. The victim stated that he was attacked by multiple assailants and that some of them were still in the area. Officers requested an ambulance at the scene to treat the victim's injuries. The victim was able to identify the assailants that were still on scene. The two men were placed under arrest for aggravated assault, and were transported to County Jail. Later in the week an additional suspect was identified by surveillance video and he was also arrested.

**Driving While Under the Influence of Alcohol/ Area of Stanyan St. -03/19/19 18:15**

Officers were dispatched to the area of Stanyan Street regarding a call of a possible drunk driver. Witnesses informed the officers that the driver of the vehicle was swerving across lanes of traffic almost causing multiple collisions. Officers observed the driver laying on the ground near his vehicle, he had bloodshot, and watery eyes. He had moderate odor of an alcoholic beverage on his breath, his speech was slow and repeated; and when attempted to stand up he was unsteady on his feet. The driver was arrested for driving under the influence of alcohol and transported to County Jail.

**Civil Sidewalks, Citation, Methamphetamine Offense/ Area of Haight St. -03/20/19 15:45**

While on patrol officers observed a male, sitting on the ground in the area of Haight Street in violation of the sit/lie ordinance. Officers made contact with the subject and informed him about the violation. The records check further revealed that the subject was on probation. Officers conducted a search of the subject, officers were able to locate multiple syringes, exposed razor blades and a small plastic baggie containing a white crystalline substance, suspected methamphetamine. Subject was issued a citation.

**Burglary, Residence, Unlawful Entry; Probation Vio; Possession of Stolen Property , Unit block of Sanchez St. Charges: NW459PC, NW496aPC, 1203.2aPC**

On March 22, 2019, a victim returned home, and noticed her property was missing. She examined the security camera and observed the suspect, later identified as Kjelson as the person who entered into her bedroom. Police were called and conducted their preliminary investigation. The victim activated and tracked her stolen tablet to a location at 15<sup>th</sup> St/Market. Police units arrived, pin-pointed the stolen tablet to a tent that was occupied by Kjelson. The Officers conducted a probation search, and recovered the victim's property. Kjelson was booked on the above listed charges and transported to County Jail.

### Safe Driving in Rainy Conditions

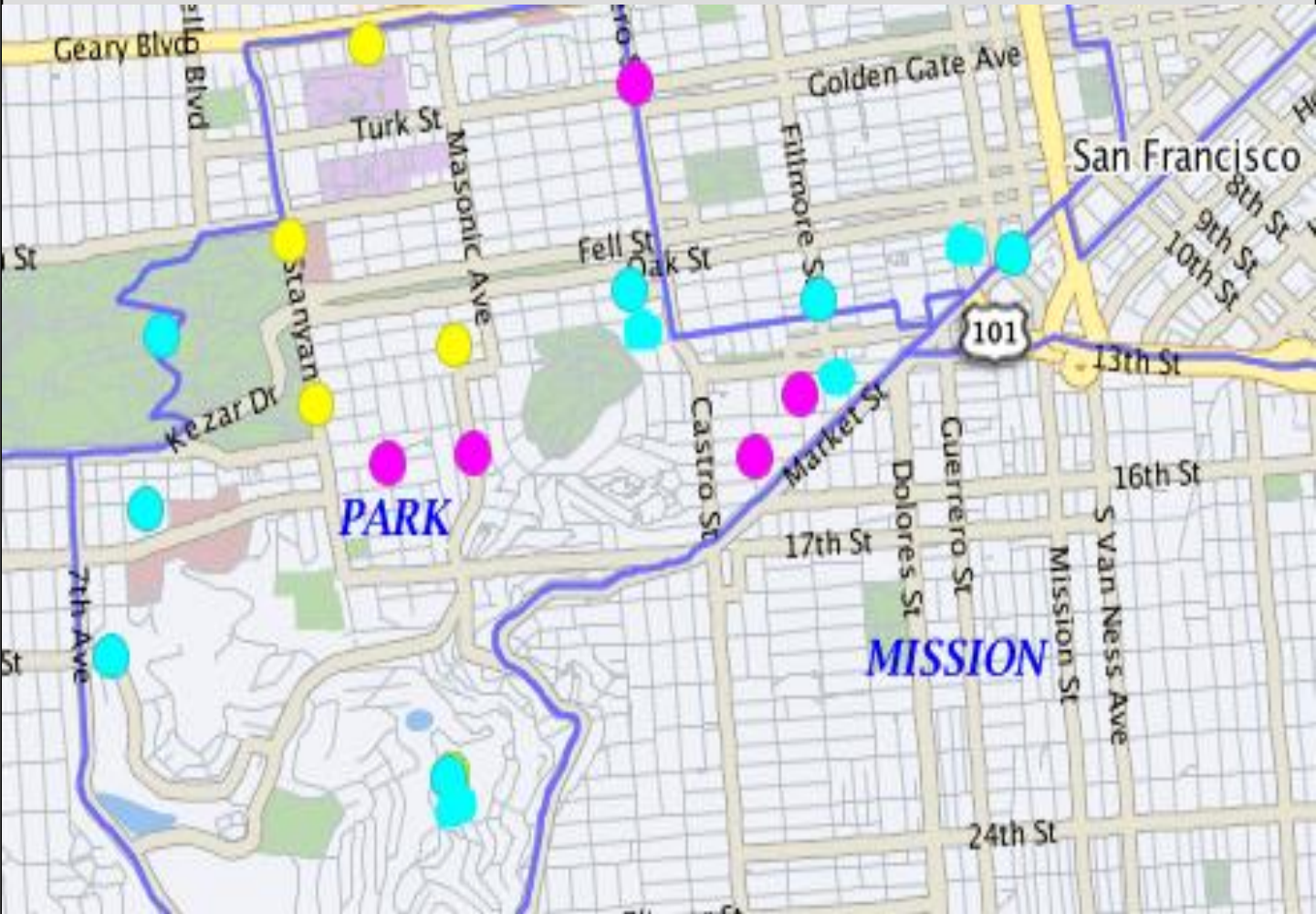
We want everyone to get to their destination safely. Here are some suggestions to help you arrive safe.

- \*Leave a few minutes early to give yourself extra time to get where you need to go.
- \*Defog/De-ice your windows before you start driving.
- \*Be on the **lookout for pedestrians** especially around schools.
- \*Lookout for cyclists, many cyclists still ride their bike when it's raining.
- \*Lookout for road hazards such as deep puddles and debris.
- \*Use your brakes earlier to avoid skidding and hydroplaning.
- \*Stay away from flooded areas and downed power lines, whether in a car or on foot.
- \***Remember if your wipers are on, your headlights are on.**

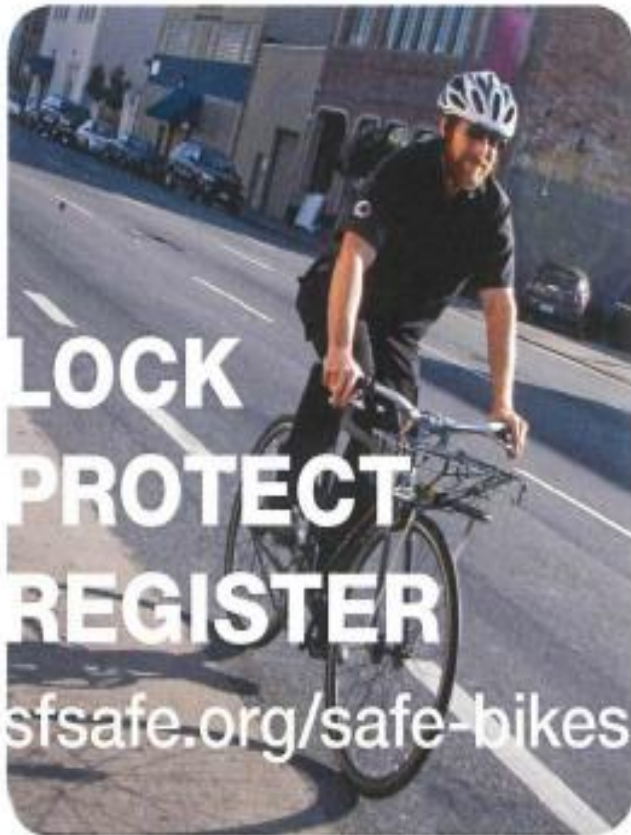

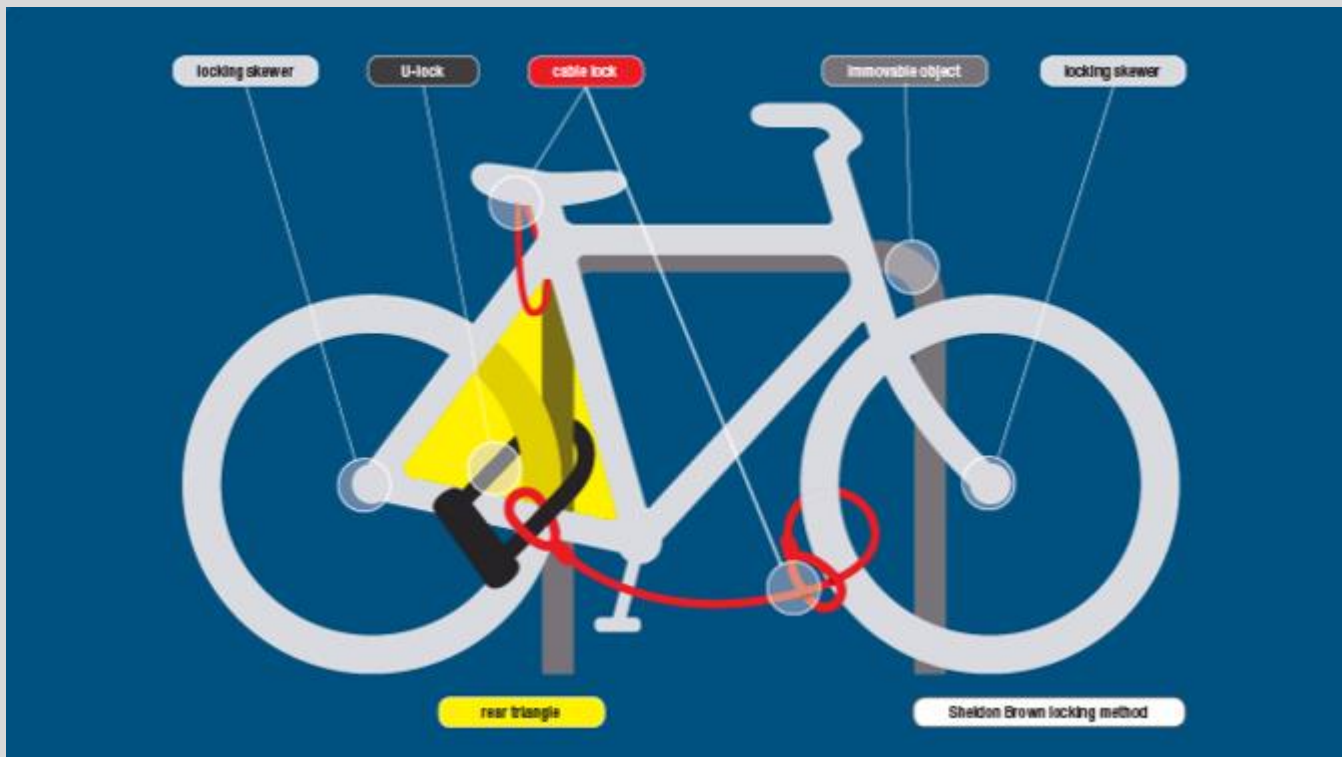

SAFE BIKES and the SFPD recommend the Sheldon Brown Locking Method.

No locking method is 100% foolproof, but this method is highly effective.

### GUIDE FOR LOCKING YOUR BIKE:

- Use the smallest U-lock that works for your bike to minimize the amount of space available for a thief to insert a jack or levers.
- Use a hardened steel U-Lock to secure back wheel inside the rear triangle of the bicycle frame.
- Check to make sure U-lock is secured to an immovable metal object.
- Secure front wheel with cable or second U-lock. Loop cable around the down tube of the bicycle or secure second U-lock to front wheel and down tube.
- Replace quick release skewers and nutted wheels with keyed locking skewers and nuts to ensure wheels and saddles are locked to the bike frame at all times.
- Check with local bike shop for proper installation of locking skewers and advice.

## YOU JUST BOUGHT A NEW BICYCLE— NOW WHAT?

### FOLLOW THESE STEPS:

- Register** and upload receipt and photos of your bicycle at [sfsafe.org/safe-bikes](https://sfsafe.org/safe-bikes).
- Buy a hardened steel U-lock and a secondary lock** such as a chain or cable (See locking tools list).
- Replace quick release skewers and nutted wheels with uniquely keyed locking skewers and nuts**, which keep wheels and saddles locked to the bike frame at all times.
- Lock** your bicycle in your garage the same way you would on the street.
- Take an urban bicycling workshop** with the San Francisco Bicycle Coalition to learn safe riding practices. Go to [sfbike.org](https://sfbike.org) for more information.
- Speak with your local bicycle shop** for more help and advice.



### TOOLS TO LOCK YOUR BICYCLE

There are many different types of locks for bicycles and many incorrect ways of using them. No locking method is 100% effective.

**For best security use a hardened steel U-lock, chain and locking skewers.**

### PREVENTING BICYCLE THEFT IN GARAGES

Garages and multi-unit apartment buildings with common garage are one of the most vulnerable places for bicycles. Thieves are waiting for the perfect opportunity.

**Secure your bicycle in the garage the same way you would on the street!**

- Secure to an immovable object or an anchor system.
- Never lock your bike near a window or door.
- Always watch your garage door and make sure it closes completely so unwanted visitors do not enter.

- If bicycle is found, contact the SFPD investigator. **DO NOT** arrange a meeting and attempt to get your bicycle back.

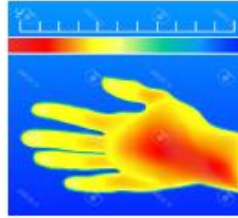

**HIGH RESOLUTION**

If you connect your camera to a DVR or other device, it will also need to be HD Compatible.



**INFRARED (IR)**

Built-in IR cut-switch that automatically enables/disables the infrared depending on the light conditions.

**IN THE KNOW**







The camera's viewing angle determines how much space the camera will cover. Wider angled lenses help cut down the # of cameras required for overall coverage. Video Surveillance should be utilized at your property with at least one camera facing towards the address street and camera should be registered with the District Attorney's office

Overview

**Note:** The following information is specific to commercial and retail establishments; however, can be applied to any location utilizing video surveillance.

Basic set up and maintenance problems can reduce the effectiveness of many systems.

- Resolution – is it good enough for facial recognition.
- Camera position – are they positioned for clear view of suspect.
- Lighting – is it adequate to capture clear images both day and night.
- Image detail – is the recorder set up for best image detail.
- Maintenance – are you maintaining your system properly so it can do its job when needed?

Set Up and Maintenance

- **Backlighting** – when sun is bright at doorway, images in front appear darker or even black. Use another light source inside to counteract back light.
- **Low Frame Rate** – saves on drive space and gives better image quality, but you may not get an image at all (now you see him; now you don't).
- **Obstructions** – displays and other objects blocking view **should be eliminated.**
- **Focus Problems** – must check system regularly to prevent.

Minimum camera resolution should be **480 horizontal lines.**

Good cameras have **faster lenses** (allows more lighting), larger maximum **aperture** opening (lets more light into the focal point of the camera) and controls image brightness (allows brighter images in dim lighting) – the more lighting, the more depth of field (greater depth of field; the more of the scene is in focus).

**Focal Length** – some cameras zoom in and out while others have a fixed focal length. The type of cameras used depends on what your needs are.

**Transaction Areas** – anything at a transaction point (cash register, toll booth, etc.), the subject's head should fill at least 15% of the total image in the frame, giving the detail you need.

**Lines of Sight** – lines of sight are always critical, make sure there are no obstructions.

**Site Plan** – the right site plan is crucial (retail store blueprint or **diagram**). Key camera spots are at transaction points (cash registers and entry/exit points) – the more cameras, the better.

You want good camera **overlap** (you want multiple chances to capture good images). Extra coverage is also needed for aisles, restrooms and other key points.

**Camera Height** – placement is very important, make sure it is as close to eye-level as possible. Otherwise, you might lose out to a baseball cap.

With a good site plan you can make sure you don't have any blind spots (you can toy around with camera positions, and do a test recording to see that you are getting what you want).

**Interior Lighting** – interior lighting can balance bright light from one direction (back lighting) by adding another light source from a different location (add a bank of lights).

Example: Artificial lighting (**inside store**) for cameras may be good in the morning, but by noon, the sun (through a doorway or window) can blow the entire frame out (add lighting to fill in for afternoon sunlight). Adding more light from a different direction balances lighting, giving better camera clarity (if sunlight is shining through large windows you can tent windows or add screens.

**Exterior Lighting** – if lights are on timers, you must adjust appropriate to seasonal changes (Fall/Winter: gets dark earlier. Spring/Summer: gets dark later).

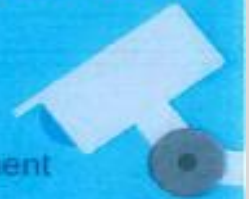

Burglary Awareness & Prevention Tips for Construction Sites



**Securing & Preventing**

1. Secure all equipment and vehicles at all times.
2. Take effort to reduce the visibility of tools and equipment secured in vehicles or on job sites.
3. Make use of adequate lighting in conjunction with open chain-link fencing on the perimeter to allow for high visibility to the job site.
4. Strongly consider the use of security systems such as alarms and video surveillance. Ensure signage for such is clearly visible.

**Precautionary Measures**

1. Photograph all tools. Ensure photographs clearly show the associated serial number and/or distinctive markings.
2. Ensure job site keys are marked "Do Not Duplicate" and are controlled at all times.
3. Attempt to park employee vehicles within visual range of the job site.

**Should a Burglary Occur**

Immediately contact 911. Be prepared to provide the following information:

- a) Time of incident.
- b) Video (if available).
- c) Items taken (include make, model, description, location taken from, value, photos and serial numbers).
- d) Insurance information.
- e) Owner's information.

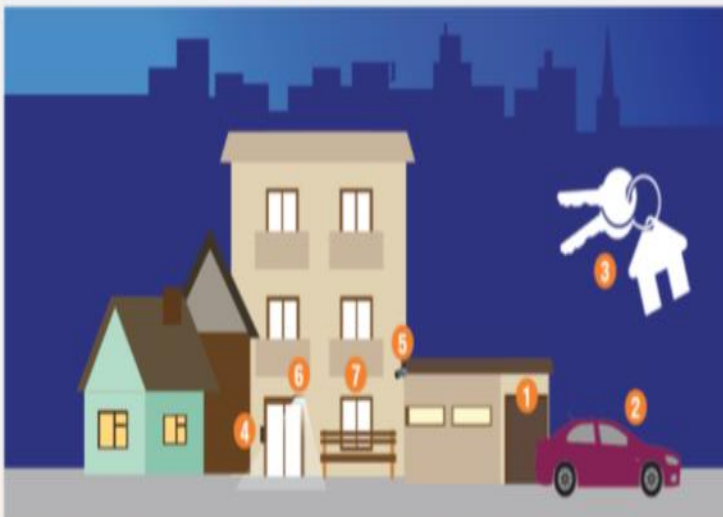






Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.

7 Residential Safety Tips



- 1 **Garage:** When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- 2 **Car:** Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- 3 **Spare Key:** Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- 4 **Door Buzzer:** When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- 5 **Security Cameras & Alarm Systems:** Cost effective tools for preventing crime and identifying criminals.
- 6 **Light Timers:** Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- 7 **Doors/Windows:** Always keep doors and windows locked.

Door and Window Safety

Doors:

- Should be made of solid wood or metal
- Have a single cylinder deadbolt lock and a 1-inch bolt
- Have a front door viewer or peep hole with a 180-degree range
- Clearly display unit number

Windows:

- Replace if glass is cracked and replace all damaged or missing locks
- Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

Keep property in good repair. Maintain visibility to your neighbors for increased safety.

## WHO AND WHEN TO CALL?

**3-1-1:** Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

**SF 3-1-1 APP** is available to use on your mobile device. Download the APP and its easy to use for many Non-emergency.



**Non- Emergency San Francisco Dispatch Line:** Please call the non- emergency dispatch line (**415-553-0123**) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, suspicious activities, or a homeless/nuisance related issue. **The non-emergency line is for situations that require the police, but do not require an immediate police response.**

**9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency.** The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1.**
