Hello all

As you all know 420 is fast approaching. This event will be held in a fenced area of Robin Williams Meadow area this Saturday 4/20/19.

Many agencies within the city are working hard to prepare for this event, ensuring the safety of all and making every effort to mitigate the impact on the surrounding neighborhoods.

Typically the event opens at 10:00am and we are anticipating upwards of 15,000 attendees. The smoke out happens at 420pm and then shortly after that attendees exit the event. There will be buses available at the Kezar Drive exit to transport attendees out of the area to downtown. Typically many people make their way down Haight St. To accommodate the entry and exit from the event we close Kezar drive to vehicular traffic and redirect traffic. We anticipate this will happen approximately 3pm and reopen by 6pm. This prediction is based on last year's event. Of course, if possible, we will make this time frame as short as possible but it will be based on what is safest for all involved. We will also be closing streets in the Haight Street area but of course residents will be allowed entrance with proof of residency.

In the following Newsletter pages there is information regarding street closures with suggested alternate routes and a station phone hot line that will be operational on the day 4/20 from 11am to 6pm. This hotline will allow residents to call in with issues they are seeing or experiencing that require non-emergency response. If it is an emergency situation call 911

We have also included information regarding how to check muni re-routes.

**CAPTAIN BAILEY'S MESSAGE CONTINUED**

One note of caution if you are attending the event please ensure you are buying your marijuana from a legal vendor. There will be no legal sale of marijuana in the event. Buying marijuana on the street and not from a legal vendor exposes you to marijuana that may be laced with other drugs. Last year we had numerous attendees pass out from using marijuana laced with fentanyl. Fentanyl is one of the strongest opiate drugs on the market being 50 to 100 times stronger than morphine. A tiny bit too much can be fatal. When dealing with a fentanyl overdose the first responder treating the individual is also at risk as the fentanyl can be absorbed through the skin. It is crucial that the first responders and anyone coming in contact with individual exposed wear gloves and carry an antidote for Fentanyl/opioid which they can administer at the scene prior to the individual being transported to the hospital. If you encounter an individual passed out on the street please call 911 and avoid making direct contact with the individual.

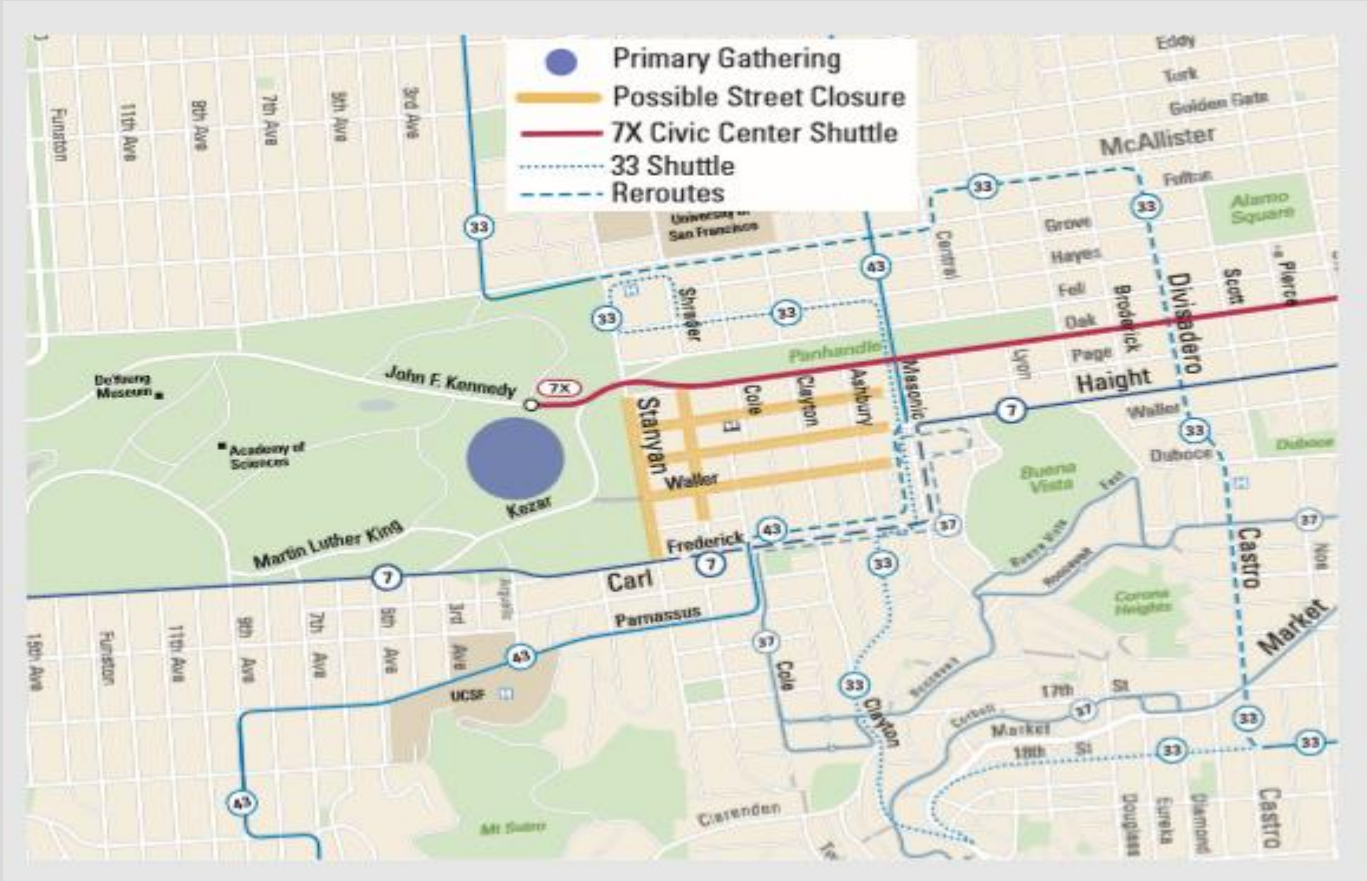

## FENTANYL INFORMATION

# FENTANYL

If you believe someone has been exposed to Fentanyl call **911** immediately.

- ◆ Fentanyl can be in a variety of forms ( e.g., powder, tablets, capsules, solutions, and rocks)
- ◆ Inhalation of airborne powder is most likely to lead to harmful effects , but less likely to contact than skin contact.
- ◆ Personal Protective Equipment is effective in protection you from exposure (e.g., gloves and mask)
- ◆ Slow breathing or no breathing, drowsiness or unresponsiveness, and constricted or pinpoint pupils are the specific signs consistent with fentanyl intoxication.
- ◆ Naloxone is an effective medication that rapidly reverse the effects of fentanyl.

On February 10, 2019 at approximately 6:00 PM Officers responded to Fulton and Masonic and a report of a stolen laptop. The first Officers arrived on scene and met with the victim and a witness. Officer Villaarin and Officer Salazar gave a detailed description over their police radios of the suspects and the laptop that was stolen.

The following Sergeants and Officers responded to the area to search for the suspects and stolen laptop: Sgt. O'Malley, Sgt. Friedman, Sgt. Salazar, Ofc. Aguirre, Ofc. Riechsteiner, Ofc. Cheng, Ofc. Asare, Ofc. Lewis, Ofc. Coronado, Ofc. Prescott, Ofc. Murphy, and Ofc. Street. A short time later one of the suspects was seen hiding between two vehicles, this suspect was detained. The victim and witness could not positively identify the suspect as the person who stole the laptop, so he was released.

The above Sergeants and Officers continued to search the area for the others suspects and stolen laptop. Unfortunately they were not located, but the laptop was found in the area where the suspect was hiding and it was returned to the victim. This investigation took a total team effort. **CITIZEN OF THE MONTH****Captain Bailey has named Marylou Para and her cousin Olivia Para Citizens Of The Month for the month of April**

This month I am nominating Marylou Para and Oliva Para as our citizens of the month. Although their home was a victim of a burglary Marylou and Olivia had taken several steps that allowed us the SFPD to successfully arrest the perpetrator in their case.

- #1 The home has an app (part of the NEST program) which notifies them when someone opens their door.
- #2 The home has a surveillance camera that provided video footage of the suspect entering their home and exiting with the stolen items
- #3 One of the stolen items taken was a device that had a tracker which allowed them to track the device to a tent in the Mission.
- #4 At this time they smartly called the police. Marylou assured me she would never have approached the suspect/s and that is why she immediately called the police.
- #5 Police responded and made the arrest of the individual who was in possession of the stolen property. This individual was on probation for burglary. All the victim's property was recovered.

What a great end to an invasion of their home. This victim's success was based on all the steps she and her cousin had taken to keep their home secure and safe and even though the culprit had made entry into her home her proactive steps allowed us to make an arrest.

Thank you Marylou and Olivia, congratulations.

Takeaway lesson- get your surveillance camera, your app that notifies you of someone entering your home and put a tracker on any device that is of value.

Be safe and do everything you can to prevent being a victim but if you are take all the precautions that will allow us to take these predators into custody.

# DISTRACTED DRIVING



## Distracted Driving

Distracted driving is anything that takes your eyes or mind off the road. In the smartphone age, distracted driving is the most dangerous when drivers are using their cell phone behind the wheel.

Whether it is talking, emailing, texting, plugging in directions, using an app or scrolling through social media feeds, using a cell phone is not only dangerous, but also illegal.

In 2017, 3,166 people were killed in distracted driving related crashes across the country, or nearly 10 percent of all traffic deaths.

Using a phone to dial, talk or text triples the risk of a driver getting into a crash. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for an average of 5 seconds. At 55 mph, that's like driving the length of a football field with your eyes closed.

Other serious driver distractions such as eating, grooming, reaching for objects on the floor, changing clothes or talking with passengers are just as dangerous. The safest thing drivers can do is put down the phone, focus on the road and just drive.





### Distracted Driving Prevention

- ✓ Never Text and Drive
- ✓ Silence your phone before you drive
- ✓ Pull over to safe parking spot to make a call
- ✓ Don't text or call someone you know is driving



## Cell Phone Law

-  Holding a phone while driving is illegal. Any electronic device must be used in a hands-free manner, such as speaker or voice commands. The law applies when at a stop sign or signal.
-  To use a phone while driving, it must be mounted on the dashboard, windshield (seven-inch square in lower right corner or five-inch square in lower left corner), or center console.
-  When the phone is mounted, drivers can swipe or tap the screen once to activate or deactivate a feature. It is illegal to swipe multiple times, enter information or text.
-  A first offense ticket is \$162, with additional offenses costing even more.
-  You may use your phone while holding it for true emergencies, like calling 911.

Not only is holding your phone while driving illegal in the State of California, distracted driving is now the number one cause of roadway crashes. Join us in being part of the solution. Grab the wheel with both hands, enjoy the drive and focus on each other. Here are some ways you can prevent driving distracted:

- > Silence your phone before you get behind the wheel and keep it mounted in a legally approved location.
- > Never text and drive or use apps or social media while driving.
- > Do not eat, drink or program your GPS/MP3 player or other devices while driving.
- > If a phone call is necessary or you need to reroute your map, pull over to use those devices.
- > If something falls to the floor, pull over to a safe parking spot before trying to reach it.

**SOME OF PARK STATION'S ARRESTS FOR THE WEEK****Robbery, Street or Public Place w/force. Weapon, carrying concealed, Animal Cruelty, Aggravated Assault, Haight and Masonic - 4/8/19 1041 Hours.**

A Park Station sergeant was driving on Haight St towards Masonic when he observed 6-8 people darting in and out of the street on Masonic. It appeared to the sergeant that some sort of fight had just taken place. As he drove closer to the intersection, he observed a male subject with a beard turn and start running away west bound on Haight St. The large group of people on the corner began pointing at the subject running away and yelling "that's him". As dispatch began to put out the call, the sergeant immediately began to chase the subject in his patrol car while updating dispatch of his actions. Shortly after, the sergeant caught the male subject with the beard and quickly learned that he was chasing after another male who was also present. The sergeant learned that the male subject was actually the victim of an apparent robbery of his cell phone. According to the victim, he witnessed some animal cruelty committed by one of the subjects. When he approached the subject to tell him to stop abusing the dog, an argument ensued, and he quickly became surrounded. The victim began to video the incident and call 911. Moments later, the victim was pushed, jabbed, struck, and had his beard pulled multiple times. At one point, his cell phone was knocked free from his hand and hit the ground. Fortunately, the victim was able to back away from the group and began chasing after an individual whom he believed took his cell phone. Numerous Park units arrived on scene to assist. They were eventually able to locate his missing cell phone, and with the help of the victim, identify and arrest several other individuals involved in the original incident. Nicole Ouweleen, Hagam Gorgas, Anthony Juatai, Allison Reed and Bianca Waldron, were arrested for above listed charges and transported to County Jail

**Assault, Aggravated, with force Malicious Mischief, Vandalism to vehicle, warrant arrest 300 block of Buena Vista East- 4/10/19 1105 Hours.**

Park Station Officers responded to the 300 block of Buena Vista Ave regarding a fight in progress. After separating and detaining both parties, they quickly discovered that one of the individuals involved in the fight; Morganti to have a outstanding warrant for his arrest. During their investigation, they learned that Morganti had approached the victim while the victim sat in his personal car. Morganti demanded water and beer from the victim, and started banging on the windows. Morganti eventually opened the unlocked passenger door and bent it backwards causing damage to the door. The victim got out of his car to tell Morganti to stop. Morganti then kicked and punched the victim to the ground. While on the ground Morganti continued to kick the victim multiple times all over his body. The victim was finally able to get away from Morganti before the police arrived. Morganti was booked accordingly for the above listed charges and transported to County Jail.

While patrolling the area of Haight St. Officers observed a subject sitting down on the sidewalk in violation of San Francisco's Sit-Lie Ordinance. Park Station officers observed an unconscious male covered in a blanket on top of a red moped parked legally on Steiner Street. The officer made contact with the individual and discovered that he had an outstanding \$35,000 narcotics warrant for his arrest. The subject was taken into custody. During the arrest search, a large dagger was found in the subject's front left pants pocket. He was booked for the above listed charges and transported to County Jail.

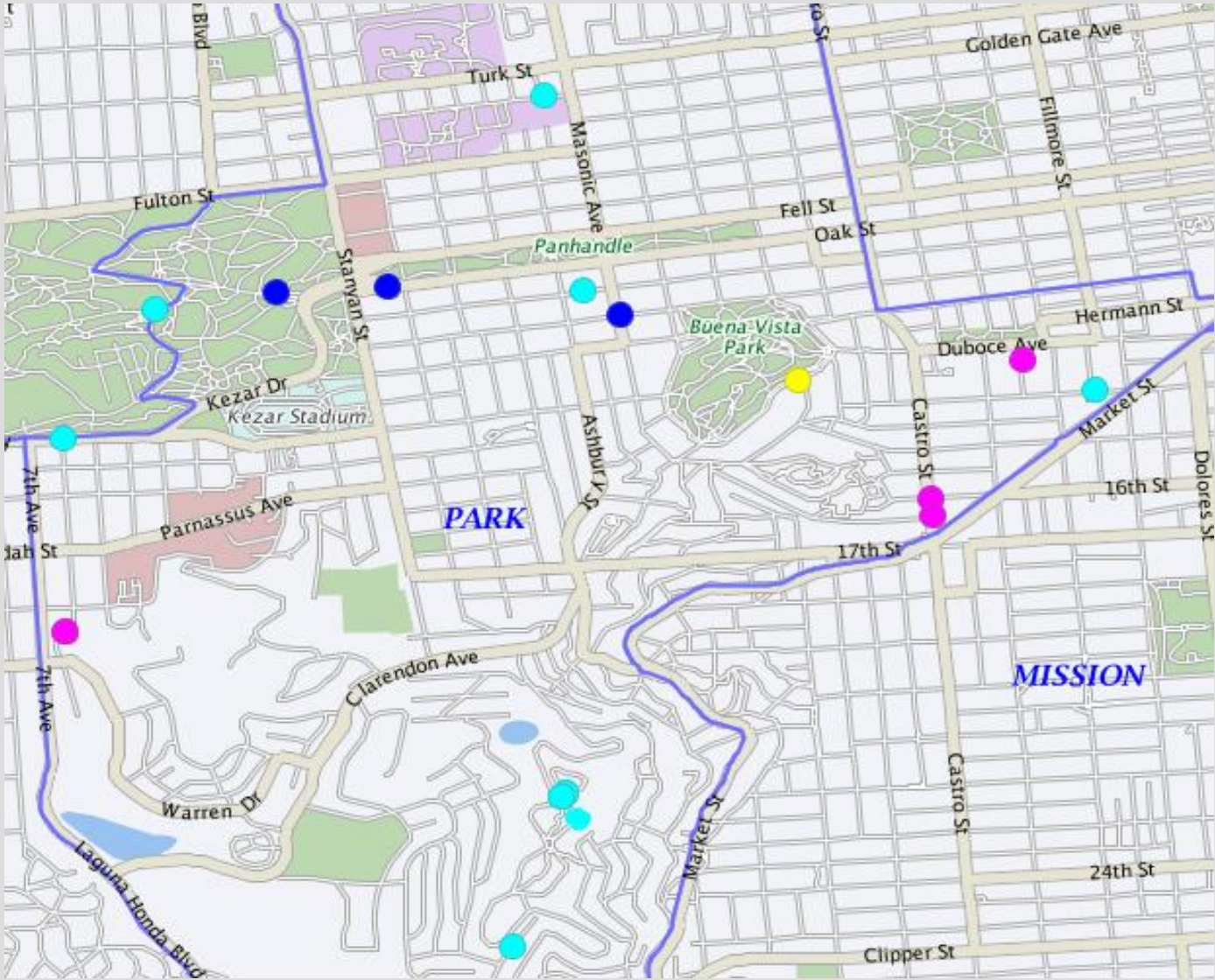
**Driving, No License Issued, Traffic Violation Arrest/ Area of Masonic Ave. -04/14/19 12:52 Hours.**

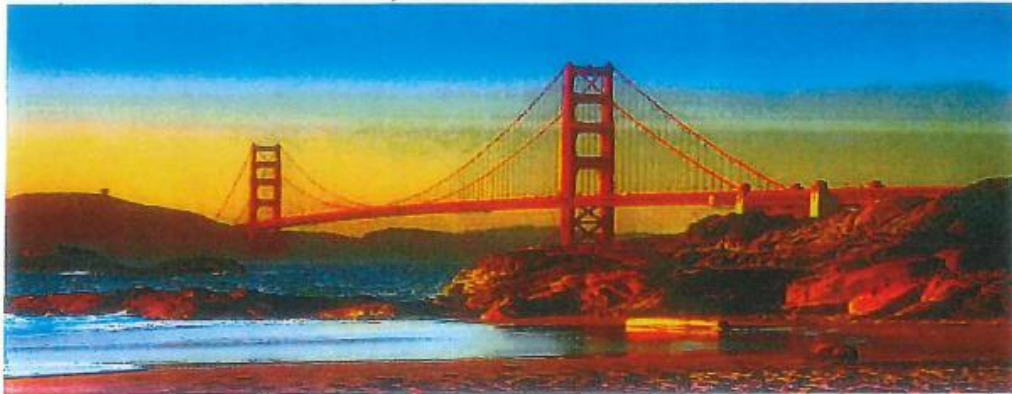

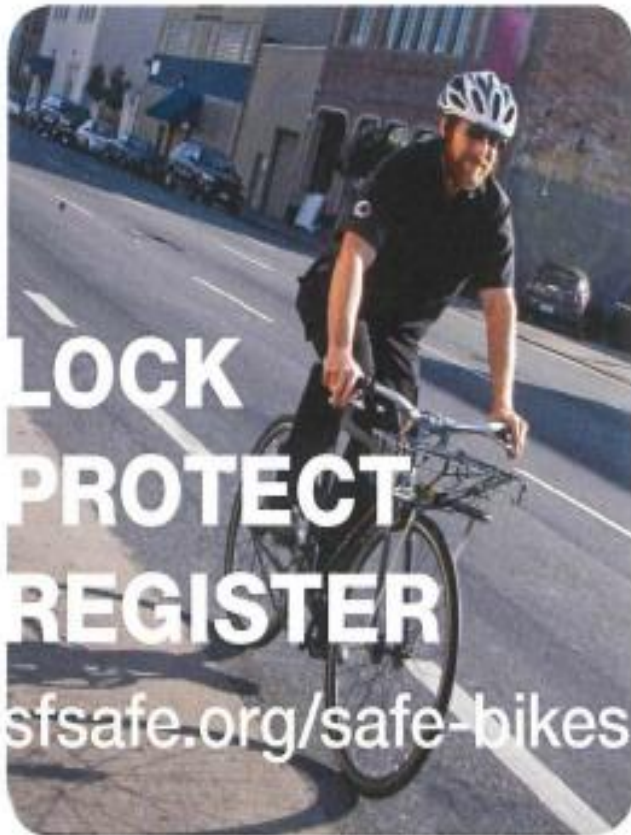

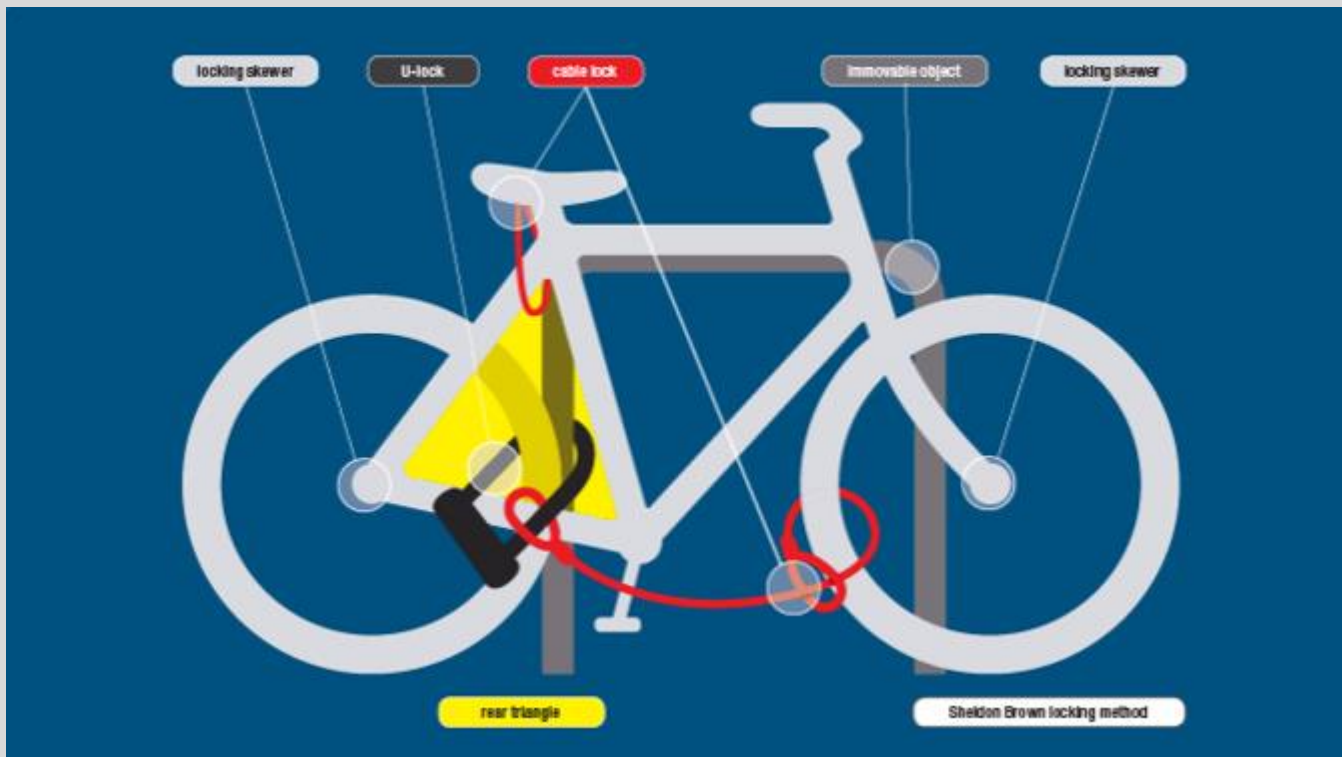

SAFE BIKES and the SFPD recommend the Sheldon Brown Locking Method.

No locking method is 100% foolproof, but this method is highly effective.

### GUIDE FOR LOCKING YOUR BIKE:

- Use the smallest U-lock that works for your bike to minimize the amount of space available for a thief to insert a jack or levers.
- Use a hardened steel U-Lock to secure back wheel inside the rear triangle of the bicycle frame.
- Check to make sure U-lock is secured to an immovable metal object.
- Secure front wheel with cable or second U-lock. Loop cable around the down tube of the bicycle or secure second U-lock to front wheel and down tube.
- Replace quick release skewers and nutted wheels with keyed locking skewers and nuts to ensure wheels and saddles are locked to the bike frame at all times.
- Check with local bike shop for proper installation of locking skewers and advice.

### PREVENTING BICYCLE THEFT IN GARAGES

Garages and multi-unit apartment buildings with common garage are one of the most vulnerable places for bicycles. Thieves are waiting for the perfect opportunity.

**Secure your bicycle in the garage the same way you would on the street!**

- Secure to an immovable object or an anchor system.
- Never lock your bike near a window or door.
- Always watch your garage door and make sure it closes completely so unwanted visitors do not enter.

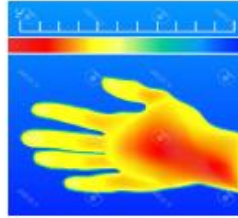

**HIGH RESOLUTION**

If you connect your camera to a DVR or other device, it will also need to be HD Compatible.



**INFRARED (IR)**

Built-in IR cut-switch that automatically enables/disables the infrared depending on the light conditions.

**IN THE KNOW**

The camera's viewing angle determines how much space the camera will cover. Wider angled lenses help cut down the # of cameras required for overall coverage. Video Surveillance should be utilized at your property with at least one camera facing towards the address street and camera should be registered with the District Attorney's office

Overview

**Note:** The following information is specific to commercial and retail establishments; however, can be applied to any location utilizing video surveillance.

Basic set up and maintenance problems can reduce the effectiveness of many systems.

- Resolution – is it good enough for facial recognition.
- Camera position – are they positioned for clear view of suspect.
- Lighting – is it adequate to capture clear images both day and night.
- Image detail – is the recorder set up for best image detail.
- Maintenance – are you maintaining your system properly so it can do its job when needed?

Set Up and Maintenance

- **Backlighting** – when sun is bright at doorway, images in front appear darker or even black. Use another light source inside to counteract back light.
- **Low Frame Rate** – saves on drive space and gives better image quality, but you may not get an image at all (now you see him; now you don't).
- **Obstructions** – displays and other objects blocking view **should be eliminated.**
- **Focus Problems** – must check system regularly to prevent.

Minimum camera resolution should be **480 horizontal lines.**

Good cameras have **faster lenses** (allows more lighting), larger maximum **aperture** opening (lets more light into the focal point of the camera) and controls image brightness (allows brighter images in dim lighting) – the more lighting, the more depth of field (greater depth of field; the more of the scene is in focus).

**Focal Length** – some cameras zoom in and out while others have a fixed focal length. The type of cameras used depends on what your needs are.

**Transaction Areas** – anything at a transaction point (cash register, toll booth, etc.), the subject's head should fill at least 15% of the total image in the frame, giving the detail you need.

**Lines of Sight** – lines of sight are always critical, make sure there are no obstructions.

**Site Plan** – the right site plan is crucial (retail store blueprint or **diagram**). Key camera spots are at transaction points (cash registers and entry/exit points) – the more cameras, the better.

You want good camera **overlap** (you want multiple chances to capture good images). Extra coverage is also needed for aisles, restrooms and other key points.

**Camera Height** – placement is very important, make sure it is as close to eye-level as possible. Otherwise, you might lose out to a baseball cap.

With a good site plan you can make sure you don't have any blind spots (you can toy around with camera positions, and do a test recording to see that you are getting what you want).

**Interior Lighting** – interior lighting can balance bright light from one direction (back lighting) by adding another light source from a different location (add a bank of lights).

Example: Artificial lighting (**inside store**) for cameras may be good in the morning, but by noon, the sun (through a doorway or window) can blow the entire frame out (add lighting to fill in for afternoon sunlight). Adding more light from a different direction balances lighting, giving better camera clarity (if sunlight is shining through large windows you can tent windows or add screens.

**Exterior Lighting** – if lights are on timers, you must adjust appropriate to seasonal changes (Fall/Winter: gets dark earlier. Spring/Summer: gets dark later).



**Securing & Preventing**

1. Secure all equipment and vehicles at all times.
2. Take effort to reduce the visibility of tools and equipment secured in vehicles or on job sites.
3. Make use of adequate lighting in conjunction with open chain-link fencing on the perimeter to allow for high visibility to the job site.
4. Strongly consider the use of security systems such as alarms and video surveillance. Ensure signage for such is clearly visible.

**Precautionary Measures**

1. Photograph all tools. Ensure photographs clearly show the associated serial number and/or distinctive markings.
2. Ensure job site keys are marked "Do Not Duplicate" and are controlled at all times.
3. Attempt to park employee vehicles within visual range of the job site.

**Should a Burglary Occur**

Immediately contact 911. Be prepared to provide the following information:

- a) Time of incident.
- b) Video (if available).
- c) Items taken (include make, model, description, location taken from, value, photos and serial numbers).
- d) Insurance information.
- e) Owner's information.

Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.

7 Residential Safety Tips



- 1 **Garage:** When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- 2 **Car:** Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- 3 **Spare Key:** Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- 4 **Door Buzzer:** When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- 5 **Security Cameras & Alarm Systems:** Cost effective tools for preventing crime and identifying criminals.
- 6 **Light Timers:** Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- 7 **Doors/Windows:** Always keep doors and windows locked.

Door and Window Safety

Doors:

- Should be made of solid wood or metal
- Have a single cylinder deadbolt lock and a 1-inch bolt
- Have a front door viewer or peep hole with a 180-degree range
- Clearly display unit number

Windows:

- Replace if glass is cracked and replace all damaged or missing locks
- Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

Keep property in good repair. Maintain visibility to your neighbors for increased safety.

## WHO AND WHEN TO CALL?

**3-1-1:** Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

**SF 3-1-1 APP** is available to use on your mobile device. Download the APP and its easy to use for many Non-emergency.



**Non- Emergency San Francisco Dispatch Line:** Please call the non- emergency dispatch line (**415-553-0123**) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, suspicious activities, or a homeless/nuisance related issue. **The non-emergency line is for situations that require the police, but do not require an immediate police response.**

**9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency.** The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1.**
