
OFFICER OF THE MONTH ANNA CUTHBERTSON

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is left unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

DEFINITIONS OF CRIME

Robbery– Robbery is the taking of property from another by using force or by using fear.

Assault– An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery- (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily in jury.

** Assault is when a person swings their arm and battery is when that arm makes contact with another person. **

Aggravated Assault—Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.


Burglary– The intent upon entry into a property to commit grand theft, petty theft, or any felony.

INCIDENTS IN THE RICHMOND DISTRICT THIS WEEK

Loaded Firearm in a Vehicle, Arrest 10/30/18 2024 Hours 850 La Playa

The Victim, Suspect 1, and Suspect 2 got in an argument that turned physical. The Victim heard the sound of a shotgun being racked, ran into Safeway looking for help, and located an Officer. The Victim asked for assistance and said that he saw a gun. The Officer immediately headed outside and located Suspect 1 in the vehicle the Victim had described. Due to the fact that there may be a gun involved, the Officer ordered Suspect 1 out of the Vehicle and kept the parties separated. While the Officer was sorting out the situation and waiting for backup to arrive, Suspect 2 thought he would try his luck at getting away and entered the same vehicle. The Officer noticed right away and drew his firearm and ordered the second suspect out of the vehicle.

Additional units arrived and searched the vehicle locating a loaded shot gun next to the driver seat.

Suspect 1 was arrested and booked at County Jail on the following charges: Loaded Firearm in a Vehicle, Illegal Firearm, Exhibiting a Firearm, Possession of a Firearm by a Prohibited Person, Driving With out a License.

Suspect 2 was arrested and booked at County Jail on the following charges: Loaded Firearm in a Vehicle, Illegal Firearm, Possession of Narcotics Paraphernalia, Driving Without a License.

Vehicle Burglary Arrest 11/1/18 1430 Hours 800 Block Point Lobos Ave

Officers spotted a suspected Auto Booster casing cars and driving a Lexus with paper plates. Officers witnessed the suspect break into the Victim's vehicle and flee the scene in the Lexus. Officers followed the suspect and coordinated his apprehension without incident.

A records check revealed the suspect had a prior history of breaking into cars and was out on bail for two separate cases for similar offenses.

Witnesses at the scene confirmed the suspect had committed three additional break-ins earlier in the day.

The suspect was arrested and booked at County Jail on the following charges: 4 Counts of 2nd Degree Burglary, Committing a Felony While out on Bail, Possession of Burglary Tools.






