

Definitions of Crimes

Criminal Threat (Penal Code section 422)

According to the Judicial Council of California Criminal Jury Instructions, to prove that the defendant is guilty of this crime, the People must prove that:

- 1. The defendant willfully threatened to unlawfully kill or unlawfully cause great bodily injury to <witness>;
- 2. The defendant made the threat (orally/in writing/by electronic communication device);
- 3. The defendant intended that (his/her) statement be understood as a threat [and intended that it be communicated to <witness>;
- 4. The threat was so clear, immediate, <u>unconditional</u>, and specific that it communicated to <witness> a serious intention and the immediate prospect that the threat would be carried out;
- 5. The threat actually caused <witness> to be in sustained fear for (his/her) own safety [or for the safety of (his/her) immediate family]; AND
- 6. <witness>'s fear was reasonable under the circumstances.

Someone commits an act willfully when he or she does it willingly or on purpose.

In deciding whether a threat was sufficiently clear, immediate, unconditional, and specific, consider the words themselves, as well as the surrounding circumstances. For example, "I am going to kill you!", is substantially different from, "If you come back here, you're going to be sorry!", the latter being neither clear, immediate, unconditional, or specific.

Someone who intends that a statement be understood as a threat does not have to actually intend to carry out the threatened act [or intend to have someone else do so].

Great bodily injury means significant or substantial physical injury. It is an injury that is greater than minor or moderate harm.

Sustained fear means fear for a period of time that is more than momentary, fleeting, or transitory.








The suspect was arrested and booked at County Jail on the following charges: Burglary, Malicious Destruction of Property







San Francisco Police Safety Tips for Lunar New Year Festivities

Gung Hay Fat Choy! The 2019 San Francisco Chinese New Year Parade will be held on **Saturday**, **February 23**, **2018**. The parade, begun in the 1860's as a means to educate the community about Chinese culture, is the largest such lunar year celebration in the country and one of San Francisco's most popular and well-attended events.



With huge crowds expected, including guests from all over the world, public safety is the San Francisco Police Department's number one priority. There will be a significant police presence during Lunar New Year activities, with both uniformed and plainclothes officers on duty to monitor public events. As with any large event, safety is everyone's responsibility, including participants, organizers, security staff and law enforcement.

Lunar New Year celebrants can help avoid becoming a victim of a crime by keeping in mind the following safety tips:

 The festivities are about celebrating community. Look out for each other and report any suspicious persons or activity to event staff or a police officer. A good adage is, "If you see something, say something." In an emergency, call 9-1-1. To provide an anonymous tip, call the SFPD Anonymous Tip Line at 1-415-575-4444.



 Stay informed by signing up for emergency text message alerts by texting the word AlertSF to 888-777. AlertSF allows us to notify you of emergencies in San Francisco.

- Keep your friends close and your drinks closer. Don't accept drinks from strangers. Drink responsibly and don't drink and drive- always use a designated driver.
- The San Francisco Bay Area has a host of public transit options that will get you to, from and around Lunar New Year events.
- If you drive to the festivities, remember to "Park Smart!" Take your valuables with you - don't leave them inside your car.



- Maintain possession of your cell phone, wallet and other valuables.
- There is safety in numbers. Stay with a group when on the street or leaving bars and clubs. Be cautious about leaving a bar or club with

a stranger. A rule of thumb is that if you feel "unsure" about someone, rely on that instinct and do not go with that person.

San Francisco Police also urge all members of the Chinese community to be suspicious of strangers claiming to provide relief from a curse or illness or those who provide "purification" ceremonies in which cash and valuable items must be offered as part of the process.

Anyone who is confronted by scammers or anyone who knows of an elder who was approached by scammers is strongly advised to contact police. Reports can be made at any SFPD District Station or by calling Dispatch at 1-415-553-0123 and requesting an officer to take a report.

Cantonese speakers can leave tips on a special tip line by calling 1-415-553-9212 or 1-855-737-3847.

Information can also be called into the Anonymous Tip Line at 1-415-575-4444 or via Text a Tip by texting a message to TIP411 and beginning the message with SFPD.



Healthy Streets Operation Center (HSOC)

The HSOC is a partnership between the San Francisco Police Department and the Department of Homelessness and Supportive Housing, the Homeless Outreach Team, the Department of Public Works (DPW), the Department of Public Health, the Department of Emergency Management, 311 and the Controller's Office.

The aim of this partnership is to create a unified response team to address homeless encampments in San Francisco. The intent is to lead with services but if services are refused then encampment residents may be cited and the encampments removed.

While HSOC is city-wide, they have identified the most concentrated areas of focus as: Castro, Civic Center/Tenderloin, Mission, Showplace Square, and the

Embarcadero.

SFPD Officers assigned to HSOC do the following:

- Support officers at each District Station
- Respond to 311 or 415-553-0123 calls regarding homeless encampments
- Address any on-view encampments
- Report abandoned property left at encampments to DPW for removal and clean-up
- Work in collaboration with other city agencies to address homeless encampments

During daytime hours all homeless related calls for service are sent to HSOC for Homeless Outreach Officers at Richmond Station and HSOC Officers to handle. During nighttime hours, HSOC Officers are focused on encampment issues based on 311 calls or any on-view encampments. After 2300 hours the calls for service are routed back to the District Stations to handle.

Always call 311 to address any homeless encampment issue, this gets the call for service logged and creates a complaint which can be tracked. Don't just email Richmond Station or use Nextdoor. 311 receives approximately 240 calls regarding homeless every day and they are trying to streamline the process.

On private property, after an initial warning, the individual can be cited for trespassing, if the property owner or representative is present and willing to sign a Citizen's Arrest (CA) form. On public property, the individual can be cited or arrested (if they are committing a crime), checked for warrants, or asked to move. Callers sometimes mistake rudeness, profanity and yelling and screaming (either intentional or as a result of altered mental status) for criminal threats—refer to the definition of criminal threats on page 7.

Bicycle and Pedestrian Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on February 4th, 12th, 20th and 28th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners, and only on a green light. Bicyclists should walk their bicycles when in the crosswalk with pedestrians, and stop at red lights and stop signs. All motorists are reminded to be mindful of others who share the road.
