#### Ingleside Captain's Message

While April 18 is a day where we pause and remember the 1906 earthquake and fire, there is no day like the present to action plan on earthquake and disaster preparedness for yourself, your family, your block, and your neighborhood. In the spirit of constantly challenging ourselves to be better and more prepared to adapt and overcome stress and adversity, Sup. Safai's Office and Ingleside Police Station partnered with the Neighborhood Empowerment Network to run a "Shake Tank" earthquake simulation. The April 24 event, graciously hosted by Pastor Barbara Cornejo at the Daring Faith Celebration Centre, lived up to its tagline: "Experience your tomorrow, today," when resident leaders from the Cayuga neighborhood engaged in the earthquake simulation with representatives from BART, Riordan High School, Recreation and Parks, the Mission Childcare Consortium, School Resource Officers, the Department of Emergency Management, CalOES, FEMA, SFFD, City College of SF, and many others. There were many positive takeaways from this event, with the biggest takeaway being the fierce urgency of getting ourselves as ready as we can be, so that we have the capacity to help others. Hot Prowl Burglary

A report of three masked men jumping out of a white SUV and breaking into a home prompted dispatch to send Ingleside Officers Peralta, Trujillo, and Andrade to investigate. When the officers arrived a woman resident said she called police after hearing footsteps upstairs and downstairs from her bedroom. She opened her bedroom door and saw a suspect run past the doorway and out the back door into the back yard. Shortly, thereafter, Ingleside Captain Hart radioed dispatch to say he was following the suspects' vehicle as it traveled south on Putnam and then east on Alemany and then onto the southbound #280 freeway. Dispatch alerted the Highway Patrol, Daly City Police, and South San Francisco Police but the chase ended when the vehicle was lost near San Francisco International Airport. Back at the home, officers discovered a back window was broken by the burglars to gain entry into the home and several neighbors reported seeing the suspects exit their vehicle and jump over the fence into the victim's backyard. #### What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

#### Pathways to ALERT membership:

- 1. Complete NERT training and receive certification. To register for NERT training courses, please visit www.sfgov.org/sfnert. Once NERT Certified, forward a copy of your NERT ID card to the ALERT program at sfpdalert@sfgov.org. After clearing our background check, you are eligible for ALERT training.
- 2. If you are an SFPD Community Police Academy graduate, you are eligible for ALERT training after clearing our background check.





#### San Francisco Police Make Arrests in Central District Homicide

On Saturday March 11, 2017 at approximately 1:35AM, San Francisco Police officers responded to the 500 block of Green Street regarding a possible shooting. An officer found 21 year-old Oswaldo Fuentes laying in the street suffering from multiple gunshot wounds. Fuentes was pronounced deceased at the scene.

The SFPD Homicide Detail began an investigation that led to the identification of suspects. On Thursday May 9, 2019 investigators arrested 26 year-old Carlos Valiente of Richmond and 31 year-old Anthony Molina of Benicia. All suspects were booked at San Francisco County Jail.



### Phase 1 – Initial Progress Report Highlights SFPD's Progress on Collaborative Reform

The California Department of Justice today announced the release of the first report on the San Francisco Police Department's progress on Collaborative Reform, including its efforts to review and reduce officer use of force, identify and address bias, and enhance community policing, transparency and accountability.

"San Francisco invited the U.S. Department Justice in for an independent review of our police department in 2016, which led to 272 recommendations for reform," said Mayor London Breed. "SFPD has made significant progress towards changing policies and culture that will ultimately lead to greater trust between law enforcement and our diverse communities. There is still much more work ahead, and we are committed to fulfilling each and every reform recommendation and to meeting the high expectations our residents have for our police department."

Following the U.S. Department of Justice's withdrawal from the Collaborative Reform process in 2017, SFPD last year requested that the California Department of Justice provide an independent evaluation of the police department's ongoing reform efforts. SFPD continued its work during this transition period, requested and received new, detailed and more stringent performance standards from the CA DOJ, and began a wholesale reexamination of reform work previously submitted to the US DOJ for approval.

Under the new process, 63 of 272 original US DOJ recommendations- including ones focusing on Use of Force, Bias and Accountability- were prioritized for review, with 11 marked as complete by the CA DOJ. As a result, the Phase 1 – Initial Progress Report finds "SFPD is better positioned to achieve successful transformation now and in the future."

"The California Department of Justice brought to the reform process more cohesive, specific and transparent performance standards which we are applying to our work accomplished under the original CRI," said Chief William Scott. "This will provide a critical, independent eye to measure our transformation over the coming years. This report identifies key challenges ahead, but we've already made significant progress. Through this collaboration with CA DOJ, we will provide more accountability to the public and ensure our success is sustainable."

Since initiating Collaborative Reform in 2016, SFPD has:

- · Reduced the use of force by 30 percent;
- Provided all patrols officers with at least 10 hours of Crisis Intervention Team field tactics training, with half of the department completing CIT course certification;
- Instituted audits of department computers, emails and phones for biased language;
- Begun its first external audit of use of force data, led by the San Francisco Controller's office on behalf of the Department of Police Accountability
- Finalized a Memorandum of Understanding enabling the San Francisco District Attorney's Office to serve as lead investigator of officer-involved shootings, increasing accountability in the process;
- Mandated implicit bias training for sworn officers to help ensure fair and impartial community policing;
- Created a comprehensive community policing strategic plan to guide the department's practices and values;
- Developed its first Department General Order that specifically deals with gender inclusivity:
- Elevated its citywide foot beat presence, driving down incidents of car break-ins and simple assault, while developing and improving relationships with community members

#### SFPD Statement on Adachi Report Criminal Investigation

There is immense public interest in the interplay between the Bryan Carmody search warrants, the First Amendment and reporter shield law protections. Therefore, we feel that disclosure of further details of the criminal investigation into the theft and unauthorized release of the death report involving Public Defender Jeff Adachi is in the public interest.

We would like to make clear to everyone that there is an ongoing criminal investigation into this matter. For that reason we are not currently able to disclose some details of the investigation. In addition, we are unable to release information ordered sealed by the court.

This criminal investigation focuses on the conspiracy to commit a crime, the theft of a police report, receiving stolen property, the unlawful dissemination of official information, and the willful obstruction of justice. Moreover, based on evidence developed, the subjects of this investigation are SFPD employees. A secondary focus of this investigation is whether Mr. Carmody was an active participant in the commission of criminal acts, beyond his role with the news media.

As the investigation developed, Mr. Carmody was and continues to be viewed by investigators as a possible co-conspirator in this theft, rather than a passive recipient of the stolen document. Investigators learned that Mr. Carmody was offering to sell the stolen report to various Bay Area news organizations. Mr. Carmody's LinkedIn profile shows that he is a "Freelance Videographer/Communications Manager, USO Bay Area" and that he was not employed by any of the news organizations who received the stolen report.

While we fully respect the First Amendment rights of journalists, and the related laws of the State of California, the San Francisco Police Department sought search warrants in the San Francisco Superior Court based on probable cause that the crimes we have

described did occur and that the warrants would further the investigation. Our actions reflect that we believe Mr. Carmody was a suspect in a criminal conspiracy to steal this confidential report.

As the investigation progressed, we concluded that the motive was one or both of the following:

#### **Financial Gain:**

Investigators learned from unsolicited correspondence from a member of the public that Mr. Carmody contacted a member of the media and offered for sale the Adachi death report for \$2,500. We are investigating whether the SFPD employee(s) conspired with Mr. Carmody to steal the confidential report and financially profit from it.

#### Mr. Adachi's Reputation and Image:

SFPD investigators conducted a consensual interview with Mr. Carmody, during which he indicated motive and expressed his disdain for Mr. Adachi and referred to the individuals who helped him obtain the report as "good people..." who "...had the right intentions."

In short, we concluded that the person (or persons) responsible for the theft of the report committed a number of criminal acts that constitute both misdemeanors and felonies. We are looking at theft of our incident report (Cal. Penal Code section 484(a)) as well as the unlawful dissemination of confidential CLETS (California Law Enforcement Telecommunication System) derived information. (Cal. Penal Code sections 11105 and 13300 et. seq.) Also, we believe the unauthorized release of the stolen report compromised, obstructed, and delayed the death investigation. (Cal. Penal Code section 148(a)(1)).

In this matter, we believe that any person employed by the SFPD knew or should have known that public exposure caused by the theft of an incident report in this type of high profile investigation would compromise, obstruct, and delay the investigation. Armed with this information we believe that any employee of this Department who knowingly and illegally caused the unauthorized release of the concerned incident report in this matter, committed an intentional act.

The Department previously issued a public apology to Mr. Adachi's family for the unauthorized release of the death report. We would like to take this opportunity to again apologize to the Adachi family.



### **Distracted Driving**

Distracted driving is anything that takes your eyes or mind off the road. In the smartphone age, distracted driving is the most dangerous when drivers are using their cell phone behind the wheel.

Whether it is talking, emailing, texting, plugging in directions, using an app or scrolling through social media feeds, using a cell phone is not only dangerous, but also illegal.

In 2017, 3,166 people were killed in distracted driving related crashes across the country, or nearly 10 percent of all traffic deaths.

Using a phone to dial, talk or text triples the risk of a driver getting into a crash. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for an average of 5 seconds. At 55 mph, that's like driving the length of a football field with your eyes closed.

Other serious driver distractions such as eating, grooming, reaching for objects on the floor, changing clothes or talking with passengers are just as dangerous. The safest thing drivers can do is put down the phone, focus on the road and just drive.







#### **Cell Phone Law**



Holding a phone while driving is illegal. Any electronic device must be used in a hands-free manner, such as speaker or voice commands. The law applies when at a stop sign or signal.



To use a phone while driving, it must be mounted on the dashboard, windshield (seveninch square in lower right corner or five-inch square in lower left corner), or center console.



When the phone is mounted, drivers can swipe or tap the screen once to activate or deactivate a feature. It is illegal to swipe multiple times, enter information or text.



A first offense ticket is \$162, with additional offenses costing even more.



You may use your phone while holding it for true emergencies, like calling 911.

# Ability to Pay

## in San Francisco Traffic Court

If you cannot afford to pay your ticket, you have a right to ask the traffic clerk or judge to consider your financial circumstances.

The court will look at your financial information, and then will decide whether to:

- 1. Reduce Your Fine, and/or
- 2. Offer you Community Service, and/or
- 3. Offer you an Affordable Payment Plan

I can't afford to pay for my traffic ticket.






Any time after you have been found guilty of a ticket, you can request the court to reduce your fine because you can't afford it.



The court will give you a form called Can't Afford to Pay Fine (TR320/CR-320) so you can explain why you can't afford to pay.



Provide as much detail as you can on the form about your income, expenses, why you can't afford to pay, and what you would like the court to do.



Attach documents showing your income and expenses, or explain on the form why these documents aren't available. Submit your form to the court.



The court will read it and let you know the decision by mail. Check with the court if you haven't heard back after 30 days.



If you've had a change of circumstances or need to provide more info about your situation, you may submit another request.
