Glen Park News

The following 4 commercial burglaries have occurred in the Glen Park neighborhood in the past week:

- 1) 7/21 overnight to 22, Destination Baking Company. 598 Chenery St. 190-529-930
- 2) 7/21 overnight to 22 Higher Grounds Coffee 691 Chenery St. 190-529-974
- 3) 7/25 overnight to 26 Glen Park Hardware 685 Chenery St. 190-541-940
- 4) 7/25 overnight to 26 Gialina's Pizza 2842 Diamond St. 190-541-978

The MO appears to be the same: kicking in the front door of the business and taking the cash register. One register was recovered and is being processed by our Crime Scene Investigations Unit. The exact times of the incidents are not clear, however, based upon the locations of these businesses, they likely happened in the very early morning hours on the 22nd and the 26th, respectively.

While it's really helpful to capture the incident on video, it's also REALLY helpful when we can capture the suspect(s) driving/walking to and/or driving/walking from the burglary.

Here's where you come in: If you happen to live in the neighborhood of these incidents, and you happen to have a camera that faces the street, would you please check the video to see if there is footage of the suspects going to or coming from this incident either on foot or in a vehicle? Anything you could find would be most helpful.

In the meantime, we are scouring the neighborhood for witnesses and evidence, coordinating with our citywide Burglary Detail to determine patterns and likely suspects across police district boundaries, and have briefed all of Ingleside's night shift officers to this crime "hotspot" location.

San Francisco SAFE, our prevention partner, along with Ingleside Station, will be meeting with these businesses to consult regarding security best practices, including lights, cameras, burglar alarms, etc.--anything that will help to dissuade, prevent, and/or rapidly detect criminal activity with these or any other businesses in the neighborhood. The only other reminder is that if people see something to please say something; all in-progress suspicious behavior should be reported to 911, so that our dispatchers can prioritize and coordinate a rapid response to suspects easing or attempting to break into our businesses.

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Ways To Become An ALERT volunteer:

- Graduate the SFFD NERT course (http://sifire.org/neighborhood-emergency-response-teamnert), or.
- Graduate the SFPD Community Police Academy course (https://sanfranciscopolice.org/communitypolice-academy)
- 3. Pass a basic DOJ/FBI Background check.
- Sign up for the next 8 hour ALERT new volunteer training class.



MUNIFORWARD Muni Subway Maintenance Project

Muni Subway Closes Early for Critical Maintenance

The SFMTA maintenance crews work hard every night after Muni Metro subway service hours to maintain the tracks and equipment underground. On most nights, this gives them only about two hours to get work done. In order to complete critical maintenance tasks that cannot be completed during normal windows, we are planning two weeks of early subway closures, so crews have more hours each night to do this vital work.



STARTS THIS MONDAY, AUGUST 12TH

Starting August 12 and continuing for approximately two weeks, the subway between Embarcadero and West Portal will close early at 9:30 p.m. When the subway closes early, buses will run above ground to connect all stops, beginning at 9:30 p.m. through the normal end of train service at 1 a.m. Owl service will remain unchanged. Trains will start regular morning service each day.

TRANSIT SERVICE PLAN - 9:30PM TO END OF NORMAL SERVICE AT 1AM



Shuttle buses will serve all Muni Metro stops between Embarcadero/Brannan and St. Francis Circle





Train service between Balboa Park and St. Francis Circle



Buses will run between Embarcadero/Brannan and Zoo. No L trains running.



Train service between Ocean Beach and Church/Duboce (Inbound N trains become outbound N trains at Church/Duboce)



Train service between Balboa Park and Church/Duboce

(Inbound J trains become outbound J trains at Church/Duboce)

Train service between Sunnydale and Embarcadero/Brannan

CUSTOMER INFORMATION:

- Inbound N Judah and outbound J Church trains will use the accessible stop entering the Duboce Portal to serve passengers needing the ramp.
- For service on Market Street, Muni customers can board bus shuttles at a bus top marked with the half-moon sign.
- Muni customers are encouraged to leave extra travel time during subway closures.
- Regular bus fares will apply on bus shuttles and valid transfers will be accepted.

The extended window will give us an opportunity to do complex work aimed at making subway operations more reliable and prevent future breakdowns.

An additional early shutdown window is planned for December.

San Francisco Police Request Public Assistance in Identifying Package Theft Suspect

Fugitive Recovery Operation in Tenderloin District Leads to 73 Arrests

On Wednesday, August 7th 2019, a six-hour operation in the Tenderloin Police District resulted in 73 arrests. Sixty-seven of those suspects were booked into San Francisco County Jail last night. Tenderloin Station officers led the operation and were assisted by San Francisco Sheriff's Deputies, State Parole Agents, and officers from Southern Station.

Fugitives wanted on outstanding arrest warrants issued by courts in San Francisco, San Luis Obispo, San Mateo, Rohnert Park, Burlingame, Alameda, Colma, Contra Costa County, Palo Alto, Berkeley, and CDC Parole, were arrested and booked. The warrants were issued for a variety of offenses including narcotics, aggravated assaults, burglary, contempt of court, theft, sex offenders, domestic violence, fraud, and parole violations. No officers or suspects were injured during the course of these arrests.

This effort is the latest in ongoing operations led by Tenderloin Station designed to reduce crime and to emphasize the San Francisco Police Department's commitment to a safer, healthier community. The Tenderloin is home to approximately 4,000 children who attend schools in the community and attend programs in neighborhood parks. These children are a major factor in the Department's commitment to removing this criminal element from the streets and sidewalks these children travel to and from school.

San Francisco Police Department Makes Arrest in Bayview District Homicide

On Saturday, August 10 2019 at approximately 9:28PM, San Francisco Police officers responded to a ShotSpotter notification in the area of the 1000 block of Oakdale Avenue. Officers arrived on scene and located 34 year-old Dietrich Whitley, who was suffering from multiple gunshot wounds. Responding officers attempted lifesaving measures until relieved by paramedics. Mr. Whitley was taken to a hospital but unfortunately succumbed to his injuries.

The SFPD Homicide Detail began an investigation that led to the identification of a suspect. On Tuesday, August 13 2019, investigators arrested 38 year-old Sauntek Harris of Concord in the city of Concord. He was booked at San Francisco County Jail on charges of homicide and a felon in possession of a firearm.

No booking photo is being released at this time due to pending identification matters.

Although an arrest has been made, investigators are asking anyone with information about this case to contact the San Francisco Police anonymously at 415-575-4444 or text-a-tip to TIP411 with SFPD at the start of the message.



Project Description

S.F. Public Works has partnered with the San Francisco Public Utilities Commission to complete infrastructure improvements along <u>Alemany Blvd.</u>

<u>Street.</u> Public Works will manage the project and we've hired D'Arcy & Harty Construction, Inc. to complete the work.

Construction is scheduled to begin in late lune 2019 with completion expected in December 2020.

This project will include sewer main replacement, street base repairs, curb ramp and bulb-out installation, minor traffic signal work at the Santa Rosa Ave. and Silver Ave. intersections and repaving between Congdon Street and Seneca Avenue. Please note, not all blocks will include sewer main replacement work. <u>Please visit our project webpage for additional information on which blocks will include sewer work</u>.

Sewer service will not be interrupted during construction. Please continue to use your household plumbing per the usual.

Once the sewer work is complete, crews will begin preparations to repave the street. Preparations will include installation of curb ramps and bulb-outs followed by street base repairs. Street base repairs will require the contractor saw-cut sections of the roadway, remove the broken concrete and pour back fresh concrete. Replacing the street base now will improve the longevity of the new asphalt road.

Since there are several blocks included in this project, it may be weeks or months before we reach your block. We are sending you this notice in advance of any work on the project.

Neighborhood Tip:

Please call 3-1-1 to report any issues in the neighborhood such as potholes, burnt-out traffic signals or streetlights, leaky fire hydrants, broken curbs or sidewalks, illegal dumping, etc. 311 is the primary customer service center for the City of San Francisco. They'll route your concern to the appropriate agency for follow-up.

Impacts and Restrictions

Street parking may not be possible on the block during construction work hours. In some cases, parking may not be possible on part of the adjacent block as we taper the traffic lanes to accommodate the work zone. Please see posted barricade signs for exact work hours, days, and locations, because they may vary depending on the construction task. The "no parking" signs will be posted at least 72 hours in advance to alert motorists of parking restrictions.

Vehicles parked in the construction zone during the posted work hours will be towed at the vehicle owner's expense. Please allow extra travel time during construction work hours.

Street cleaning restrictions will still be in effect

Distracted Driving

Distracted driving is anything that takes your eyes or mind off the road. In the smartphone age, distracted driving is the most dangerous when drivers are using their cell phone behind the wheel.

Whether it is talking, emailing, texting, plugging in directions, using an app or scrolling through social media feeds, using a cell phone is not only dangerous, but also illegal.

In 2017, 3,166 people were killed in distracted driving related crashes across the country, or nearly 10 percent of all traffic deaths.

Using a phone to dial, talk or text triples the risk of a driver getting into a crash. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for an average of 5 seconds. At 55 mph, that's like driving the length of a football field with your eyes closed.

Other serious driver distractions such as eating, grooming, reaching for objects on the floor, changing clothes or talking with passengers are just as dangerous. The safest thing drivers can do is put down the phone, focus on the road and just drive.







Cell Phone Law



Holding a phone while driving is illegal. Any electronic device must be used in a hands-free manner, such as speaker or voice commands. The law applies when at a stop sign or signal.



To use a phone while driving, it must be mounted on the dashboard, windshield (seveninch square in lower right corner or five-inch square in lower left corner), or center console.



When the phone is mounted, drivers can swipe or tap the screen once to activate or deactivate a feature. It is illegal to swipe multiple times, enter information or text.



A first offense ticket is \$162, with additional offenses costing even more.



You may use your phone while holding it for true emergencies, like calling 911.

If you cannot afford to pay your ticket, you have a right to ask the traffic clerk or judge to consider your financial circumstances.

The court will look at your financial information, and then will decide whether to:

- 1. Reduce Your Fine, and/or
- 2. Offer you Community Service, and/or
- 3. Offer you an Affordable Payment Plan

I can't afford to pay for my traffic ticket.






Any time after you have been found guilty of a ticket, you can request the court to reduce your fine because you can't afford it.



The court will give you a form called Can't Afford to Pay Fine (TR320/CR-320) so you can explain why you can't afford to pay.



Provide as much detail as you can on the form about your income, expenses, why you can't afford to pay, and what you would like the court to do.



Attach documents showing your income and expenses, or explain on the form why these documents aren't available. Submit your form to the court.



The court will read it and let you know the decision by mail. Check with the court if you haven't heard back after 30 days.



If you've had a change of circumstances or need to provide more info about your situation, you may submit another request.


