Hello all,

Belated happy Saint Patrick's Day.

Park District continues to be a safe place with all our crimes down by comparison to 2018. This is really good news and my officers will continue to work hard to see these numbers go down further.

I want to remind you all that safety and crime prevention begins with you. Please remember never to leave anything visible in your car when you park and if you are putting items in the trunk of your car do so away from where you are going to park your car.

Remember lock all you doors especially garage doors as we are seeing an uptick in burglaries that involve the burglar entering into the garage and taking a bike. If you have a bike do consider putting a tracker on your bike so that if it is stolen we can increase our chance of finding the bike. In addition lock the bike to a stationary object even if it is in your garage. This will at least slow down the thief if they make entry into your garage.

Do think about installing surveillance cameras in and around your home. This week alone we have been able to identify four people through video footage. One subject had just committed a burglary and the other three were part of serious crimes. I cannot overemphasize the advantage to having surveillance cameras installed as the video footage of crimes committed allows us to identify the suspects in the crimes and also gives us additional evidence in criminal cases.



### **ANTI-BIKE THEFT TIPS**

SAFE BIKES and the SFPD recommend the Sheldon Brown Locking Method.

No locking method is 100% foolproof, but this method is highly effective.

### GUIDE FOR LOCKING YOUR BIKE:


- Use the smallest U-lock that works for your bike to minimize the amount of space available for a thief to insert a jack or levers.
- Use a hardened steel U-Lock to secure back wheel inside the rear triangle of the bicycle frame.
- Check to make sure U-lock is secured to an immovable metal object.
- Secure front wheel with cable or second U-lock.
   Loop cable around the down tube of the bicycle or secure second U-lock to front wheel and down tube.
- Replace quick release skewers and nutted wheels with keyed locking skewers and nuts to ensure wheels and saddles are locked to the bike frame at all times.
- Check with local bike shop for proper installation of locking skewers and advice.



### YOU JUST BOUGHT A NEW BICYCLE-**NOW WHAT?**

### FOLLOW THESE STEPS:

- Register and upload receipt and photos of your bicycle at sfsafe.org/safe-bikes.
- Buy a hardened steel U-lock and a secondary lock such as a chain or cable (See locking tools list).
- Replace quick release skewers and nutted wheels with uniquely keyed locking skewers and nuts, which keep wheels and saddles locked to the bike frame at all times.
- Lock your bicycle in your garage the same way you would on the street.
- Take an urban bicycling workshop with the San Francisco Bicycle Coalition to learn safe riding practices. Go to sfbike.org for more information.
- Speak with your local bicycle shop for more help and advice.





### TOOLS TO LOCK YOUR BICYCLE

There are many different types of locks for bicycles and many incorrect ways of using them. No locking method is 100% effective.

For best security use a hardened steel U-lock, chain and locking skewers.

U-lock

- Very good deterrent
- · Use the smallest U-lock that works for your bike to minimize the amount of space available for thief to insert a jack or levers

Chain

· Hardened alloy steel with thickness of at least 3/6" thick and heaviest is best

- Locking . Very good deterrent
- Skewers . Replace all quick release parts
  - Check local bike shops for proper installation

Cable

- · Recommended for secondary locking device
- · Good security for movable parts

### PREVENTING BICYCLE THEFT IN GARAGES

Garages and multi-unit apartment buildings with common garage are one of the most vulnerable places for bicycles. Thieves are waiting for the perfect opportunity.

Secure your bicycle in the garage the same way you would on the street!

- Secure to an immovable object or an anchor system.
- Never lock your bike near a window or door.
- Always watch your garage door and make sure it closes completely so unwanted visitors do not enter.
- Contact SAFE at 415-553-1984 or info@sfsafe.org for a residential security survey.




- File a police report through sf-police.org or visit your local police district station.
- Notify SAFE BIKES at info@sfsafe.org or call 415-553-1984.
- Provide pictures and serial numbers for bicycle with the police report and any identifying marks.
- If you don't have a serial number or pictures, track down your serial number from the point of purchase and/or use stock photos and send them to the investigator immediately.
- File an insurance claim.

### INTERNET INVESTIGATIONS

- Post pictures of stolen bicycle to Craigslist, set up a Google alert, and use IFTTT.com.
- If bicycle is found, contact the SFPD investigator. DO NOT arrange a meeting and attempt to get your bicycle back.
- Check racklove.com and stolenbikeregistry.com to find your bicycle.

### A JOB WELL DONE

On February 10, 2019 at approximately 6:00 PM Officers responded to Fulton and Masonic and a report of a stolen laptop. The first Officers arrived on scene and met with the victim and a witness. Officer Villaarin and Officer Salazar gave a detailed description over their police radios of the suspects and the laptop that was stolen.

The following Sergeants and Officers responded to the area to search for the suspects and stolen laptop: Sgt. O'Malley, Sgt. Friedman, Sgt. Salazar, Ofc. Aguirre, Ofc. Riechsteiner, Ofc. Cheng, Ofc. Asare, Ofc. Lewis, Ofc. Coronado, Ofc. Prescott, Ofc. Murphy, and Ofc. Street. A short time later one of the suspects was seen hiding between two vehicles, this suspect was detained. The victim and witness could not positively identify the suspect as the person who stole the laptop, so he was released.

The above Sergeants and Officers continued to search the area for the others suspects and stolen laptop. Officer Cheng was born and raised in San Francisco. He has also attended public schools from kindergarten to high school in the San Francisco Unified School District, starting off with Jefferson Elementary, Herbert Hoover Middle School and Abraham Lincoln High School. After graduating from Lincoln, Officer Cheng attended San Francisco State University, where he earned a B.A. degree in Economics with a minor in Hospitality Management.

Officer Cheng wanted to contribute back to the city he was born and raised in and loved so dearly, he decided to apply to become a San Francisco Police Officer and was recruited to attend the Police Academy in 2008. Officer Cheng did his Field Training in Tenderloin Station, passed and began his one year probation in the Bayview District, where he passed and remained for another three more years. Officer Cheng ultimately transferred to Park District, where he has stayed since. During his career, Officer Cheng has been assigned to Patrol, Plainclothes Unit, Captain's Staff and now Park Station CPT. He has continued to enjoy serving the public, protecting and ensuring the safety of the community.

### Some of Park Station's Arrests for the Week

Burglary, Store, Forcible Entry, Malicious Mischief, Vandalism To Property, Theft from Building, 1300 Block of Haight Street 3/13/19 -10:35

On 3/13/19 between 0328 hours and 0337 hours, a suspect used a crowbar to pry open the front security gate and then break the front door window to a smoke shop located on the 1300 block of Haight Street. The suspect entered the store and proceeded to steal items. When the owner arrived, he viewed the security camera footage which showed the suspect. At approximately 1035 hours, the owner/victim saw the suspect at Haight and Masonic Streets. Officers responded and detained the suspect. A search of the suspect revealed items stolen in the burglary. The suspect was arrested and booked for accordingly for the above charges.

### Warrant Arrest, local SF Warrant, Municipal Code Violation/ area of Fell Street 3/15/19 - 03:44

Officers were patrolling the area of the Panhandle Park and observed a subject that had an outstanding warrant for his arrest. The Officers contacted the subject, arrested him and then transported him to County Jail.

Stolen Vehicle & Recovered, Stolen Property, Possession of Stolen Property With Knowledge, Receiving. Driving under the Influence of Alcohol, Driving Reckless, License Suspended or Revoked, Probation Violation, Traffic Violation Arrest, Vandalism or Graffiti Tools Possession, Open Container of Alcohol in Vehicle, Area of Twin Peaks View Point.

On 3/16/19, Park Station Officers observed a vehicle driving recklessly in the area of twin Peak. The vehicle was lost in the area, but later an off-duty San Francisco Police Sergeant saw the vehicle at 6th and Lincoln Avenue driving recklessly. The sergeant followed the vehicle to Big Rec Park and watched the driver exit the vehicle. Park Officers responded and detained the suspect. The investigation revealed that the vehicle had been stolen. An Officer form Richmond Station arrived on scene and conducted a DUI investigation. During the investigation, it was determined that the suspect had been under the influence of alcohol and was driving on a suspended driver's license. The investigation also revealed that the suspect was on felony probation for robbery. He was in possession of a graffiti tools and an open a container of alcohol. He was arrested and booked for the above charges.


### Marijuana Offense, Area of Christmas Tree Point Road. 3/16/19 -13:50

Officers observed a group of subjects in the area of Christmas Tree Point Road smoking marijuana. The Officers made contacted with the subjects, and conducted a probable cause search of their vehicle for additional marijuana, any additional contraband and to determine if the marijuana was above the legal limit allowed. The search revealed that subjects had over the legal limit of marijuana. The subjects were issued citations and released.

### Malicious Mischief, MUNI LRV, Irving and 2nd Ave. 3/14/19 - 02:39

Officers responded to a vandalism of a MUNI LRV. The suspect that was on the bus was yelling profanities on the bus and disturbing another passenger. The bus driver asked the suspect to get off the bus, the suspect complied. Once off the bus he smashed the front door window with a rock. The Officers located the suspect a few blocks away and placed him under arrest. The damage to the bus was approximately \$1,500. The suspect was booked for felony vandalism and transported to County Jail.

### TRAFFIC ENFORCEMENT


### **Safe Driving in Rainy Conditions**

We want everyone to get to their destination safely. Here are some suggestions to help you arrive safe.

- \*Leave a few minutes early to give yourself extra time to get where you need to go.
- \*Defog/De-ice your windows before you start driving.
- \*Be on the **lookout for pedestrians** especially around schools.
- \*Lookout for cyclists, many cyclists still ride their bike when it's raining.
- \*Lookout for road hazards such as deep puddles and debris.
- \*Use you brakes earlier to avoid skidding and hydroplaning.
- \*Stay away from flooded areas and downed power lines, whether in a car or on foot.
- \*Remember if your wipers are on, your headlights are on.



Overview

Note: The following information is specific to commercial and retail establishments; however, can be applied to any location utilizing video surveillance

Basic set up and maintenance problems can reduce the effectiveness of many systems.

- Resolution is it good enough for facial recognition.
- Camera position are they positioned for clear view of suspect.
- Lighting is it adequate to capture clear images both day and night
- d. Image detail is the recorder set up for best image detail
- e. Maintenance are you maintaining your system properly so it can do its job when needed?

### Set Up and Maintenance

- Backlighting when sun is bright at doorway, images in front appear darker or even black. Use another light source inside to counteract back light.
  - Low Frame Rate saves on drive space and gives better image quality, but you may not get an image at all (now you see him; now you don't)

SAFE VIDEO SURVEILLANCE RECOMENDATIONS

- Obstructions displays and other objects blocking view should be eliminated.
- Focus Problems must check system regularly to prevent.

Minimum camera resolution should be **480 horizontal lines**.

Good cameras have faster lenses (allows more lighting), larger maximum aperture opening (lets more light into the focal point of the camera) and controls image brightness allows brighter images in dim lighting) – the more lighting, the more depth of field (greater depth of field; the more of the scene is in focus)

Focal Length – some cameras zoom in and out while others have a fixed focal length. The type of cameras used depends on what your needs are.

Transaction Areas – anything at a transaction point (cash register, toll booth, etc.), the subject's head should fill at least 15% of the total image in the frame, giving the detail you need.

Lines of Sight – lines of sight are always critical, make sure there are no obstructions.

Le reprise the right site plan is crucial (retail store blueprint or diagram). Key camera spots are at transaction points (cash registers and entry/exit points) - the more cameras, the better.

You want good camera overlap (you want multiple chances to capture good images). Extra coverage is also needed for aisles, restrooms and other key points

Camera Height – placement is very important, make sure it is as close to eye-level as possible. Otherwise, you might lose out to a baseball cap.

With a good site plan you can make sure you don't have any blind spots (you can toy around with camera positions, and do a test recording to see that you are getting what you want).

screens sunlight). Adding more light from a different direction balances lighting, giving better camera clarity (if sunlight is shining through large windows you can tent windows or add screens Example: Artificial lighting (inside store) for cameras may be good in the morning, but by noon, the sun (through a doorway or window) can blow the entire frame out (add lighting to fill in for nterior Lighting – interior lighting can balance bright light from one direction (back lighting) by adding another light source from a different location (add a bank of lights).

Exterior Lighting – if lights are on timers, you must adjust appropriate to seasonal changes (Fall/Winter: gets dark earlier. Spring/Summer: gets dark later).

### Securing & Preventing

- 1. Secure all equipment and vehicles at all times.
- Take effort to reduce the visibility of tools and equipment secured in vehicles or on job sites.
- Make use of adequate lighting in conjunction with open chain-link fencing on the perimeter to allow for high visibility to the job site.
- Strongly consider the use of security systems such as alarms and video surveillance. Ensure signage for such is clearly visible.

### Precautionary Measures

- Photograph all tools.
   Ensure photographs clearly show the associated serial number and/or distinctive markings.
- Ensure job site keys are marked "Do Not Duplicate" and are controlled at all times.
- Attempt to park employee vehicles within visual range of the job site.

### **Should a Burglary Occur**

Immediately contact 911. Be prepared to provide the following information:

- a) Time of incident.
- b) Video (if available).
- c) Items taken (include make, model, description, location taken from, value, photos and serial numbers).
- d) Insurance information.
- e) Owner's information.

Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.

7 Residential Safety Tips



- Garage: When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- Car: Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- Spare Key: Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- O Door Buzzer: When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- Security Cameras & Alarm Systems: Cost effective tools for preventing crime and identifying criminals.
- Clight Timers: Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- Doors/Windows: Always keep doors and windows locked.

### Door and Window Safety

### Doors:

- · Should be made of solid wood or metal
- Have a single cylinder deadbolt lock and a 1-inch bolt
- Have a front door viewer or peep hole with a 180-degree range
- · Clearly display unit number

### Windows:

- Replace if glass is cracked and replace all damaged or missing locks
- Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

### WHO AND WHEN TO CALL?


**3-1-1:** Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

Non- Emergency San Francisco Dispatch Line: Pease call the non- emergency dispatch line (415-553-0123) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, suspicious activities, or a homeless/nuisance related issue. The non-emergency line is for situations that require the police, but do not require an immediate police response.

9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency. The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1**.
