#### Hello all,

#### We need your help.

As everyone knows San Francisco has had a major issue with vehicle break ins/ theft from vehicles. In the Park district we continue to see a reduction for 2019. However historically we do see an increase in this crime in the Park District during the months of August, September and October. For the most part the criminals victimize tourists but we still have San Francisco residents who are victims. Here is where we need your help.

#1 Always take the time to remove all valuables from your vehicle when you leave your parked car even if it is only for a brief period of time.

#2 If you are placing items in your trunk to ensure they are out of sight of potential thieves do so before you park your car so any on looking thief does not see you do this.

#3 If you see any tourists on you street parking their car please educate them about not leaving anything in their vehicle while they shop or sight see.

#4 There are a number of flyers in our newsletter regarding vehicle break ins please feel free to distribute to your neighbors or any potential victim in an effort to stop this crime.







These two outstanding Officers have served the citizens of San Francisco for 18 years, they both attended the San Francisco Police Academy class of 203rd. In 2003 they came to Park Station and have been partners ever since. The residents of the Park District are fortunate to have these extremely dedicated Officers protecting them daily. Officer Mitchell and Officer Tarbox have helped many citizens over the years and have arrested numerous criminals.



With a new school year starting, here are some Safety Tips when walking to school.



- Plan a safe route, always walk with an adult or a friend. Wear bright colored clothes if possible.
- Walk on the sidewalk, watch for cars at every driveway and intersection.
- Always use crosswalks or intersections when crossing the street, do not cross mid block and don't forget to activate the crosswalk signal if one is available.
- Look before you cross the street, look left, right and left again, do not cross the street if you see a car coming, even if you have the right-a-way. The driver may not see you. Try to make eye contact with the driver before you cross the street.
- Do not walk with earbuds or headphones on.
- Do not walk while texting or talking on the phone, be aware of your surroundings.

#### SCHOOL SAFETY TIPS

#### Driving safe around schools



- Be aware of school zones, pay extra attention around schools, playgrounds, and parks. A young child may dart in front of your vehicle.
- Don't block the crosswalk when stopped at a stop sign, red light or waiting to make a turn. This forces pedestrians to go around your vehicle and could put them in the path of moving traffic.
- Yield to pedestrians crossing the street or intersection. Always stop for a school crossing guard holding up a stop sign.
- Never pass a vehicle stopped for pedestrians.
- Always stop for pedestrians even if you have the right of way.
- Never pass a school bus when it is stopped to unload children.

#### Some of Park Station's Arrests for the week

#### Driving, No License Issued, Traffic Violation Arrest/ Area of Oak St. -08/12/19 23:16

While patrolling the area of Oak St. officers observed a vehicle with expired registration tags. Officers conducted a traffic stop on the vehicle, and asked the driver to provide a driver's license, but she failed to show proof. A computer query revealed that the driver did not have a driver's license. The driver was issued a citation and her vehicle was towed.

#### Warrant Arrest/ Area of Page St. -08/12/19 15:59

Officers responded to the area of Page St. as a backup to assist a Park Station Sergeant with a wanted subject. Headquarters advised that the subject had multiple active misdemeanor bench warrants out of the City and County of San Francisco. Officers made contact with the subject and conducted a warrants check. Subject had three misdemeanor bench warrants: Two Violations of 166(a) (4) PC bail at \$3,500 and violation 422 PC bail at \$5,000. The warrants were confirmed and the subject was placed under arrest and transported to County Jail.

#### <u>Vehicle, Stolen & Recovered, Stolen Property, Possession with Knowledge, Receiving, Warrant Arrest,</u> Local SF Warrant/ Area of Noe St. -08/13/19 16:03

Officers from Park Station were dispatched to the area of Noe Street regarding a possible vehicle theft. Dispatch informed the officers of a description of the suspect, officers canvassed the area and observed the suspect standing behind a gated area of a residence, which was not his residence. The reporting party stated that the suspect attempted to steal his vehicle. Suspect was detained, a records check revealed that the suspect had a misdemeanor warrant for his arrest. Officers also located a small baggie of suspected methamphetamine in the suspect's coin pocket. The suspect was in violation for 647(a) PC, bail of \$15,000. Suspect was placed under arrest and transported to County Jail.

#### Burglary, Residence, Forcible Entry, Malicious Mischief, Vandalism to Property, Probation Violation/ Area of Cole St. -08/14/19 17:40

Officers from Park Station were dispatched to the area of Cole Street regarding a possible burglary incident. Dispatch informed the officers that there was a subject who was seen by neighbors attempting to gain entry to a vacant home. Officers requested responding units to set up a perimeter around the vacant home. Officers entered the home and saw the subject who matched the description that was received from 911 caller. Officers gave the subject verbal commands who complied and exited the home. Subject was detained and placed under arrest. A records check revealed that the subject was on active probation from Sacramento County. The subject was booked at County Jail for burglary and a probation violation.



While on patrol, officers observed a male subject urinating on the west sidewalk of Shrader Street at Haight Street. Officers approached and detained the male subject without further incident. Male subject was asked for his identification and officers conducted a warrants check. Officers entered the driver's license number on CalPhoto to positively identify the male subject, but the photo did not match the suspect. Officers asked the male subject to provide them his real name, but he refused. Officers were able to locate the subject's wallet and his real identification. A computer query revealed that the subject was on active probation from Placer County, male subject was booked for the above listed charges and booked at County Jail.

#### **Distracted Driving**

Distracted driving is anything that takes your eyes or mind off the road. In the smartphone age, distracted driving is the most dangerous when drivers are using their cell phone behind the wheel.

Whether it is talking, emailing, texting, plugging in directions, using an app or scrolling through social media feeds, using a cell phone is not only dangerous, but also illegal.

In 2017, 3,166 people were killed in distracted driving related crashes across the country, or nearly 10 percent of all traffic deaths.

Using a phone to dial, talk or text triples the risk of a driver getting into a crash. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for an average of 5 seconds. At 55 mph, that's like driving the length of a football field with your eyes closed.

Other serious driver distractions such as eating, grooming, reaching for objects on the floor, changing clothes or talking with passengers are just as dangerous. The safest thing drivers can do is put down the phone, focus on the road and just drive.

#### **Cell Phone Law**



Holding a phone while driving is illegal. Any electronic device must be used in a hands-free manner, such as speaker or voice commands. The law applies when at a stop sign or signal.



To use a phone while driving, it must be mounted on the dashboard, windshield (seveninch square in lower right corner or five-inch square in lower left corner), or center console.



When the phone is mounted, drivers can swipe or tap the screen once to activate or deactivate a feature. It is illegal to swipe multiple times, enter information or text.



A first offense ticket is \$162, with additional offenses costing even more.



You may use your phone while holding it for true emergencies, like calling 911.



Not only is holding your phone while driving illegal in the State of California, distracted driving is now the number one cause of roadway crashes. Join us in being part of the solution. Grab the wheel with both hands, enjoy the drive and focus on each other. Here are some ways you can prevent driving distracted:


- > Silence your phone before you get behind the wheel and keep it mounted in a legally approved location.
- > Never text and drive or use apps or social media while driving.
- Do not eat, drink or program your GPS/MP3 > player or other devices while driving.
- > If a phone call is necessary or you need to reroute your map, pull over to use those devices.
- > If something falls to the floor, pull over to a safe parking spot before trying to reach it.



SAFE BIKES and the SFPD recommend the Sheldon Brown Locking Method.

No locking method is 100% foolproof, but this method is highly effective.

#### GUIDE FOR LOCKING YOUR BIKE:

- Use the smallest U-lock that works for your bike to minimize the amount of space available for a thief to insert a jack or levers.
- Use a hardened steel U-Lock to secure back wheel inside the rear triangle of the bicycle frame.
- Check to make sure U-lock is secured to an immovable metal object.
- Secure front wheel with cable or second U-lock. Loop cable around the down tube of the bicycle or secure second U-lock to front wheel and down tube.
- Replace quick release skewers and nutted wheels with keyed locking skewers and nuts to ensure wheels and saddles are locked to the bike frame at all times.
- Check with local bike shop for proper installation of locking skewers and advice.



#### SAFE BIKE REGISTRY

#### YOU JUST BOUGHT A NEW BICYCLE-NOW WHAT?

#### FOLLOW THESE STEPS:

- Register and upload receipt and photos of your bicycle at sfsafe.org/safe-bikes.
- Buy a hardened steel U-lock and a secondary lock such as a chain or cable (See locking tools list).
- Replace quick release skewers and nutted wheels with uniquely keyed locking skewers and nuts, which keep wheels and saddles locked to the bike frame at all times.
- Lock your bicycle in your garage the same way you would on the street.
- Take an urban bicycling workshop with the San Francisco Bicycle Coalition to learn safe riding practices. Go to sfbike.org for more information.
- Speak with your local bicycle shop for more help and advice.





#### TOOLS TO LOCK YOUR BICYCLE

There are many different types of locks for bicycles and many incorrect ways of using them. No locking method is 100% effective.

For best security use a hardened steel U-lock, chain and locking skewers.

U-lock	<ul> <li>Very good deterrent</li> <li>Use the smallest U-lock that works for your bike to minimize the amount of space available for thief to insert a jack or levers</li> </ul>
Chain	<ul> <li>Hardened alloy steel with thickness of at least %" thick and heaviest is best</li> </ul>
Locking Skewers	<ul> <li>Very good deterrent</li> <li>Replace all quick release parts</li> <li>Check local bike shops for proper installation</li> </ul>
Cable	<ul> <li>Recommended for secondary locking device</li> <li>Good security for movable parts</li> </ul>

#### PREVENTING BICYCLE THEFT IN GARAGES

Garages and multi-unit apartment buildings with common garage are one of the most vulnerable places for bicycles. Thieves are waiting for the perfect opportunity.

#### Secure your bicycle in the garage the same way you would on the street!

- Secure to an immovable object or an anchor system.
- Never lock your bike near a window or door.
- Always watch your garage door and make sure it closes completely so unwanted visitors do not enter.

#### SAFE BIKE REGISTRY

#### YOUR BICYCLE GETS STOLEN-NOW WHAT?

- File a police report through sf-police.org or visit your local police district station.
- Notify SAFE BIKES at info@sfsafe.org or call 415-553-1984.
- Provide pictures and serial numbers for bicycle with the police report and any identifying marks.
- If you don't have a serial number or pictures, track down your serial number from the point of purchase and/or use stock photos and send them to the investigator immediately.
- File an insurance claim.

#### INTERNET INVESTIGATIONS

- Post pictures of stolen bicycle to Craigslist, set up a Google alert, and use IFTTT.com.
- If bicycle is found, contact the SFPD investigator.
   DO NOT arrange a meeting and attempt to get your bicycle back.
- Check racklove.com and stolenbikeregistry.com to find your bicycle.

#### IF YOU FEEL COMFORTABLE RESPONDING:

- 1. DO NOT ATTEMPT TO SNAP, BEND OR BREAK ANY PART OF THE NEEDLE. IF THE CAP IS OFF DO NOT ATTEMPT TO RECAP IT.
- 2. DO GET A HARD PLASTIC, PUNCTURE RESISTANT CONTAINER AND A SET OF TONGS OR PLIERS.
- PLACE THE CONTAINER ON THE GROUND NEXT TO THE SYRINGE.
- PICK UP THE SYRINGE IN THE CENTER WITH THE NEEDLE POINTING AWAY FROM YOU AND PLACE THE SYRINGE IN THE CONTAINER.

# Note: The following information is specific to commercial and retail establishments; however, can be applied to any location utilizing video surveillance. Overview

Basic set up and maintenance problems can reduce the effectiveness of many systems.

a. Resolution – is it good enough for facial recognition.

b. Camera position - are they positioned for clear view of suspect.

  c. Lighting is it adequate to capture clear images both day and night.
  - d. Image detail is the recorder set up for best image detail.
- e. Maintenance are you maintaining your system properly so it can do its job when needed?

## Set Up and Maintenance

- Backlighting when sun is bright at doorway, images in front appear darker or even black. Use another light source inside to counteract back light.
  - Low Frame Rate saves on drive space and gives better image quality, but you may not get an image at all (now you see him; now you don't)
    - Obstructions displays and other objects blocking view should be eliminated.
      - Focus Problems must check system regularly to prevent.

## Minimum camera resolution should be 480 horizontal lines.

Good cameras have faster lenses (allows more lighting), larger maximum aperture opening (lets more light into the focal point of the camera) and controls image brightness allows brighter images in dim lighting) - the more lighting, the more depth of field (greater depth of field; the more of the scene is in focus)

Focal Length - some cameras zoom in and out while others have a fixed focal length. The type of cameras used depends on what your needs are

Transaction Areas - anything at a transaction point (cash register, toll booth, etc.), the subject's head should fill at least 15% of the total image in the frame, giving the detail you need.

Lines of Sight - lines of sight are always critical, make sure there are no obstructions.

Site Plan - the right site plan is crucial (retail store blueprint or diagram). Key camera spots are at transaction points (cash registers and entry/exit points) - the more cameras, the better.

You want good camera overlap (you want multiple chances to capture good images). Extra coverage is also needed for aisles, restrooms and other key points.

Camera Height - placement is very important, make sure it is as close to eve-level as possible. Otherwise, you might lose out to a baseball cap.

With a good site plan you can make sure you don't have any blind spots (you can toy around with camera positions, and do a test recording to see that you are getting what you want). nterior Lighting - interior lighting can balance bright from one direction (back lighting) by adding another light source from a different location (add a bank of lights).

afternoon sunlight). Adding more light from a different direction balances lighting, giving better camera clarity (if sunlight is shining through large windows you can tent windows or add screens. Example: Artificial lighting (inside store) for cameras may be good in the morning, but by noon, the sun (through a doorway or window) can blow the entire frame out (add lighting to fill in for

Exterior Lighting – if lights are on timers, you must adjust appropriate to seasonal changes (Fall/Winter: gets dark earlier. Spring/Summer: gets dark later).



Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.



- Garage: When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- O Car: Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- 8 Spare Key: Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- O Door Buzzer: When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- 6 Security Cameras & Alarm Systems: Cost effective tools for preventing crime and identifying criminals.
- 6 Light Timers: Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- Doors/Windows: Always keep doors and windows locked.

Keep property in good repair. Maintain visibility to your neighbors for increased safety.

#### Door and Window Safety

Doors:

- Should be made of solid wood or metal
- · Have a single cylinder deadbolt lock and a 1-inch bolt
- · Have a front door viewer or peep hole with a 180-degree range
- Clearly display unit number

Windows:

- · Replace if glass is cracked and replace all damaged or missing locks
- · Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- · Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

#### **DEFINITION OF SUSPICIOUS ACTIVITY**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



#### **CRIME DEFINITIONS**

#### **Definitions**

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

\*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

#### WHO AND WHEN TO CALL?

**3-1-1:** Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

SF 3-1-1 APP is available to use on your mobile device. Download the APP and its

easy to use for many Non-emergency.



Non- Emergency San Francisco Dispatch Line: Pease call the non- emergency dispatch line (415-553-0123) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, suspicious activities, or a homeless/nuisance related issue. The non-emergency line is for situations that require the police, but do not require an <u>immediate</u> police response.

**9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency.** The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please** 

call 9-1-1.
