Captain Bailey's Message

Hello all,

Although we are down 30% in burglaries this year to date by comparison to 2018 we did see a slight increase last week. Please review the following information to help ensure you are not a victim of this crime.

I want to review with everyone how you can best avoid being a victim of a burglary. Please ensure that you are taking basic security measures i.e. locking and securing all doors and windows. Be mindful of this security even when at home do not leave a window or door open that is easily accessible from the ground floor.

Always remember to keep your garage doors closed and secured. If storing a bike in your garage please secure that bike with a lock and secure the locked bike to a fixed item. This is especially true if you store your bike in a shared garage. A shared garage means there is a greater chance that someone will leave the door open or unsecured allowing easy access to your stored property. Please consider putting a tracker on your bike so that if it is taken there is a way for us to track the bike and increase the possibility of suspect apprehension. Ensure you have the serial number for your bike recorded which you can do by taking a photo of your bike and then a close up photo of the bike's serial number. Of course having a camera installed that captures video of anyone coming or going in and out of your home is also invaluable when it comes to apprehending suspects. SFPD are typically able to identify the suspects because these suspects are more often than not repeat offenders.

CAPTAINS BAILEY'S MESSAGE CONTINUED

Do not leave a hide-a key. Suspects are very in tune with where people leave spare keys. Do not leave your garage door opener in your car or at least keep it out of view. Of course a big deterrent for burglars is having a dog but I know not all of us can be lucky enough to have our furry friends on guard each day and night.

Please immediately call 911 if you think you see a crime in progress or a suspicious person in your neighborhood. District residents have being doing a great job of calling 911 when they see suspicious activity or what they believe to be a crime in progress. These calls have led to numerous arrests. Our officers responded quickly and are able to take suspects into custody.

Let me end by saying two things please think about installing a security camera and motion activated lights. The footage provided by these cameras have proven invaluable in solving crimes not only at the individual's house but also in their neighborhood. The motion activated lights have proven to be a deterrent and also provide lighting for the video footage.

Take photos of all items in your home that are of value to you and if there are serial numbers take photos of those too. This will increase the chance of us being able to reunite you with your property should you be a victim and also be able to arrest any suspect who is in possession of your property.

Your safety is paramount to us here at Park Station and with your help we can prevent many crimes and solve more.





Some of Park Station's Arrests for the week

Warrant Arrest, Enroute to Dept. of Corrections, 9/11/2019, 0901 Hrs. Area of 15th Street

On September 11th, 2019 Officers responded to 15th Street regarding numerous individuals sitting in the parking lot in violation of the Sit/Lie ordinance. The suspects were identified and one of the suspects was found to have a 'no bail' parole warrant for his arrest. The suspect was arrested and booked accordingly for the above listed charge.

Warrant Arrest, Local SF Warrant, Narcotics Paraphernalia, Possession Of, 9/13/109 1715 Hrs. Area of Noe St.

On 9/13/19 at approximately 1715 hrs. numerous officers responded to the area of 15th St./Noe regarding one male chasing another with a knife. Officers arrived on scene and observed one male chasing the other male, the officers ordered both males to sit down and both males complied and sat down. The officers did not locate a knife on either of the males. Both individuals were detained and questioned. One of the men was extremely agitated and appeared to be under the influence of narcotics. It was alleged that he had brandished a knife at the other individual. The officers conducted an investigation and determined that brandishing a knife could not be substantiated. One of the individuals did have a warrant and was arrested, a search incident to arrest revealed the subject with the warrant was in possession of narcotics paraphernalia and was booked accordingly for the above listed charges.

Marijuana Sales, Possession for Sales 9/13/19, 1458 Hrs. Area of Haight and Clayton Street.

Officers were driving an unmarked police vehicle on westbound Haight Street when they observed a hand to hand narcotics transaction. The Officers stopped and detained the two individuals involved in the transaction. One of the subjects admitted to buying marijuana from the other subject that was detained. The officer's investigation determined that the sales of the marijuana was an illegal transaction and the suspect was arrested for the above listed charges. The buyer of the marijuana was detained and then released.

Warrant Arrest, Enroute to Outside Jurisdiction, Civil Sidewalk Warning, 9/14/19 1641 Hrs. Area of Church Street

On September 15th, 2019 Officer observed a male sitting on the sidewalk in violation of the Civil Sidewalk Ordinance. Officers contacted the suspect and conducted a warrant check, which revealed that he had a \$15,000 warrant for drugs. The subject was arrested and booked for the listed charges.

Warrant Arrest, Civil Sidewalk Booking, Opiates Offence, 9/14/19, 0841 Hrs. Area of Oak Street.


Officers were on patrol in the area of Oak and Masonic when they observed a male lying on the sidewalk in violation of 168(b) MPC. The officers contacted the suspect and a warrant check revealed that he had a \$10,000 warrant for resisting arrest. A search of the suspect property revealed that the suspect was in possession of suspected opiates. The suspect was arrested for the warrant and the opiate offense and transported to County Jail.

Bicycle Theft <\$50, Trespassing 9/14/19, 1233 Hrs. Area of Page Street.

Park Station Officers responded to Page St. regarding a suspect that jumped over a metal gate and removed a bicycle from an outside storage area. The victim heard the suspect jumping over the metal gate and watched him walk across the street with the bicycle. The victim went outside and told the suspect that he wanted his bicycle back, the suspect stated, "I was going to take it for a ride." The victim stated, "I don't think you should." the suspect returned the bicycle to the victim and walked east on Page toward Masonic Ave. The officers located and detained the suspect. A cold show was conducted and the victim positively identified the suspect as the person who took the bicycle. The suspect was arrested and cited for theft under \$50.00 and trespassing.

Distracted Driving

Distracted driving is anything that takes your eyes or mind off the road. In the smartphone age, distracted driving is the most dangerous when drivers are using their cell phone behind the wheel.

Whether it is talking, emailing, texting, plugging in directions, using an app or scrolling through social media feeds, using a cell phone is not only dangerous, but also illegal.

In 2017, 3,166 people were killed in distracted driving related crashes across the country, or nearly 10 percent of all traffic deaths.

Using a phone to dial, talk or text triples the risk of a driver getting into a crash. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for an average of 5 seconds. At 55 mph, that's like driving the length of a football field with your eyes closed.

Other serious driver distractions such as eating, grooming, reaching for objects on the floor, changing clothes or talking with passengers are just as dangerous. The safest thing drivers can do is put down the phone, focus on the road and just drive.

Cell Phone Law



Holding a phone while driving is illegal. Any electronic device must be used in a hands-free manner, such as speaker or voice commands. The law applies when at a stop sign or signal.



To use a phone while driving, it must be mounted on the dashboard, windshield (seveninch square in lower right corner or five-inch square in lower left corner), or center console.



When the phone is mounted, drivers can swipe or tap the screen once to activate or deactivate a feature. It is illegal to swipe multiple times, enter information or text.



A first offense ticket is \$162, with additional offenses costing even more.



You may use your phone while holding it for true emergencies, like calling 911.



Not only is holding your phone while driving illegal in the State of California, distracted driving is now the number one cause of roadway crashes. Join us in being part of the solution. Grab the wheel with both hands, enjoy the drive and focus on each other. Here are some ways you can prevent driving distracted:


- > Silence your phone before you get behind the wheel and keep it mounted in a legally approved location.
- > Never text and drive or use apps or social media while driving.
- Do not eat, drink or program your GPS/MP3 > player or other devices while driving.
- > If a phone call is necessary or you need to reroute your map, pull over to use those devices.
- > If something falls to the floor, pull over to a safe parking spot before trying to reach it.

SAFE BIKES and the SFPD recommend the Sheldon Brown Locking Method.

No locking method is 100% foolproof, but this method is highly effective.

GUIDE FOR LOCKING YOUR BIKE:

- Use the smallest U-lock that works for your bike to minimize the amount of space available for a thief to insert a jack or levers.
- Use a hardened steel U-Lock to secure back wheel inside the rear triangle of the bicycle frame.
- Check to make sure U-lock is secured to an immovable metal object.
- Secure front wheel with cable or second U-lock. Loop cable around the down tube of the bicycle or secure second U-lock to front wheel and down tube.
- Replace quick release skewers and nutted wheels with keyed locking skewers and nuts to ensure wheels and saddles are locked to the bike frame at all times.
- Check with local bike shop for proper installation of locking skewers and advice.



SAFE BIKE REGISTRY

YOU JUST BOUGHT A NEW BICYCLE-NOW WHAT?

FOLLOW THESE STEPS:

- Register and upload receipt and photos of your bicycle at sfsafe.org/safe-bikes.
- Buy a hardened steel U-lock and a secondary lock such as a chain or cable (See locking tools list).
- Replace quick release skewers and nutted wheels with uniquely keyed locking skewers and nuts, which keep wheels and saddles locked to the bike frame at all times.
- Lock your bicycle in your garage the same way you would on the street.
- Take an urban bicycling workshop with the San Francisco Bicycle Coalition to learn safe riding practices. Go to sfbike.org for more information.
- Speak with your local bicycle shop for more help and advice.





TOOLS TO LOCK YOUR BICYCLE

There are many different types of locks for bicycles and many incorrect ways of using them. No locking method is 100% effective.

For best security use a hardened steel U-lock, chain and locking skewers.

U-lock	 Very good deterrent Use the smallest U-lock that works for your bike to minimize the amount of space available for thief to insert a jack or levers
Chain	 Hardened alloy steel with thickness of at least %" thick and heaviest is best
Locking Skewers	 Very good deterrent Replace all quick release parts Check local bike shops for proper installation
Cable	 Recommended for secondary locking device Good security for movable parts

PREVENTING BICYCLE THEFT IN GARAGES

Garages and multi-unit apartment buildings with common garage are one of the most vulnerable places for bicycles. Thieves are waiting for the perfect opportunity.

Secure your bicycle in the garage the same way you would on the street!

- Secure to an immovable object or an anchor system.
- Never lock your bike near a window or door.
- Always watch your garage door and make sure it closes completely so unwanted visitors do not enter.

YOUR BICYCLE GETS STOLEN-NOW WHAT?

- File a police report through sf-police.org or visit your local police district station.
- Notify SAFE BIKES at info@sfsafe.org or call 415-553-1984.
- Provide pictures and serial numbers for bicycle with the police report and any identifying marks.
- If you don't have a serial number or pictures, track down your serial number from the point of purchase and/or use stock photos and send them to the investigator immediately.
- File an insurance claim.

INTERNET INVESTIGATIONS

- Post pictures of stolen bicycle to Craigslist, set up a Google alert, and use IFTTT.com.
- If bicycle is found, contact the SFPD investigator.
 DO NOT arrange a meeting and attempt to get your bicycle back.
- Check racklove.com and stolenbikeregistry.com to find your bicycle.

IF YOU FIND A SYRINGE PLEASE DO NOT IGNORE IT LET'S WORK TOGETHER FOR A SAFER COMMUNITY

IF YOU FEEL COMFORTABLE RESPONDING:

- 1. DO NOT ATTEMPT TO SNAP, BEND OR BREAK ANY PART OF THE NEEDLE. IF THE CAP IS OFF DO NOT ATTEMPT TO RECAP IT.
- 2. DO GET A HARD PLASTIC, PUNCTURE RESISTANT CONTAINER AND A SET OF TONGS OR PLIERS.
- PLACE THE CONTAINER ON THE GROUND NEXT TO THE SYRINGE.
- PICK UP THE SYRINGE IN THE CENTER WITH THE NEEDLE POINTING AWAY FROM YOU AND PLACE THE SYRINGE IN THE CONTAINER.
- 5. SEAL THE CONTAINER AND BRING TO YOUR LOCAL SYRINGE ACCESS PROGRAM OR DROP IT OFF AT A 24-HOUR DISPOSAL SITE.

Basic set up and maintenance problems can reduce the effectiveness of many systems.

a. Resolution – is it good enough for facial recognition.

b. Camera position - are they positioned for clear view of suspect.

 - d. Image detail is the recorder set up for best image detail.
- e. Maintenance are you maintaining your system properly so it can do its job when needed?

Set Up and Maintenance

- Backlighting when sun is bright at doorway, images in front appear darker or even black. Use another light source inside to counteract back light.
 - Low Frame Rate saves on drive space and gives better image quality, but you may not get an image at all (now you see him; now you don't)
 - Obstructions displays and other objects blocking view should be eliminated.
 - Focus Problems must check system regularly to prevent.

Minimum camera resolution should be 480 horizontal lines.

Good cameras have faster lenses (allows more lighting), larger maximum aperture opening (lets more light into the focal point of the camera) and controls image brightness allows brighter images in dim lighting) - the more lighting, the more depth of field (greater depth of field; the more of the scene is in focus)

Focal Length - some cameras zoom in and out while others have a fixed focal length. The type of cameras used depends on what your needs are

Transaction Areas - anything at a transaction point (cash register, toll booth, etc.), the subject's head should fill at least 15% of the total image in the frame, giving the detail you need.

Lines of Sight - lines of sight are always critical, make sure there are no obstructions.

Site Plan - the right site plan is crucial (retail store blueprint or diagram). Key camera spots are at transaction points (cash registers and entry/exit points) - the more cameras, the better.

You want good camera overlap (you want multiple chances to capture good images). Extra coverage is also needed for aisles, restrooms and other key points.

Camera Height - placement is very important, make sure it is as close to eve-level as possible. Otherwise, you might lose out to a baseball cap.

With a good site plan you can make sure you don't have any blind spots (you can toy around with camera positions, and do a test recording to see that you are getting what you want). nterior Lighting - interior lighting can balance bright from one direction (back lighting) by adding another light source from a different location (add a bank of lights).

afternoon sunlight). Adding more light from a different direction balances lighting, giving better camera clarity (if sunlight is shining through large windows you can tent windows or add screens. Example: Artificial lighting (inside store) for cameras may be good in the morning, but by noon, the sun (through a doorway or window) can blow the entire frame out (add lighting to fill in for

Exterior Lighting – if lights are on timers, you must adjust appropriate to seasonal changes (Fall/Winter: gets dark earlier. Spring/Summer: gets dark later).



Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.



- Garage: When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- O Car: Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- 8 Spare Key: Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- O Door Buzzer: When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- 6 Security Cameras & Alarm Systems: Cost effective tools for preventing crime and identifying criminals.
- 6 Light Timers: Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- Doors/Windows: Always keep doors and windows locked.

Keep property in good repair. Maintain visibility to your neighbors for increased safety.

Door and Window Safety

Doors:

- Should be made of solid wood or metal
- · Have a single cylinder deadbolt lock and a 1-inch bolt
- · Have a front door viewer or peep hole with a 180-degree range
- Clearly display unit number

Windows:

- · Replace if glass is cracked and replace all damaged or missing locks
- · Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- · Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



CRIME DEFINITIONS

Definitions

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

WHO AND WHEN TO CALL?

3-1-1: Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

SF 3-1-1 APP is available to use on your mobile device. Download the APP and its

easy to use for many Non-emergency.



Non- Emergency San Francisco Dispatch Line: Pease call the non- emergency dispatch line (415-553-0123) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, suspicious activities, or a homeless/nuisance related issue. The non-emergency line is for situations that require the police, but do not require an <u>immediate</u> police response.

9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency. The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please**

call 9-1-1.
