- Award you or the other parent custody of or visitation with a minor child or children.
- Restrain the attacker from molesting or interfering with minor children in your custody.
- Direct the party not granted custody to pay support o finor children, if they have a legal obligation to do so.
- Direct the defendant to make specified debit payments coming due while the order is in effect.
- Direct either or both parties to participate in couseling.
