Dear President Loftus and San Francisco Police Commissioners,

Statistical reports, Summary of Complaints Received in May 2016 and Companion Reports

In compliance with San Francisco City Charter section 4.127 and Police Commission Resolution number 97-04 that require the Office of Citizen Complaints (OCC) to provide the Police Commission with a monthly summary of complaints received including the number and type of complaints filed, attached please find a summary of cases received in May 2016, a comprehensive statistical report, a pending case list, and a how complaints were received report for the period January 1, 2016 through May 31, 2016 and for comparison purposes, the same reports for the period January 1, 2015 through May 31, 2015.

Mediation of Complaints in May 2016

The OCC mediated five cases in May, 2016 with a total of 24 cases mediated from January 1, 2016 through May 31, 2016. The OCC mediated three cases in May 2015 with a total of 22 cases mediated from January 1, 2015 May 31, 2015.

Chief's Proposed Discipline on OCC Sustained Complaints in May 2016

In May, 2016, then Chief Gregory P. Suhr made findings and proposed discipline in two cases and Interim Chief of Police Toney Chaplin proposed discipline in one case investigated by the OCC and determined by the OCC Director Joyce M. Hicks to have sustainable allegations. The OCC's findings and the Chief's proposed discipline are as follows:

1. In violation of DGO 5.20, Language Access Services for Limited English Proficient Persons (LEP), an officer failed to advise the complainant of her right to a Russian-speaking interpreter causing him to provide inadequate police services to the complainant. **The officer was admonished and retrained.**

- 2. A sergeant was sustained for three counts of neglect of duty as follows:
 - a. Seizing a cell phone belonging to the complainant but failing to prepare a property receipt form and to issue the complainant a property receipt in a timely manner, in violation of DGO 6.15, property processing.
 - b. Handcuffing the complainant but failed to issue him a Certificate of Release, in violation of DGO 5.03.
 - c. Failing to properly process property by seizing a cell phone belonging to the complainant but not documenting the seizure of this evidence or establishing and documenting a chain of custody, in violation of DGO 6.02 and the SFPD Field Training Manual.

The sergeant received a written reprimand and retraining.

3. In violation of DGOs 1.03 and 2.01 an officer failed to investigate and failed to make required written reports of a crime or incident requiring police attention. Complainant complained that the complained of officer inadequately responded to her request for assistance after in her absence and on civil standby other officers permitted her ex-boyfriend into her apartment and he took her property. The complained of officer admitted the complainant told him that her ex-boyfriend had taken some of her belongings during a civil standby. Instead of investigating the complainant's allegation of theft, the officer referred her to the district station and to the OCC. The officer failed to investigate the alleged theft of the complainant's property and failed to document the incident in an incident report. The officer received a written reprimand and retraining.


